# **Performance of the Finance Commission**

# (From 01st of January 2018 to 31st of March 2018)

This report covers the main activities performed by the Finance Commission during the period of 1<sup>st</sup> January 2018to 31<sup>st</sup> March 2018.

# 1. Sending budget guidelines on recurrent and capital needs of the ensuing year to the Provinces.

Each year, the Finance Commission issues Guidelines to the provinces regarding the Needs Assessment of both recurrent and capital work. A specimen format has been developed for this purpose.

Guidelines on need assessment for 2019 was sent to the provinces and their requests on Needs Assessment of Capital Expenditure and Recurrent Expenditure for 2019 are expected to reach the Finance Commission by the 31<sup>st</sup> May.

### 2. Receiving Provincial Annual Development Plans – 2018 from the provinces.

The Finance Commission has received Provincial Annual Development Plans - 2018 from all the provinces.

This year, the Chairman and the Secretary along with other relevant officers of the Finance Commission visited all provinces on following days to review plans and ongoing projects. The Chief Secretaries and other responsible officers including heads of Provincial Ministries / Departments / Authorities attended those meetings.

# 3. Granting concurrence for the Provincial Annual Development Plans.

All Provincial Development Plans have been granted concurrence by the Finance Commission for implementation of the development plans subject to make some revisions, as agreed upon.

#### 4. Annual Report of the Finance Commission -2016/2017

**Annual Report for 2016** was submitted to H.E. the President and the Parliament. The Annual Report 2017 is being prepared.



The Annual Report for 2016 of the Finance Commission was handed over to President Maithripala Sirisena at the Presidential Secretariat on 15<sup>th</sup> of February 2018. The report of the Commission was presented to the President by Finance Commission Chairman Mr. Uditha H. Palihakkara. Central Bank Governor Dr. Indrajit Coomaraswamy, Secretary to the Treasury Dr. R.H.S Samaratunga, Mr. V.Kanagasabapathy, Prof. H.M.Zafrullah and Secretary Mr. A.T.M. U.D.B.Tennakoon were also present at the occasion.

#### 5. Preparing reports on Provincial Audit Reports

North Western and Southern Provincial Audit reports received from Auditor General's Department were studied and observations of the Finance Commission were sent to the Provincial Chief Secretaries with a view to improving accountability of the Provinces.

#### 6. Construction of New Building for the Finance Commission

Construction work of the Administration Building of the Finance Commission (FC) is in progress. Every month, two Progress review meetings were held at the Finance Commission and two technical meetings were held at the site with the participation of Project Consultancy Unit (Faculty of Architecture, University of Moratuwa) and the Contractor. Out of the 180 million allocated for 2018, 14.7 million was paid by end of the 1<sup>st</sup>quarter. It was noted that

the project is behind schedule about 96 days. The Construction project is to be finished by May 2018





#### 7. Finance Commission Data Base and MIS

The Finance Commission had a series of discussions with the Asia Foundation and University of Colombo School of Computing (UCSC) in relation to development of a Data Base / Management Information System (MIS) for the use of the Finance Commission.

An MOU between Finance Commission and the Asia Foundation in this regard was planned to sign. The Secretary of Finance Commission signed the MOU as the authorized officer from the Finance Commission. The MOU was sent to the Asia Foundation for the signature of the authorized officer. Meanwhile UCSC has started their study regarding the current process of the Finance Commission in recurrent expenditure and Provincial Revenue.

#### 8. Internal Audit Committee

The 01<sup>st</sup> Quarter meeting of the Internal Audit Committee was held on 27<sup>th</sup> February 2018 with the participation of the Director, Department of Management Audit. Decisions of the meeting were informed to the staff of the Finance Commission, for necessary follow up action. The Commission decided that Internal Audit, in addition to regularity aspects should deal with performance aspects as well.

#### 9. Follow up matters on recommendations to H E the President

At the request made by the Chairman, Finance Commission Mr. Austin Fernando, Secretary to the President granted an appointment to discuss the recommendations submitted to H.E. the President. It was decided that Secretary, Ministry of Provincial Councils and Local Government should convene a meeting with the relevant officials of Central Ministries and Provincial Councils to discuss on policy recommendations of the Finance Commission.

# 10. Meeting on the matters related to Independent Commissions

A meeting was held by the Presidential Secretariat on 2<sup>nd</sup> February 2018 on the invitation of Mr. Austin Fernando, Secretary to the President, with representation of the Commissions. The Secretary Finance Commission participated in the meeting.

The objective of the meeting was to provide an opportunity to all representatives to discuss issues of their Commissions and make necessary recommendations.

Consequently the Commission was informed H. E. the President has forwarded a cabinet paper for approval for preparation of an Act for the Finance Commission.

The Cabinet Meeting held on 2<sup>nd</sup> January 2018, it was decided to instruct the Legal Draftsman to draft necessary legislation for the purpose.

# 17. Water supply scheme for the Dorowwa village



The officials of the Western Province and the Finance Commission participated in a field visit in Dorowwa village in Gampaha District on 15<sup>th</sup> February 2018 to observe a water supply scheme for the Dorowwa village. Water supply tanks have been constructed under a Community Water Supply Scheme. The issue is insufficiency

of water in the wall. There should be an alternative water source for the project. The Western Provincial Council is to identify proper solution for the issue.
