New Clause

"Provision of nursing intervals for nursing mothers 18I. The Employer of a female employee in any shop or office shall, if she is nursing a child under one year of age, allow her, in any period of nine hours, two nursing intervals at such times as she may require. Each interval shall, where creche or other suitable place is provided by such employer to such female employee for nursing such child, be not less than thirty minutes, and where no crèche or other suitable place is so provided, be not less than one hour, and shall be in addition to any interval provided to such female employee for meals or rest under any written law and be regarded, for the purposes of her employment, as time during which she has worked in her employment.".

Question that the Clause, be added to the Bill, put, and agreed to.
