PERFORMANCE APPRAISAL REPORT OF THE

COMMISSIONER OF ELECTIONS

FOR THE YEAR 2014

01. Introduction

Enumeration of electors and certifying of the electoral register for the year 2014, conduct of elections to Western, Southern and Uva Provincial Councils, organization of preliminary activities of the Presidential Election which was scheduled to be held on 8th January 2015 and the filling of vacancies in the Parliament, Provincial Councils and Local Authorities were the activities performed by the Department of Elections during the year 2014.

02. Registration of Electors Act, No. 44 of 1980

2.1 Revision of Electoral Registers – 2013

- 2.1.1. Necessary steps were taken to publish a notice under the Section 12(1) of the Registration of Electors Act in the Government *Gazette* No. 1810/33 on 15.05.2013 and to publish the same notice in Sinhala, Tamil and English newspapers, on the same day, in regard to the commencement of the enumeration of electors for the year 2013.
- 2.1.2. Until the year 2013, house to house enumeration of electors commenced on 1st of June every year. But steps were taken to distribute enumeration forms to the chief occupants from 15th May 2013 after taking into consideration the provisions of the Registration of Electors Act and the decision to certify the register within the same year. But in terms of the Registration of Electors Act No. 44 of 1980, 1st of June in the relevant year was considered as the qualifying date as in the previous years.
- 2.1.3. In addition to all awareness programmes conducted in the 2012 enumeration through electronic and print media, additional steps were taken to make general public aware about enumeration of electors in relation to the revision of electoral registers for the year 2013. Commissioner of Elections declared 01st of June in every year as the "Voters' Day" and took necessary steps to conduct various awareness programmes by the Elections Secretariat and at district level.
- 2.1.4. The Electoral Register was certified on 31.12.2013 in terms of Section 18 of the Registration of Electors Act, No. 44 of 1980 after taking into consideration the matters relating to multiple registrations and inquiries into claims / objections together with re-scrutinizing the names of all the electors with the enumeration forms (BC Forms). The notice under

- Section 20 regarding the certification was published in the *Gazette* No. 1843/9 of 31.12.2013 and in newspapers.
- 2.1.5. The determination of the Commissioner of Elections in terms of Article 98(8) of the Constitution regarding the number of members to be elected for the year 2013 from each electoral district at a Parliamentary Election, based on the statements about the total no. of names in the electoral register, provided by the Registering Officer of each electoral district, under Section 23 of the Registration of Electors Act after certifying the Electoral Register in 2013, was published in the *Gazette* No. 1853/3 of 10th February 2014. Relevant details are shown in *Table I*.
- 2.1.6. Accordingly, the number of Members of Parliament for No. 11 Vanni Electoral District and No. 19 Badulla Electoral District were increased by one and the number of members for No. 08 Matara Electoral District and No. 15 Kurunegala Electoral District were decreased by one in the year 2013. Comparative Statement on the number of Members of Parliament to be elected for each electoral district (2005-2014) under the Article 98(8) of the Constitution is shown in *Table II*.

2.2 Revision of Electoral Registers – 2014

- 2.2.1. Necessary steps were taken to publish a notice under the Section 12(1) of the Registration of Electors Act in the Government *Gazette* No. 1862/12 on 16.05.2014 and to publish a notice in Sinhala, Tamil and English in the newspapers on the same day in regard to the commencement of the enumeration of electors for the year 2014.
- 2.2.2. Until the year 2013, house to house enumeration of electors commenced on 1st of June every year. But as in the year 2013, in the year 2014 also steps were taken in the year 2014, to commence the enumeration in the mid of May 2014. However, as in the previous years 1st of June in the relevant year was considered as the qualifying date to register as an elector under the Registration of Electors Act No. 44 of 1980.
- 2.2.3. Necessary instructions regarding enumeration of electors in all electoral districts were issued to District Registering Officers on 11.03.2014 and the Commissioner of Elections informed the Secretaries of all the recognized political parties on the same day regarding the revision and the procedure for appointing their representatives.
- 2.2.4. Besides general public awareness programmes carried out through electronic and print media, steps were taken during the revision of electoral register, 2014, as in the year 2013, to implement various programmes at district level based on the "Voters' day" on 1st of June. The main function in relation to the voters' day of the year 2013 was held in Colombo while centralizing the Colombo District. However, in the year

2014 revision also, action was taken to carry out main functions including walks, street dramas and various other programmes as in the year 2013, in Nuwara Eliya, Kilinochchi, Puttalam, Matara and Ampara districts, and to implement general public awareness programmes in all other districts in concurrence to it. The Commissioner of Elections attended to the main function held in Nuwara Eliya District in relation to the voters' day and senior officers of the Elections Secretariat participated for the main functions held in Kilinochchi, Puttalam, Matara and Ampara Districts. District Registering Officers/ Government Agents and District Deputy/ Assistant Commissioners of Elections gave their maximum contribution to make the awareness programmes, held in all other districts including the afore mentioned districts, succeed.

- 2.2.5. More attention was paid as in the year 2013 to register the groups which acted as obstacles for the objective of inserting all qualified electors into the electoral register. Accordingly, instructions were given to all District Registering Officers/ Government Agents as well as to Deputy/ Assistant Commissioners of Elections to afford the priority to low income persons living in urban areas, people living in urban high rise apartments, people living in rented / lease houses, people migrating to urban areas in search of employment, Tamil speaking people who were serving in plantation industry and related jobs in Central, Uva and Sabaragamuwa Provinces and Colombo, Kalutara, Galle and Matara Districts, internally displaced persons living in other areas of the Island due to military operations and mentally sick persons who have been cured but continue to stay in Mental Hospitals due to non acceptance by their relatives.
- 2.2.6. Although certain complications in enumeration activities in the year 2014 was occurred due to the programme of Urban Development Authority to evict the slums in the Colombo District and replace them with flats, complications in relation to the registration of such persons could be solved according to the order given by the Court. On the agreement entered into by the residents of slums and the officers of the Urban Development Authority, the Court has ordered to insert the names of the slum dwellers to the electoral register although they were not reside at their residences, but until the day they would given homes at the same place where they lived. But confirmation of the registration of some slum dwellers could not be obtained due to the difficulties faced in obtaining new addresses of them and to the fact that slum dwellers in certain areas lived away from their homes after taking their compensation. Further, for the first time, names of 173 mentally sick persons who have been cured but continue to stay in the premises of the respective mental hospitals due to non acceptance by their relatives, were inserted to the electoral register.
- 2.2.7. In concurrence with the Voters' Day, door to door collection of enumeration forms in areas of selected Municipal Councils/ Urban Councils was conducted on 02.06.2014 by the enumerators as well as the

- officers of the Elections Secretariat. According to the observations of District Deputy/ Assistant Commissioners of Elections in this connection, BC forms could be accepted from the real residents and especially attempts to insert names fraudulently to admit children to popular schools could also be minimized.
- 2.2.8. Instructions were given to implement a special programme under the personal supervision of each District / Deputy / Assistant Commissioner of Elections as in the year 2013, for registration of Tamil speaking persons serving in the plantation industry and other related jobs and were until then not registered as electors due to various reasons *viz.* non confirmation of date of birth, problems in relation with the citizenship, staying away from homes due to their careers and uninteresting about the registration as an elector. This programme with the participation of Superintendants of Estates, Plantation Community Facilitators and Grama Niladharis in estate areas was helped to insert the names of most of persons in the estates to the electoral register. A special programme at the district level was also launched during the claim period to insert the names of electors in estate areas who were unable to insert their names at the primary enumeration.
- 2.2.9. House to house enumeration of electors was conducted in the Northern Province by enumerators except for a limited area in 29 polling districts in 04 polling divisions of No. 10 Jaffna Electoral District and one polling division in Mannar district which belongs to No. 11 Vanni Electoral District, where displaced persons have not been resettled. Instructions were given to retain the names of the electors who could not be enumerated by door to door enumeration but appeared in the Previous *viz.* 2013 electoral register. Details of the polling divisions and polling districts in this regard are shown in *Table III*.
- 2.2.10. It is previously planned to certify the 2014 electoral register on 31st December 2014 after completing the revision during the month of December 2014, which was commenced on 16th May 2014 at the field level. But representatives of the multinational organizations including the Members of the Parliament and the citizens who concerned in this regard submit information to the fact that, if the electoral register is certified at the end of the year about three lakhs of electors who have completed the age of 18 years and qualified for new registration would not get the opportunity cast their votes. Therefore, discussions were held with Registering Officers Deputy/ District and District Assistant Commissioners of Elections in this regard and abilities to certify the 2014 electoral register during the month of October were sought. Accordingly, action was taken to certify the electoral register on the 31st of October 2014 and to amend the programme of revision of electoral registers.

- 2.2.11. Accordingly, steps were taken to conclude, before mid-July, the field activities of the enumeration of electors which were commenced on 16th May 2014. The "A" list, which contains the names deleted from the operative register, 2013 and the "B" list, which contains the newly inserted names to the operative register, were prepared during the mid August and were exhibited under Section 13 of Registration of Electors Act No. 44 of 1980 at all District Elections Offices, Divisional Secretariats, all Grama Niladhari Offices and Local Authorities, during 28 days period commencing from 01.09.2014 to 28.09.2014, for the perusal of general public and to provide them an opportunity to submit their claims if their names were not included in the register. In the revision of electoral registers for the year 2014, there were 809,393 names to be deleted and 1,125,582 new names to be inserted to the operative register (2013) in relation to the all electoral districts. Claims and objections were accepted during this period of exhibition. The notice about exhibition of "A" and "B" lists was published in *Gazette* No. 1878/17 of 03.09.2014 and in all national newspapers on 03.09.2014, under the Section 13(2) of the Registration of Electors Act.
- 2.2.12. Before the commencement of enumeration, steps were taken to inform all recognized political parties to appoint representatives, on their behalf, to observe the delivery of enumeration forms (BC forms) to the Chief Occupants and acceptance of such forms after the enumeration. They were also informed to examine the same at the enumerators' offices after completion of the field enumeration and thereby submit their observations. Since 1981, this opportunity was given to all recognized political parties, as the participation of the agents of political parties to observe the duties of the enumerators will help to prepare an accurate electoral register. It is also a responsibility of all political parties to ensure the participation of their representatives in the enumeration process and ensure that the enumeration has been done correctly without complaining about depriving of the franchise of their party supporters, at a time of an election or when there are complaints from party men. However, while very limited number of political parties appoint their agents in this regard, insignificant number of those appointed contribute to this work. Therefore, for the first time, action was taken at the beginning of the 2014 revision, to inform the party secretaries by letters with relevant statistics, in regard to the number of representatives appointed and that actual number participated for the previous revision (2013) together with other relevant details. The details regarding appointments and participation of representatives of political parties for the revision of year 2014 are shown in Table IV.
- 2.2.13. In the year 2014, action was taken at the time of accepting enumeration forms (BC Forms), from enumerators, to inform chief occupants of the relevant households in writing, to obtain further information, about the

incidents which the enumerators had not recommend the inclusion of the names on various grounds, though the chief occupants entered those names or which all the electors of a household were deleted in the year 2014 though they were registered in the year 2013 or which any name was deleted due to various reasons *viz.* failure to handover the BC forms. According to the responses received from the chief occupants, the names which could be registered were accepted and names which could not be registered were treated as claims received during the period for claims and were called for enquires. Names of the electors which could be accepted according to the revealed information in the enquiries were inserted in to the electoral register, accordingly.

- 2.2.14. With regard to the revision of the year 2014 under the exhibition of "A" and "B" lists, 84585 claims and 853 objections were received by District Registering Officers under each electoral district. The District Registering Officers were instructed to arrange inquiries in relation to above claims and objections within the month of October. Accordingly, the number of claims and objections received, accepted and rejected are shown in *Table V*.
- 2.2.15. The programme which was implemented in the year 2013 regarding the multiple registrations of the electoral register was carried out during the year 2014 also. Accordingly, multiple registrations among
 - **★** new inserted names
 - * newly inserted names within the district and the names in the operative electoral register of the district
 - **★** newly inserted names within the district and newly inserted names in all other districts
 - **★** newly inserted names within the district and the names in the operative electoral registers of all other districts

were examined by using information technology methods. Situations where two or more persons under the same National Identity Card number were also revealed at these examinations and during the enquiries carried out with the electors who were informed by post. However, 137,071 names of multiple registrations were deleted in the year 2014 and details of the number of deleted names, because of multiple registrations, relating to each electoral district are shown in *Table VI*.

2.2.16. Enumerators were instructed to make every effort to obtain the National Identity Card Numbers of persons enumerated, as the production of a valid identity card has been made compulsory at the time of voting according to the Elections (Special Provisions) Act No. 14 of 2004. Even where the identity card number given at the time of enumeration, the computer programme used in the revision process can detect any incorrect numbers. In such instances, the Department of Registration of Persons

and the voter concerned are informed. It was possible by this process to correct a large number of errors in identity card numbers. Attempts by voters to enter their names under several addresses, for various reasons could also be prevented by inserting the National Identity Card number to the electoral Register. Particulars of the persons, who produced their National Identity Cards at the 2014 enumeration and the comparative statement on the number of persons producing particulars of the National Identity Cards at the revisions of electoral registers from year 2005 – 2014, are shown in *Table VIII and VIIII* respectively.

- 2.2.17. Action was taken to delete the names of 38 persons from the 2014 electoral register as they were reported to be imprisoned for offences committed under the Bribery Act and Election Laws. Relevant details of the names deleted due to various reasons are shown in *Table IX*.
- 2.2.18. Before certifying the electoral register draft register was exhibited at District Election Offices and all Grama Niladhari Offices from 23.10.2014 in addition to the publication in the website. General public were informed in this regard *via* paper advertisements and electronic media and to inform before 31.10.2014 the Commissioner of Elections or the District Elections Office if their names were not included in the electoral register. This can be considered as a significant feature which provided such an opportunity to the electors.
- 2.2.19. The Electoral Registers for the year 2014 were certified under Section 18 of the Registration of Electors Act, No. 44 of 1980 on 31.10.2014. The Notice under Section 20 of the Act was published in *Gazette* No. 1886 / 67 of 31.10.2014 and in newspapers on the same day. Under the procedure followed in the annual revision of the electoral register, in the year 2012 and 2013, the register could be certified on the 31st of December of the respective year. However, in the year 2014, the register was certified two months before to such period. This can be considered as an historic event which was achieved for the first time.
- 2.2.20. Number of electors registered in 2013 and 2014 according to the electoral districts and the comparative statement of number of electors in polling divisions of each electoral district from the year 2005 to 2014 are shown in *Table X and XI* respectively.

2.3. Registration of Electors (Special Provisions) Act, No. 27 of 2013

2.3.1. The respective Act was passed in the Parliament on 21st of June 2013 to enable internally displaced persons and their children eligible to vote, to exercise their right to franchise in the electoral district in which their permanent places of residence were situated prior to being internally displaced as a result of military actions or certain actions of other militant terrorists or other groups in the recent past.

- 2.3.2. The notice under the provisions of the Registration of Electors (Special Provisions) Act, No. 27 of 2013 was published in the *Gazette* Extraordinary No. 1886/68 of 01.11.2014 and applications from qualified persons were accepted from 01.11.2014 to 07.11.2014.
- 2.3.3. The notice under Section 3(1) of the Registration of Electors (Special Provisions) Act, No. 27 of 2013 was published in the *Gazette* Extraordinary No. 1887/48 of 08.11.2014 and the Assistant Registering Officers of relevant electoral districts took necessary action to declare the period for submission of appeals and objections, as from 08.11.2014 to 14.11.2014.
- 2.3.4. Total number of applications received during the whole period, including the period for appeals was 349. No objections were received. Number of applications which were taken in to consideration was 322 and from that 316 applications were accepted. Information in this regard is given in *Table XII*

3. Parliamentary Elections Act, No. 1 of 1981

3.1 Recognition of political parties

- 3.1.1. The provisions in the Parliamentary Elections Act, No. 1 of 1981 regarding the recognition of political parties, were amended by Parliamentary Elections (Amendment) Act, No. 58 of 2009 which was passed on 16.09.2009 and according to the new provisions the Commissioner of Elections should call for applications from political parties for recognition in January every year. If any election is pending in this month, actions relevant to calling for applications should be taken within 30 days after such election.
- 3.1.2. Due to the elections to Pudukudiiruppu and Maritimepattu Pradeshiya Sabhas in Mullaitivu District were scheduled to be held, the conduct of elections to Western, Southern and Uva Provincial Councils in the year 2014 and due to the declaration of the order of the Commissioner of Elections on 21st November 2014 in regard to the Presidential Election which was to be held on 08.01.2015, the Commissioner of Elections was unable to issue, during the year 2014 also, the notice regarding the recognition of political parties.
- 3.2 The Commissioner of Elections is required by Section 7(4) (b) of the Parliamentary Elections Act, to publish the list of recognized political parties in the Government *Gazette* at the commencement of every calendar year. Accordingly, the list of parties for the year 2014 was published in the *Gazette* Extraordinary No. 1847/37 of 29.01.2014 and accordingly, 64 parties were

registered as recognized political parties for the year 2014. The list is shown in *Table No. XIII*.

3.3 Action was taken to fill two vacancies in the Membership of Parliament in the year 2014 and details of it is shown in *Table XIV*.

04. Administration Report of the Commissioner of Elections for the year 2013

This report was tabled in Parliament on 08.07.2014.

05. Presidential Elections Act No. 15 of 1981

In terms of Article 31 (3) (A) of the Constitution, two years before end of his term of office, His Excellency the President, Mahinda Rajapaksa, who was selected under the Section 56(2) of the Presidential Elections Act No. 15 of 1981, at the Presidential Election on 26th January 2010, expressed on 20.11.2014, his intention of appealing to the people for a mandate to hold the office, by election, for a further term. Accordingly, The Commissioner of Elections published the Notice under the Section 2 of the Presidential Elections Act, in the extraordinary *Gazette* No. 1889/31 dated 21.11.2014. By this notice acceptance of nominations and the conduct of election was ordered to be on 08.12.2014 and 08.01.2015 respectively. Accordingly, during the months of November and December, 2014, steps were taken to carry out the preliminary organization activities of the Seventh Presidential Election which was to be held on 08th January 2015.

06. Provincial Councils Elections Act, No. 2 of 1988

6.1 Provincial Councils Elections – 2014

Western, Southern and Uva Provincial Councils were dissolved during the year 2014 and the steps were taken to conduct elections accordingly. Provincial Councils of Western and Southern were dissolved at midnight of 12th January 2014 by *Gazette* notifications No. 1844/75 and 1844/76, respectively. Accordingly, notices of nominations for Colombo, Gampaha, Kalutara, Galle, Matara and Hambantota Administrative Districts which belong to Western and Southern Provincial Councils were published in the Extra Ordinary *Gazette* No. 1845/18 of 16.01.2014. Uva Provincial Council was dissolved at midnight of 11.07.2014 by the *Gazette* notification No. 1870/04. Accordingly, notice of nomination for Badulla and Moneragala Administrative Districts which belong to Uva Province was published in the Extra Ordinary *Gazette* No. 1871/32 of 16.07.2014.

6.2 Accordingly, nominations for Western and Southern Provincial Councils were received from 30.01.2014 to 12.00 noon on 06.02.2014 and for Uva Provincial

Council from 30.07.2014 to 12.00 noon on 06.08.2014 at relevant District Secretariats.

- 6.3 129 nominations were received for Western and Southern Provincial Councils and out of them 06 nominations were rejected. Total number of 3794 candidates from 123 accepted nominations of 24 recognized political parties and 42 independents groups were in contest. 18 political parties and 11 independent groups for Colombo District, 13 political parties and 09 independent groups for Gampaha District, 13 political parties and 09 independent groups for Kalutara District and 14 political parties and 04 independent groups for Galle District, 14 political parties and 05 independent groups for Matara District and 09 political parties and 04 independent groups of Hamabantota District, were contested, accordingly. There were 5,898,428 registered voters and 4253 polling stations were in the two provinces and the election was held on 29th March 2014.
- 6.4 33 nominations were received for Uva Provincial Council and all of them were accepted. Total number of 617 candidates from 33 accepted nominations was in contest. They represented 14 recognized political parties and 11 independents groups *viz.* 10 political parties and 04 independent groups for Badulla District, 12 political parties and 07 independent groups for Moneragala District. There were 942730 registered voters and 834 polling stations were in the province and the election held on 20th September 2014.

6.5 Procedure followed at the election

- 6.5.1 The competition between candidates of each of the political parties and among the candidates of the same party for preferences commenced immediately after the period of nominations. Commissioner of Elections received a large number of complaints on displaying of illegal posters, banners, cutouts and misusing of state property for election propaganda. Establishment of election offices by political parties and independent groups violating the legally allowed limits was also observed.
- 6.5.2. Number of complaints received by the Commissioner of Elections grew rapidly with the spread of this phenomenon. Action was taken to establish complaint centers in all District Secretaries apart from the complaint centre established at the Elections Secretariat to accept complaints.
- 6.5.3. Besides to the Consultative Committee comprising of Secretaries of all contesting political parties and the Inspector General of Police which met regularly, a Standing Committee consisting of representatives of political parties and observer organizations was also established at the Election Complaints Monitoring Bureau to discuss and obtain views about the matters relating to conduct of free, fair and peaceful election.
- 6.5.4. Deputy / Assistant Commissioners of Elections of all the districts, where there were no elections, were attached to the districts where elections

- were conducted and all steps were taken to prevent increasing illegal activities.
- 6.5.5. Secretaries to all Ministries, Chief Secretaries of Provincial Councils and Heads of Institutions were issued written instructions on prohibition of misuse of state property. Additional Secretaries of Ministries were summoned to a meeting held at the Elections Secretariat, at which indepth instructions were given on prevention of misuse of state property. Lengthy discussions about the steps to be followed at Government Institutions on appointments and transfers during this period were held. Large amount of complaints about appointments and transfers on political grounds received during this period and necessary steps were followed regarding them.
- 6.5.6. Guidelines to private and public media institutions were issued, Heads of media institutions were summoned and necessary instructions about the conduct of the media during the period of the election were given to them. Further, a code of conduct was issued to the political parties.
- 6.5.7. The Commissioner of Elections continuously interacted personally with the Secretaries of Ministries, Chief Secretaries of Provincial Councils and District Secretaries during this period and took all necessary steps to ensure the conduct of a free and fair election by preventing illegal activities.
- 6.5.8. Steps which were followed at the previous elections to ensure the security of polling stations and ballot boxes were implemented at this time also and necessary action was also taken after considering the various requests made by the political parties in this regard. Appropriate action was taken especially to get rid of doubts expressed by political parties regarding the poll, count of votes and declaration of results.

6.6 Pre election period and poll day

- 6.6.1. The poll day was calm and peaceful though the pre election period recorded disturbances and clashes to some extent. No incidents of obstructive nature occurred to disturb the poll other than some minor incidences. Especially, the National Identity Card was mandatory for expressing the vote, situations arising out of attempts to impersonate were minimal.
- 6.6.2. A minimum of one officer from other districts was deployed to polling stations, in addition to the officers in the district for poll duties. All the officers of the Department of Elections and officers from other Departments who were engaged with the duties of the Department were also deployed for duties in the districts. The aim of the Commissioner of

Elections was to carry out a comprehensive observation about the election by them. The number of centres for receiving election related complaints which were established throughout the pre election period was increased further on the poll day. Necessary steps were taken to refer the complaints, which were received by the centres, to the relevant places instantly for follow up action regarding them. Counting of votes commenced as scheduled as there were no adverse reports received through observation reports which justified annulment of polls.

6.7 Counting of votes and declaration of results

- 6.7.1. At the Western and Southern Provincial Councils Elections, there were a total of 14 counting centres established in six districts and they were consisted of 569 ordinary counting halls and 59 postal votes counting halls. The results of each centre were received, checked at the Head Office and confirmed by the Commissioner of Elections. Results which were confirmed were given to the electronic medias through the Director of Information for broadcast. Under Section 60 of the Provincial Councils Elections Act No. 2 of 1988, the names of the elected members were published in *Gazette* No. 1856/9 of 01.04.2014 by Commissioner of Elections.
- 6.7.2. In relation to the Uva Provincial Council Election there were 5 counting centres established in two districts and they were consisted of 90 ordinary counting halls and 20 postal votes counting halls. The results of each centre were received and checked at the Head Office and confirmed by the Commissioner of Elections. Results which were confirmed were given to the electronic medias through the Director of Information for broadcast. Under Section 60 of the Provincial Councils Elections Act No. 2 of 1988, the names of the elected members were published in *Gazette* No. 1881/15 of 23.09.2014 by Commissioner of Elections.
- 6.7.3. Detailed results of the Western, Southern and Uva Provincial Councils where the elections were conducted are shown in the *Table XV*.
- 6.8. Details regarding to filling of vacancies of members of Provincial Councils during the year 2014 are shown in *Table XVI*.

07. Local Authorities Elections Ordinance (Chapter 262)

7.1 Elections to Puthukudiiruppu and Maritimepattu Pradeshiya Sabhas of Mullaitivu District were not conducted during the year 2014, also, due to the interim order to postpone the elections, was issued by the Court of Appeal on 19th March, 2012. Accordingly, none of the Local Authorities Elections were conducted during the year 2014 and only the vacancies in Local Authorities were filled.

7.2. Relevant details of filling of vacancies in Municipal Councils, Urban Councils and Pradeshiya Sabhas are shown in *Table XVII*, *XVIII* and *XIX*.

08. Staff

8.1 Creation of new posts

In view of the increase in the work of the Department of Elections, action was taken to create the following posts, with the approval of the Management Services Department.

- 8.1.1. A post of Assistant Commissioner of Elections, Class III of Sri Lanka Administrative Service have been approved by Director General, Department of Management Services of Ministry of Finance and Planning, by his letter No. DMS/1014 dated 30.05.2014 for Gampaha District Elections Office of this Department.
- 8.1.2. By the letter No. DMS / 1014 dated 30.10.2014, the Director General of Management Services Department of Ministry of Finance and Planning, one post of Deputy Director (Research and Planning), Class II of the Sri Lanka Planning Service have been approved to this Department.
- 8.1.3. One post of Supra Class of Public Management Assistants' Service for the Vavuniya District Election Office of this Department was created with the approval of Director General of Management Services Department, of Ministry of Finance and Planning by his letter No. DMS / 1014 dated 10.11.2014.
- 8.1.4. One post of Additional Commissioner of Elections, Special Class of Sri Lanka Administrative Service and one post of Class III/II/I of Development Officers' Service were created with the approval of the Director General of Management Services Department, Ministry of Finance and Planning by his letter No. DMS / 1014 dated 08.12.2014.
- 8.1.5 Action was taken to create more posts within the year 2014, with the approval of the Management Services Department in view of the increase in the work of the Department of Elections. Accordingly, one post of Translator (Sinhala Tamil) and five posts of Drivers of Combined Drivers' Service were created. 14 posts of Public Management Assistants of Public Management Assistants' Service which have been approved for this Department were suppressed and 14 posts of Information and Technology Assistants of Class III of Sri Lanka Information and Technology Service were created.

8.2. Appointments

- 8.2.1. Mr. S.W. Welgama, Class III of Sri Lanka Administrative Service, who was attached to this Department from 01.04.2014 by the letter No. R/1/1/2013Post of 27.03.2014 of Secretary to the Ministry of Public Administration and Home Affairs, was appointed as the Assistant Commissioner of Elections of Kilinochchi District Elections Office with effects from 19.05.2014 and then as the Assistant Commissioner of Elections of Trincomalee District Elections Office from 01.12.2014.
- 8.2.2. By the letter No. R/1/1/2014Post dated 07.08.2014 of the Secretary to the Ministry of Public Administration and Home Affairs, Mr. R.C. Amalraj of Class III of Sri Lanka Administrative Service, who was attached to this Department from 14.08.2014, was appointed as the Assistant Commissioner of Elections of Kilinochchi District Elections Office with effects from 15.11.2014.
- 8.2.3. Mr. P. Channa Pushpamal De Silva of Class III of Sri Lanka Planning Service, who was attached to this Department by letter No. MF 13/C2/1/67 dated 28.11.2014 of the Deputy Secretary to the Treasury, was appointed as an acting Deputy Director (Research and Planning) from 02.12.2014.
- 8.2.4. The total number of vacancies in cadre of the Public Management Assistants' Service was 54 as at 31.12.2013. Ministry of Public Administration gave 41 persons from the new recruitments of Public Management Assistants' Service to fill these vacancies.
- 8.2.5 A paper Advertisement was published to recruit 25 Development Officers and 17 qualified officers were selected from the applications received. Ministry of Public Administration was informed to make their transfers to the Elections Department. But only 3 officers permanently transferred to the Department. One of them was attached to the post of Budget Assistant, and other two were attached to the Vavuniya District Elections Office and Jaffna Elections Office.
- 8.2.6 Approval of Cabinet of Ministers was given to extend up to 02.02.2015, the service period of 12 casual Management Assistants who were recruited by the Department of Elections to meet the special needs of working in both official languages.
- 8.2.7 Action was taken to recruit 14 qualified persons who were selected by an interview conducted according to the provisions of P.A. Circular 24/95 and Service Minute of Office Employees' Service, to fill the vacancies in Office Employees' Service of the Department of Elections, with effects from 01.08.2014.

8.3 Promotions

- 8.3.1 Mr. M.A.P.C. Perera, Special Class of Sri Lanka Administrative Service who is serving as the Deputy Commissioner of Elections at Ratnapura District Elections Office was appointed to the post of Senior Deputy Commissioner of Elections at Ratnapura District Elections Office with effects from 12.12.2014.
- 8.3.2 Mr. M.M. Mohamed, Special Class of Sri Lanka Administrative Service and is serving as the Deputy Commissioner of Elections (Administration) at the Elections Secretariat was appointed to the post of Additional Commissioner of Elections (Law and Investigation) of the Head Office with effects from 01.11.2014.

8.4. Transfers

- 8.4.1. Mr. S. Achchuthan, Class II of Sri Lanka Administrative Service who was serving in the Head Office as the Assistant Commissioner of Elections (Administration) was appointed as the acting Assistant Commissioner of Elections of Colombo District with effects from 22.04.2014.
- 8.4.2. Mr. A. O. M. Nafeel, Class I of Sri Lanka Administrative Service was appointed as the Deputy Commissioner of Elections of Northern Province from 05.05.2014.
- 8.4.3. Mr. P. R. N. H. Ratnayake, Class III of Sri Lanka Administrative Service who was serving in the Trincomalee District Elections Office was appointed as the Assistant Commissioner of Elections (Administration) with effects from 01.12.2014.
- 8.4.4. Four officers of Public Management Assistants' Service were transferred out of the Department under the annual transfers in 2014 and their four substitutes assumed duties in the Department.
- 8.4.5. Another 14 officers of Public Management Assistants' Service who expressed their desire to serve in this department were transferred to this Department in 2014 under inter department transfers.
- 8.4.6. Eight officers of Public Management Assistants' Service, three members of Office Employees' Service and one driver were transferred out of the Department and the service rendered to the Department by all of them is appreciated.

8.5. Transfers out of the Department

8.5.1. Mr. N. D. Laththuwahandi, Class III of Sri Lanka Administrative Service who was serving as the Assistant Commissioner of Elections, Colombo District was attached to the Regional Administration Unit, by the Ministry

- of Public Administration and Home Affairs by his letter No. 75/10/5039 dated 31.12.2013. He was therefore released from the Department of Elections with effect from 06.01.2014. Mr. K. A. Sumith Chandana, Class III of Sri Lanka Administrative Service was released from the post of Assistant Commissioner of Elections, Puttalam District with effect from 02.01.2014, enable him to assume duties at the Department of Agrarian Development as per letter No. 75/10/5227 dated 31.12.2013 of the Secretary, Ministry of Public Administration and Home Affairs.
- 8.5.2. These two officers as Assistant Commissioners of Elections at their respective offices and at other District Elections Offices on service requirement, have rendered valuable support to complete the works of the Election Department effectively. The support they provide when it is necessary for activities in relation to the conduct of elections and carry out the revision is greatly appreciated.
- 8.5.3. Mr. T. Nakuleshvaran, Mr. W. Suresh and Mr. U. J. M. Tilakaratne who were serving at District Elections Offices in Jaffna, Galle and Kandy, respectively, were released from this Department, with effect from 13.01.2014, as they passed the competitive examination for Promotion of Minor Employees of Public Service to the Class III of Public Management Assistants' Service.
- 8.5.4. Ms. S.M.S.R. Jayathilake (Ampara), Ms. E.V.S.I. Harshani (Colombo City), Ms. E.G.C.J. Sumanaratne (Colombo City), Mr. R. Pravintharaj (Head Office) and Ms. W.P.C.C. Weerawardhane (Gampaha), Public Management Assistants' Service who were serving at this Department were released during the year 2014 as they were obtained other posts in the public service and state banks.
- 8.5.5 Mr. K. A. I. A. Ratnasekara who was attached to the Colombo City Elections Office and Mr. A. A. D. A. S. Alahakoon, Class II of Public Management Assistants' Service and was serving in the Elections Secretariat, were resigned from the public service with effect from 12.01.2014 and 10.07.2014, respectively, due to personal reasons.
- 8.5.6. I admire the services rendered to the Department by all of above officers who were serving in the Department and were released to serve at other Departments, institutions, etc. Especially, Mr. A. A. D. A. S. Alahakoon who served as the acting Head of Information Technology Unit for two years and rendered his service for the development of the Information Technology Unit and resigned due to his personal reasons is greatly appreciated. Further, the support rendered by most of the officers who came to undertake the essential duties of the department, even after their departure, was very much helpful to successfully carry out the duties of the department.

8.6. Retirements

- During the year 2014, 08 officers of Public Management Assistants' 8.6.1 Service and three members of Office Employees' Service of this Department retired from the service. Among these officers Ms. D. C. S. Jayasinghe, assumed her duties at the Department of Elections on 01.01.2003 and when she retired on 10.11.2014, was serving as the Chief Public Management Assistant of the Colombo City Elections Office. Also Mr. H. D. Gunaratne, joined to the Department on 25.06.1979 and at the time of his retirement, on 30.03.2014, he served as the Chief Public Management Assistant of the Kurunegala District Elections Office. Persons of Public Management Assistants' Service, Ms. Janaranjani Thanapalan of Colombo City Elections Office, Ms. P. M. Samsun Najeeha of Matara Elections Office, Mr. S. M. S. N. Bandara of Matale Elections Office, Mr. L.P. Chandrasena and Mr. P. G. Dhanasiri Nandapala of Kalutara Elections Office and members of Office Employees' Service, Mr. J. Arivaratne of Hambantota District Elections Office, Mr. D. M. Jayasundara of Badulla District Elections Office and Mr. B. G. Leelaratne of Kandy District Elections Office also retired. Ms. P. Sutharshan, Public Management Assistants' Service was retired on medical grounds. The services rendered to this Department by all of these retired persons are appreciated. Detailed report of the retired officials retirees is shown in *Table No. XX*.
- 8.6.2. Ms. S. Sithambaranathan, Class I of Public Management Assistants' Service, was attached to the Jaffna District Elections Office from 28.06.1991 to 21.01.2014, was passed away on 22.01.2014 due to an illness. Action was taken to provide the relevant benefits to her dependants. Ms. Sithambaranathan was a very conciliatory officer who was working with friendly mind towards all the officers of the Department of Elections and was very skillful in coordination activities. I admire the service she rendered to the Department.

9. Trainings

9.1 Local

- 9.1.1. Steps were taken to provide subjective knowledge to the staff officers, officers of Public Management Assistants' Service and to the Drivers through the training programmes conducted by organizations such as Sri Lanka Institute of Development Administration, Institute for Construction, Training and Development, Department of Official Languages, Ministry of Youth Affairs and Skills Development, Sri Lanka Foundation Institute and Skills Development Fund, etc.
- 9.1.2. Several training programmes on Accounts and Payments, General Administration, matters in relation with Storeroom Administration and

Audit, revision of electoral registers, co-ordination in between District Elections Offices and the Head Office and performance of special duties assign at a election, were conducted at the Head Office, to make relevant officers of all District Offices aware about minimization of audit queries in District Elections Officers including the Head Office.

- 9.2.1. Mr. S. D. S. A. Rupasinghe, Assistant Commissioner of Elections of Matale District, participated in the "Second State Training of Post Graduate Degree Programme" held in Malaysia, from 31.01.2014 – 07.02.2014.
- 9.2.2. Mr. S. D. S. A. Rupasinghe, Assistant Commissioner of Elections of Matale District, attended for the Training on Management of Elections held in India, from 19.04.2014 to 23.04.2014.

- 9.3.1. Deputy Commissioner of Elections, Mr. M. M. Mohamed attended to the "Common Wealth Election Officers' Workshop" held in Kenya from 23.06.2014 to 26.06.2014.
- 9.3.2. The Commissioner of Elections, Mr. Mahinda Deshapriya, Deputy Commissioner of Elections, Mr. M. M. Mohamed and the Co-ordination Secretary to the Commissioner, Mr. R.M.A. Hameed participated in the "SAARC Election Authorities Workshop", held in Malaysia, from 07.10.2014 11.10.2014.
- 9.3.3. Mr. J.A.S.P. Jayasinghe, Assistant Commissioner of Elections attended the Workshop on "Desires of Voters and the Contribution of Women in Electoral Process" held in Bhutan from 12.10.2014 to 16.10.2014.
- 9.3.4. Mr. R.M.A.L. Ratnayake, Additional Commissioner of Elections and Deputy Commissioner of Elections, Mr. M. M. Mohamed left the island to participate for the "SAARC Regional Experience Sharing Workshop", held in India from 17.10.2014 to 21.10.2014.
- 9.3.5. The Commissioner of Elections, Mr. Mahinda Deshapriya and the Coordination Secretary to the Commissioner, Mr. R.M.A. Hameed participated to the "Asian Election Authorities Conference" held in India from 28.10.2014 to 31.10.2014.
- 9.3.6. The Commissioner of Elections, Mr. Mahinda Deshapriya, Deputy Commissioner of Elections, Mr. S. Achchuthan and the Co-ordination Secretary to the Commissioner, Mr. R.M.A. Hameed participated in the "Fifth Forum of Election Management Bodies of South Asia", held in Nepal, from 29.11.2014 01.12.2014.

11. Financial Information

- 11.1. Rs. 986.84 million and Rs. 293.87 million was spent to conduct elections for the Western and Southern Provincial Councils Elections and for the Uva Provincial Council Election, respectively. The cost per elector for Western and Southern Provincial Councils has being decreased and the cost per elector for Uva Provincial Council has being increased when compared to the Central, North and North Western Provincial Councils Elections, held in the previous year. While the large number of registered voters in the Western and Southern Provincial Councils and the small number of registered voters in the Uva Provincial Council were the reasons for above change.
- 11.2. The cost of preparation of the electoral register in year 2014 was approximately Rs.104 million which shows an increase of Rs. 17 million compared to the expenditure incurred in regard to the year 2013. The expenditure in this year was increased due to the conduct of special awareness programmes for voters after naming the 01st of June 2014 as "Voters Day" and the printing of the electoral register necessary for two island wide elections.
- 11.3. The recurrent expenses in year 2014 and 2013 were Rs. 2095 million and Rs. 1315 million respectively. The recurrent expenses show a 59% increase when compared to the previous year. Expenses which had to incur for the conduct of elections to Western, Southern and Uva Provincial Councils and for the preliminary activities of the Presidential Election which was scheduled to held on 08.01.2015 were the reasons for this increase.
- 11.4. The capital expenditure in 2014 was Rs.79.1 million and was Rs. 38.5 million higher than in 2013. The increase in the capital expenditure was due to the completion of the addition of a new portion to the Head Office, repairs and maintenance of existing buildings and purchase of necessary computers, equipment and office items to the District Elections Offices.
- 11.5. All the applications for disaster loans were granted in this year and loans up to Rs.6.6 million was paid to 85 members of the staff. This is a decrease of Rs. 10.8 million compared to the previous year and was due to the decrease of number of applicants in the year.

- 11.6. Revenue earned by issue of extracts of the electoral register was Rs. 4.65 million in the year 2014 and it indicates a decrease of Rs. 3.9 million when compared with the previous year. The reasons for the decrease in this regard is due to the limitation of issuing the extracts of the electoral register as there were elections conducted throughout the year.
- 11.7. With the increase of production of the register in CD format while limiting the preparation of the register in book form, Rs. 1.92 million revenue could be earned by sale of electoral register through compact discs, in 2014.
- 11.8. Rs. 377,791/- was expended on domestic training courses of staff officers and non-staff officers to improve the efficiency of the Department.

12. Conclusion

Both two duties devolved to the Commissioner of Elections by the Constitution viz. annual revision of electoral register, thereby preparing of the electoral register and conduct of elections, were carried out during the year 2014. Especially, while the Commissioner of Elections has vested from the relevant Acts and Orders, twelve months time period to prepare and certify the electoral register, the effort made by all the officers of the Department of Elections to certify the register for the year 2014 within a five month period for the first time, in consideration with the matters relating to the conduct of Presidential Election which was appearing at the end of the year 2014 and the requests made by various political parties, multinational organizations and the general public in that regard, is greatly appreciated. Further, activities in relation to the conduct of Western, Southern Provincial Councils Elections and the preliminary actions of the Presidential Election which was scheduled to conduct within a very limited period of time, could be completed in the proper way with the assistance of the officers of and outside the Department. Especially, it should also be notified that to ensure the conduct of a free and a fair election, certain actions, which were not applied in previous occasions, had to arrange to get rid of the circumstances aroused.
