MESSAGE OF THE SECRETARY OF STATE MINISTRY OF DEFENCE







PERFORMANCE OF DIVISIONS

1. POLICY AND PLANNING DIVISION

1.1 Overview

Policy and Planning Division is engaged in the preparation of the "National Security Policy" to strengthen the security provisions for the present time and for the coming decade. This division also act as the unit to monitor the progress of the utilization of provisions which are annually allocated for the Ministry and State Ministry of Defence.

1.1.1 Functions

- Coordinate the matters related to Defence Sector Policy formulation.
- Preparation of progress report and performance report and table them at the Parliament.
- Preparation of Action Plan
- Preparation of Project Proposals and submission to the Department of National Planning for funding requirements.
- Preparation of Cabinet Memoranda and obtain the Cabinet approval for the projects which exceed Rs 20Mn.
- Supervision of the projects carried out by the Ministry of Defence and its affiliated Institutions as well as the reviewing of the progress of those projects
- Provide information regarding projects to the other government Institutions
- Take necessary action to provide the assistance for the special projects and programmes which are being implemented by the line Ministries.Ex.Disaster Management.
- Supervision of the Special Projects implemented by the the affiliated Institutions and report the progress to the President Secretariat.
- Supervision of the physical progress of the projects/programmes.

1.2 Achievements in 2016

▼ Formulation of the Defence policy

Ministry is in the process of formulating of National Defence Policy with the participation of the three forces. A core team comprising senior offices of the three forces has been appointed to look into all aspects of the defence policy. All the matters related to the policy formulation were coordinated by the division.

Established "Institute of National Security Studies of Sri Lanka (INSSSL)

INSSSL was established and matters between the Ministry and INSSSL were coordinated.

■ Preparation of the Performance Report-2015

Performance report of the Ministry for the year 2015 was completed and tabled at the Parliament. In addition, performance reports of the Three Armed Forces were tabled at the Parliament.

Preparation of the Annual Progress Report - 2016

The progress report was prepared by analyzing the progress of the functions of the Divisions and Institutions coming under the purview of the Ministry of Defence for the time period starting from 01.01.2016 to 31.08.2016 and tabled at the Parliament in time.

■ Preparation of the Action Plan – 2017

Action Plan for the year 2017 was prepared and forwarded to the President Secreatariat, Treasury Operations Department, Department of Project Management and Monitoring and National Budget Department.

■ Progress review of the projects

Reports regarding the progress of the projects which have been implemented by the Ministry and the affiliated institutions were prepared regularly and forwarded to the President Secretariat, National Budgrt Department and Department of Project Management and Monitoring.

Progress of the decisions taken by the Cabinet Committee on Economic Managemant (CCEM)

Progress of the functions which were assigned to the Ministry by the Cabinet Committee on Economic Managemant (CCEM) was monitored.

Sectoral Oversight Committee on National Security(SOCNS)

Reports regarding the legal systems of the Ministry and affiliated institutions and progress of the budgetary provisions were forwarded to the SOCNS.

■ Report the progress to the Department of National Budget (DNB)

Reports regarding the Financial and Physical progress of the provisions allocated for the year were prepared and submitted every two weeks following the formats introduced by the DNB.

■ Humanitarian Search & Rescue Capacity Development

Equipment and training which required for the capacity development of the Search and

Rescue teams of Three Armed Forces were provided.

1.3 Future Prospects

- Necessary measures will be taken to prepare a data base which included with the information regarding the projects implemented by the Ministry and the affiliated institutions.
- ▶ Monitor the effective utilization of provisions allocated for the year according to the Action Plan for the year 2017.
- ▶ Preparation of Action Plan for the year 2018, forward to the relevant government institutions and monitor the effective utilization of provisions.
- ► Forward the duly prepared Performane Report-2016 to the Parliament in time.
- Coordination of matters related to the Policy formulation.
- ▶ Monitoring the progress of capacity development of Search and Rescue Teams.

2. DEFENCE DIVISION

2.1 Overview

The Defence Division of the Ministry of Defence is in-charge of all the establishment and administrative matters of the Three Armed Forces. In addition, this division is in-charge of armed forces related duties engaged in UN Peacekeeping Missions and establishments duties of Department of Sri Lanka Coast Guard.

2.2.4 Ranawiru Surekum Allowance

Offering 100 percent of pension by adding 15 percent of Ranawiru Surekum Allowance to the 85 percent of pension for the military persons, disabled in action due to terrorist activities and entitled for salary and pension up to 55 years of age according to the Cabinet decision No 1982/305/(09) dated 21.07.1982, for the wives of disabled military persons, and widows of deceased military persons entitled for salary and pension until the death of military persons or their wives.

2.2.5 Arrears of Salary

Submission of Cabinet paper on 07.04.2016 to take necessary measurements to pay arrears of salary from the date of retirement up to 01.31.2014, for 1573 Tri forces disabled military persons resigned or retired after completing relevant years of service without any benefits due to disability of more than 20 percent and less than 50 percent in action under the Cabinet decision No 1982/305/(09), settling the arrears pension during 15 years by paying 1/15 of the total pension per year. Approval has been granted for the Cabinet paper through Cabinet paper 16/0754/703/034-I and Cabinet Decision dated 13.12.2016.

2.2.6 10/12 Pensions

According to the instructions given by His Excellency the President regard to the offering of pension to resigned officers with uncompleted 10 years of service and other rankers with uncompleted 12 years of service due to disablement in action, Code amendment of Armed forces Pension and Gratuity 1981 has been completed through the Extraordinary Gazette No 1992/76 and 11/11/2016.

2.2.7 Disability Pension

Gazette announcements, related to the Code amendment of Armed forces Pension and Gratuity 1981 regarding the offering of disability pension, have been forwarded to the Attorney – General.

3. TECHNICAL DIVISION

3.1 Overview

Technical Division of Ministry of Defence is entrusted to deal with communication and engineering matters in relation to national security whilst formulating strategies for the utilization and development of its applications to be used by the general public of the Country. Communication Scope covers Radio Communication, Telecommunication Services. Television Broadcasting, Data Communication and Providing observations and granting approval required by the Telecommunication Regulatory Commission of Sri Lanka for the importation, Installation and Commissioning of Communication, Navigational and Surveillance equipment which could affect the national Security. Engineering Scope covers all civil and field engineering support required to develop infrastructure facilities instructed by the Government Island wide whilst ensuring the National Security.

Technical division Coordinates and liaise with line Ministries and Institutions on communication and engineering matters with regard to national security.

Defence Head Quarters Complex Project (DHQC) and the Strategic Defence Communication Network (SDCN) project are the ongoing major projects implemented by the division, at present. In addition, research projects implemented by Center for Research and Development (CRD) are also supervised by the Technical Division.

3.2 Analysis of activities conducted by Technical Division

In 2016, the division granted security clearance for Telecom Operators to construct 197 towers. Further, granted Security clearance for 160 vendor licenses of Electronic / Communication related applications.




Chart 3.1: Security Clearnces for Tower Construction 2016

Security clearance was given for importation of Communication and Navigational equipment, Vehicle Tracking Systems, Colour multifunctional Printers, Drones (Quardcopter, Airplane, UAV) and radio equipment for Armature Radio License Holders (Local/Foreign), GPS.




Chart 3.2 : Security Clearnces for visiting to Towers at Military Complexes – 2016

Security clearance on allocation of Radio Call Signs/ Frequencies for 629 fishing trawlers registered in Fisheries and Aquatic Department was granted in liaison with Telecommunication Regulatory Commission of Sri Lanka (TRCSL).

3.2.1 Defence Headquarters Relocation Project

Colombo Master Plan of 1979 envisaged shifting of government officers from Colombo to the new administrative capital of Sri Jayewardenepura Kotte enabling release of large extents of highcommercial-value land for commercial development. The prime objectives of all Services to come under one Defence Headquarters Complex was to effectively utilize resources presently divided amongst several institutions and to minimize the duplication of infrastructure, to provide defence personnel with a state of the art office complex to enhance their Operational/ Administrative/Logistic efficiency and to minimize the disturbances caused to the general public and to economic activities by minimizing the presence of high security zones within the Concentrated Development Zone. The construction started in year 2011 and have been progressing to date. The construction activities are phased out into two for the convenience of construction management and to maintain financial viability.

3.2.1.1 DHOC Project - Phase I

Phase I consists of construction of the Main Buildings complex (Nine blocks), Communication Building, Security Building, Water Sump & Pump House, Permanent Accommodation for 250 Officers & Permanent Accommodation for 2500 out of 6100 Others Ranks.

Phase I is further divided in to following stages due to financial restrictions enforced during the constructions.

Stage 01 - To complete Blocks 6,7, 8, Communication Building, Security Building, Water Sump and Pump House, and Other Ranks Accommodation at Kinnadeniya before 28th February 2018.

Stage 02 – Construction of balance work of phase I.

3.2.1.2 DHQC Project - Phase II

Phase II consists of permanent accommodation and associated facilities for 500 Officers and 6100 living-in staff (OR) of Tri Forces including cook houses/messes and related external works.

3.2.1.3 Project Management & Construction

To facilitate construction, a project specific structures were established. Project Management Unit (PMU) for Project management and procurement and Construction Management Unit (CMU) for Construction work of the project.

Project consultant is Central Engineering Consultancy Bureau for consultants for architectural and structural design, MEPI and Quantity Surveying.

3.2.2 Strategic Defence Communication Network Project

Strategic Defence Communication Network (SDCN) Project will provide a secure common communications backbone which consists of 37 microwave links and Network Management System (NMS) connecting pre-selected terminal points of the Tri Forces, Police and STF in Island wide.

In 2016, installation of 10 electrical generators was completed out of 22 electrical generators and tenders for construction of eleven self-supported towers and thirty seven microwave radio links were evaluated and to be forwarded to the tender board.

During the period (January to December 2016), physical progress is 10 percent and financial progress is comparatively low at 3.3 percent out of annual allocation.

3.2.3 Centre for Research and Development

CRD is located at Moragahena Road , Pitipana, Homagama. A two storey building was constructed to facilitate administrative functions and Other Rank accommodations. Under the third stage construction of another two storey building was completed to provide accommodation for Research Officers attached to CRD and declared open by the Secretary of Defence.

Physical progress of construction works as at 01st January 2016 was (Phase 1) 35.3 percent and overall progress (Phase1) as at 31st December 2016 was 40.8 percent. Due to issues faced with award of major tenders such as Ceiling, General Area Tiles, Wet Area Tiles and Fittings, Decorative Timber Roof, the cascading effects have impacted the progress of MEPI which has retarded the overall progress of the project, extending the possible occupancy date whilst incurring additional costs.

Present Commitment and Payments – 5,071,741,113.15 (84.53 percent of the annual allocation for 2016). Due to Zero margin procedure adopted in opening of LC's, though a financial commitment exists and provided for LC payments, it is likely to rollover to 2017.

3.3.1.3 Special Issues

The major issue of the project is claiming of Extension of Time (EOT) and nine contractors have already submitted their claims for respective contracts.

Target Based evaluation criteria was introduced to all tradesman to expedite constructions and to monitor progress, with additional responsibilities vested to Director Construction Management Unit, Deputy Directors and Project Managers. This has paved results where all structural construction within the scope of service personal are almost complete or on schedule. This status could be further enhanced if the proposed organization structure for the project shelved from mid-2016 is sanctioned and approved.

A program was initiated in liaison with ACTA to evaluate workmanship of tradesmen whilst working "on the job" and to get the accreditation for them to receive NVQ certification.

Common facilities in the project such as Auditorium, Water sump, Water mains, Power Supply were commenced to meet occupation deadlines of Army Headquarters, Office of Chief Defence Staff and Ministry of Defence.

Over and above the priorities vested on construction of Blocks 6, 7 & 8, the balance work in other blocks of main building complex to minimize damages due to exposure to elements, resulting in deterioration of structures were re-commenced with spill over strengths (tradesman) to ensure structural stabilities are maintained /restored.

3.3.2 Strategic Defence Communication Network Project

3.3.2.1 Issues and Challenges

Issues on acquiring adequate land extent caused delay in floating the tender for construction of eleven self-supported communication towers. As most of the bidders have submitted incomplete bids, tenders for towers and Microwave Radio may have to be recalled. Balance electrical generators (12 No's) can be installed once the construction of eleven self-supported communication towers is completed in 2017.

3.3.3 Center for Research and Development 3.3.3.1 Financial and Physical progress of the projects

CRD was able to complete a considerable number of projects successfully during the year with limited number of research officers and limited budget.

3.3.3.2 Issues and Challenges

- CRD having required to procure items and equipment required for research projects only from registered suppliers of the MOD faced difficulties in sourcing such items and equipment due to high prices quoted, unavailability of suppliers for certain items and delays in supplying ordered items and equipment. It is therefore emphasized the need to adopt a mechanism to purchase such items from competitive suppliers in the open market.
- Items that are not available in the local market required to be imported directly and CRD faces difficulties in settling payments for such imports.

3.4 Work Postponed to next year

One of the main functions of this Division is the assigning and vesting /acquisition of land for the use of military with coordination with the Divisional administration, Ministry of Lands, Land Commissioner's Department. In regard to the above, the following functions were carried out during 2016

- Obtain land vesting/ acquisition applications through the Three Forces.
- Obtain the recommendations and observations from the Divisional Secretaries and the institution where land ownership is vested.
- Submit the land acquisition/ vesting. requests to the Secretary of Land Ministry and Land Commissioner General with all required supporting documents.
- Carry out field inspection in the case of uncertainty occurred in ownership of the lands
- Coordinate surveying of lands and obtaining valuation reports of lands.
- Obtain the approval of the Treasury to pay the compensation for the lands to be acquired.
- Obtain the approval of the Cabinet for special land acquisitions.

In addition, to support the Government's initiative in supporting the reconciliation and resettlement activities the Division together with the three armed forces coordinates matters pertaining to the returning of lands to the original owners.

The progress of the land released from 01.01.2016 up to 31.12.2016 can be summarized as follows.

In addition, relevant officers were participated with necessary information for the Sectoral Oversight Committees on other Ministries when called for

4.2.2.4 Standing Orders and Adjournment Motions

During the period of review, answers have been provided to 05 Adjournment Motions and 08 Standing Orders.

4.2.2.5 Preparation of Cabinet Memorandums and provide observations for the Cabinet Memorandums

Nine (09) Cabinet Memorandums were prepared and forwarded to obtain the approval of the Cabinet of Ministers. As well as the observations of the Minister of Defence were prepared and forwarded for 17 Cabinet Memorandums.

4.2.2.6 Budget Debate at the parliament

All necessary actions were taken for the representation of relevant Senior Officials of the MOD at the reading the expenditure head of the Ministry of Defence in Committee Stage Budget debate at the parliament on 07.12.2016

4.2.2.7 Provision of uniforms and Textile materials for the Three Forces. (DTAC)

Matters related to the purchasing of apparel materials to the Three Forces and the Department

of Civil Security were being carried out with the coordination of the Ministry of Industries and Commerce by calling the quotations from the local manufacturers with accordance to the tender procedure.

In the year 2016 Cabinet approval was obtained to purchase uniforms & Textile materials worth of Rs. 1,872,215,000.00 for the year 2017 for the three armed forces and the Department of Civil Security.

4.2.2.8 Appeals and Grievances of the General Public

Necessary actions were taken to provide the reliefs to the appeals and grievances made by the general public directly to this Ministry and also though the Presidential secretariat, Office of the Prime Minister and other Government Institutions.

4.2.2.9 Internal administrative matters

General administrative, training and welfare activates of the Officers of the Division were being carried out effectively and efficiently. Officers in the Division have been trained though the opportunities made available by the Administration Division. In addition, an interactive session named "Sathara Diganthaya Horawa" has been initiated to strengthen team work and enhance skills and knowledge of the staff.

Two main projects are being implemented under this programme.

1. Project of constructing entire houses.

Under this project necessary actions are being taken to construct the entire houses and hand over to the warheroes deprived of a house of their own.

2. Partially complete house scheme.

Under this project necessary actions are being taken to complete partially built houses for the warheroes.

5.1.2 "Sathviru Sanhinda" partially built housing project

This project is being carried out by the Ministry to complete partially built houses for the warheroes at present by covering the whole island through the budgetary provisions allocated by the Government for the warheroes who had rendered their youth to the acrimonious war to bring forth a unitary land.

5.2 Armed Services Welfare Division

Conduct the welfare matters of retired war heroes and personnel still engaged in service in the Three Armed Forces and the civil Defence Service, those who had rendered their lives for the unity and the territorial sovereignty of the motherland. Following functions are being carried out under this division.

- Provide lands to the warheroes deprived of a land of their own to build a house.
- Take necessary actions to solve the discrimination taking place over school admission of the children of the warheroes.
- Provide reliefs over the transfers of spouses of the warheroes in the State sector.
- Provide assistance to solve the land problems of the warheroes.
- Implement welfare programmes for the warheroes.

6. CIVIL SECURITY & DEVELOPMENT DIVISION

6.1 Overview

In executing the functions assigned to this division, following main objectives are expected to be fulfilled.

- Building a secure civil society.
- Ensure safety in the utilization of explosives in the commercial field.
- Provision of regulated Private Security Service facilities and authentication of Maritime Security Service Agencies.
- Provision of opportunities of educational and professional development to members of the Armed Forces, the Police and the Civil Security Force and to their children.
- Providing assistance to realize the institutional, administrative and development projects coming under the scope of the Department of Civil Security.
- Matters related to General Sir John Kotelawala Defence University
- Matters related to Joint Services Language Training Institute at Kothmale
- Admission of Children of members of the Tri Forces and the Police to First grade on the basis of active Service
- Importing equipment for mine clearing and matters pertaining to it.
- Internal Administrative matters of the division
- Human rights matters and the National Anti-Human Trafficking Task Force.

6.2 Achievements in 2016

With the intention of fulfilling above objectives, following tasks have been completed by this division from 01.01.2016 to 31.12.2016

- Under two programmes carried out in April and June 2016 to hand over illegal firearms to the Government, 846 illegal firearms have been turned over to the Government and handed over to the Sri Lanka Army for disposal.
- The drafts for amending the Firearms Ordinance to correspond with the timely requirements have been prepared and forwarded to the Department of Legal Draftsman.
- Matters of revising the charges under the Explosives Ordinance which had not been amended for the past 15 years to correspond with the current economic conditions through new Gazettes were concluded and the revised charges were implemented from 01.10.2016 through which there will be a minimum increase of 300 percent in the annual revenue yielded in the field of explosives.
- A Programme has been launched in collaboration with the Centre for Research and Development (CRD) to computerize the process of issuing firearms licence and explosives licences. These computer programmes will be implemented from 2017.
- A scheme of promotion for officers of the Department of Civil Security has been prepared and submitted to the Salaries and Cadre Commission.

9. INTERNATIONAL RELATIONS SECTION

9.1 Overview

The International Relations Section of the Defence Ministry functions directly under the supervision of the Secretary of the Ministry of Defence, and is tasked with handling all substantive aspects of the foreign relations of the Defence Secretary. The section also supports the foreign relations work of the State Ministry of Defence. The Section is headed by a senior career officer of the Sri Lanka Foreign Service at the rank of Senior Asst. Secretary.

The International Relations Section of the Ministry provides defence policy positions on issues related to national security which have an international dimension in consultations with the Secretary of Defence.

The International Relations Section engages in the following activities on a regular basis:

Coordinate the substantive aspects of inward and outward visits from foreign countries related to Handle all communications of the Secretary of Defence with foreign dignitaries; Coordinate with the Ministry of Foreign Affairs and provide defence input as required; Prepare briefing material/talking points/ speehes/ programmes for foreign visits undertaken by the Secretary of Defence and follow up on decisions arrived at during such visits; Prepare defence input for foreign visits being undertaken by H E the President, Minister of Foreign Affairs and the State Minister of Defence; Coordinate work related to defence agreements/MoUs with foreign countries ;Provide defence input for the UN General Assembly (UNGA) Sessions; Coordinate responses to defence related issues raised in the UN Human Rights Council; Coordinate Defence Ministry's interactions with the United Nations Office of Drugs and Crime (UNODC) and the Office of the United Nations High Commissioner for Refugees (UNHCR); Assist the Office of the Chief of

National Intelligence on Counter Terrorism work (UN Security Council Regulations 1267, 1373, 1540 etc) and coordinate interactions with the UN Counter Terrorism Executive Directorate: Streamline bilateral defence cooperation of the Ministry of Defence; Coordinate defence related matters with regional organisations such as BIMSTEC, SAARC, Shangri-La Dialogue, ASEAN Regional Forum (ARF), Bali Process etc.; Coordinate the work of the annual defence dialogues with China and India; Coordinate the work of the

Trilateral Maritime Security Cooperation Arrangement between India, Sri Lanka and the Maldives ;Coordinate the work of the Australia-Sri Lanka Joint Working Group on People Smuggling and Other Transnational Crime; Prepare policy positions on international conventions related to arms trade and disarmament; Prepare defence input for international treaties and conventions (For Ex. the International Convention on Civil and Political Rights (ICCPR); Coordinate response from the defence establishment on concerns raised by UN Special Procedure Mandate Holders; Prepare cabinet observations on foreign policy matters which have defence implications; Prepare Cabinet papers and Notes to Cabinet on Defence matters which have an international dimension: Assist the work of the Office of the Chief of National Intelligence on compiling responses to the UN Working Group on Enforced and Involuntary Disappearances (UN WGEID) and the UN Working Group on Arbitrary Detention (UN WGAD) among others; Assist with requests from Lanka Logistics and Technologies Ltd (LLTL) on their work with foreign governments; & Provide policy input to the Policy Planning Division of the Ministry of Defence on the external security environment and bilateral, regional and global strategic developments of interest.

9.2 Achievements in 2016

US-Sri Lanka Partnership Dialogue (PD)-26th February 2016, Washington D.C., USA

The International Relations section of the Ministry coordinated the participation of Eng. Karunasena Hettiarachchi at the inaugural US-Sri Lanka Partnership Dialogue (PD) which was held on 26th February 2016 in Washington D.C., USA. The Partnership Dialogue demonstrates the consolidation of cooperation between the United States and Sri Lanka and serves to further strengthen and enhance bilateral relations in the widest sense, through regular and structured engagement.

Both countries agreed to strengthen Maritime Security Cooperation efforts in the Indian Ocean Region. The Secretary highlighted the need for capacity and capability building in this area for our Armed Forces in particular the Navy, Air Force and Coast Guard.

At the meeting, the United States welcomed the commitment by Sri Lanka to further contribute towards UN Peacekeeping Operations. The United States also pledged to continue to support Sri Lanka's demining efforts.

The delegations aim to expand export control cooperation through the Export Control and Related Border Security program in support of nonproliferation objectives. At the meeting both nations recognized the need for greater counterterrorism and intelligence cooperation and information sharing as well as capacity building in view of increasing transnational threats. Both countries also expressed commitment to continue to cooperate to counter money laundering, terrorist financing, and violent extremism. Recognizing the importance of international cooperation to promote an open and secure cyberspace, and Sri Lanka's standing as the only South Asian nation party to the Budapest Convention, the two sides agreed to explore opportunities for collaboration on cyber security and to combat cybercrime.

DEFEXPO 28-31 March 2016, Goa, India









The International Relations section of the Ministry coordinated the visit of Hon Hon. Ruwan Wijewardene, State Minister of Defence and delegation to DEFEXPO 2016 held in India from 28-31 March 2016. The Secretary to the Ministry of Defence Eng. Karunasena Hettiarachchi accompanied the State Minister during his visit. DEFEXPO India 2016 is the ninth in the series of biennial Land, Naval and Internal Homeland Security Systems Exhibition. More than two hundred foreign companies from 32 countries participated in the show along with 15 country pavilions. It provides a platform to exhibitors to display their latest technologies and products and an opportunity to explore/tap the market and business potential for mutual benefits. On the sidelines of the Exhibition, the State Minister of Defence, Defence Secretary and the Sri Lanka delegation met the Indian Minister of Defence Hon. Manohar Parrikkar and Indian Minister of State for Defence Hon. Rao Inderjit Singh in two separate Matters of bilateral importance and occasions. mutual relevance were discussed during the meetings. In addition the State Minister and Secretary of Defence also met with Minister Chang Myoung-Jin, Korean Minister of Defence Acquisition on the sidelines of DEFEXPO 2016. During the visit the State Minister and the Secretary also visited the Goa Shipyard to ascertain the progress being made on the Advanced Offshore Patrol Vessels (AOPV) being built for the Sri Lanka Navy.

15th Defence Services Asia Exhibition and Conference in Malaysia-18-21 April 2016

The International Relations section of the Ministry of Defence coordinated the participation of a delegation led by the Hon Ruwan Wijewardene, State Minister of Defence at the 15th Defence Services Asia (DSA) Exhibition and Conference in Kuala Lumpur, Malaysia from 18-21 April 2016. The State Minister held discussions with Dato' Seri Hishammuddin Tun Hussein. Minister of Defence. Malaysia during the sidelines of the event. Discussions were based on defence related matters of both countries. Chief of Defence Staff Air Chief Marshal Kolitha Gunathilaka accompanied the State Minister during his visit. Since its beginning in 1988 the DSA has become one of the world's top five defence and security exhibitions and Asia's largest. About sixty leading players in the industry from 30 countries attended the four day event this year.

Several seminars and conferences were also held in conjunction with the DSA 2016, including the Chief of Army Roundtable Talks (ChART), Putrajaya Forum, Cyber Security Forum, Humanitarian Assistance & Disaster Relief (HADR) Forum and Chemical Biological Radiological Nuclear Explosives -CBRNE forum.

15th IISS Shangri-La Dialogue: Asia Security Summit, 3-5 June 2016, Singapore

The 15th IISS Shangri-La Dialogue: Asia Security Summit the premiere defence interaction in the Asia Pacific region was held from 3-5 June 2016 in Singapore. The Dialogue has established itself as a key element in the regional security architecture and brings together Defence Ministers, Chiefs of Defence Staff, Permanent Heads of Defence Ministries, Intelligence chiefs, policy makers, academics and representatives of think tanks from the region and across the globe. The Keynote address was made by General (Retd.) Prayut Chano-cha, Prime Minister of Thailand, who spoke of guidelines for regional cooperation and the need for a new equilibrium that supports each other and leaves no one behind. Speaking at the Opening Plenary on "Meeting Asia's Complex Security Challenges" Dr Ashton Carter, US Secretary of State for Defence said that the US believes that the Asia Pacific region would "Rise, Prosper and Win"

through the establishment of a "Principled Security Network". A central point of discussion at the Dialogue was the South China Sea issue with many delegations reiterating the need to find mutually acceptable solutions.

Eng. Karunasena Hettiarachchi, Secretary/Ministry of Defence led the Sri Lanka delegation to the Dialogue. On the sidelines of the Dialogue the Secretary met with Hon Hariit Singh Saijan. Minister of National Defence of Canada, the Rt. Hon. Michael Fallon, Secretary of State for Defence of the UK, H E Anatoly Antonov, the Deputy Minister of Defence of Russia, Mr Chan Yeng Kit, Permanent Secretary of Defence of Singapore, and Admiral John M Richardson, Chief of Naval Operations of the USA. The bilateral discussions centred on strengthening defence cooperation with the countries concerned with particular emphasis on maritime security, defence and intelligence exchanges, defence procurement, training and capacity building assistance, participation in defence fora. The Secretary briefed those he met on the significant steps taken since January 2015 to release lands in the North and East and ease security restrictions.

The Chief of Defence Staff Air Chief Marshall K A Gunatilleke also met with his counterparts Air Vice Marshall Mark Binskin, Chief of Defence Force of Australia and Major General Perry Lim Cheng Yeow, Chief of Defence Force of Singapore on the sidelines of the Dialogue and discussed issues of mutual interest.

H E Nimal Weeraratne, High Commissioner of Sri Lanka for Singapore, Air Chief Marshal K A Gunetilleke, Chief of Defence Staff, Rear Admiral S S Ranasinghe, Chief of Staff/Navy, Major General B A Perera, Director General General Staff/Army, Air Vice Marshal D L S Dias, Director, Logistics/Air Force and Ms Sashikala Premawardhane, Senior Asst. Secretary (Foreign Affairs), Ministry of Defence accompanied the Secretary to the Dialogue as a part of the Sri Lanka delegation.

Launching of SLNS Sayurala, 10th June 2016, Goa, India

Secretary to the Ministry of Defence Eng. Karunasena Hettiarachchi graced the launching ceremony of the Sri Lanka Navy Ship (SLNS) Sayurala at the Goa Shipyards Ltd in India on 10th June 2016. As per naval tradition, Chairperson of the Seva Vanitha Unit of the Ministry of Defence (MoD SVU) Mrs. Wasantha Gunawardena ceremonially launched the SLNS Sayurala. Commander of the Navy Vice Admiral Ravindra Wijegunaratne was also present at the occasion. Advanced Offshore Patrol Vessel (AOPV) SLNS Sayurala will incur nearly 74 million USD when finished. The AOPV also contains a helipad and has a displacement capacity of 2350tons. The vessel has an endurance of 4500 nautical miles for surveillance operations and can accommodate up to 18 officers and 100 sailors on board. It is 105m in length and 13.6m in width.

Joint Secretary Aeronautical and Defence Production Ministry of Defence India, Shri Sanjay Prasad, High Commissioner of Sri Lanka in India, His Excellency Esala Weerakoon and Mrs Weerakoon, Flag Officer Naval Aviation and Flag Officer Commanding Goa Area, Rear Admiral and Mrs. Puneet Kumar Bahl, former Commanders of the Indian Navy, Admiral (Retd) Arun Prakash and Admiral (Retd) Sureesh Mehta, President and Managing Director of Goa Shipyards Ltd. Rear Admiral and Mrs. Shekhar Mital, dignitaries and special invitees of the Indian government, senior officers of Indian and Sri Lanka Navies also attended the event.

Seminar on Sustaining Peace in Sri Lanka: "A reflection on the challenges of upholding peace and the role of the Military", 9-10 June 2016, Defence Services Command and Staff College, Makola South

Following recommendations made by the Ministry of Foreign Affairs, the International Relations Section of the Ministry of Defence together with the Defence Service Command and Staff College (DSCSC), Ministry of Foreign Affairs, UN Department of Political Affairs in New York and the UN Office in Colombo organized a seminar on the above theme. The purpose of the Seminar was to share experiences of experts from the militaries of other nations which have gone through a period of conflict and transitioned to peace with senior Sri Lankan military officials.

The UN team was led by Mr Pablo de Grieff, Special Rapporteur on Truth, Justice, Reparations and Guarantees of Non-recurrence and included r Andreas Mathes, Germany Institute Germany), Mr Philip Barnabas Afako, UK Member of the Standby Team of Senior Mediation Advisors of the Department of Political Affairs (DPA) of the UN (Facilitator), Mr Brenden McAllister, UK- Member of the Standby Team of Senior Mediation Advisors of the Department of Political Affairs (DPA) of the UN (Facilitator), Mr Binoj Basnyat, Nepal (Ex-military), Mr Javier Martin Urbina Paredes/Chile (Ex-military), Mr Alexander Mayer-Rieckh/Austria (Exmilitary), and Ms Ellen Alradi, Department of Political Affairs, New York.

3rd Meeting of the Sri Lanka-Australia Joint Working Group (JWG) on People Smuggling and Other Transnational Crime- 14th June 2016

The Sri Lanka- Australia Joint Working Group (JWG) on People Smuggling and Other Transnational Crime met on the 14th of June 2016 at the Ministry of Defence. This is the 3rd occasion that the Joint Working Group was convened. Launched in 2012, by the then Foreign Ministers of Sri Lanka and Australia it opened a new chapter in cooperation between the two countries enabling a structured dialogue focused on combating people smuggling and other transnational crime.

In his Opening Remarks Eng. Karunasena Hettiarachchi, Secretary/Ministry of Defence said that continued information and intelligence sharing and coordinated efforts enabled Sri Lankan authorities to successfully disrupt many people smuggling ventures directed towards Australia. He added that the political commitment that underpins the cooperation under the JWG remains strong. Speaking on the broader context of engagement between the two countries His Excellency Bryce Hutchesson, Australian High Commissioner to Sri Lanka referred to the rich people to people relationships between the two nations and the robust investment and trade ties that exist. The High Commissioner also made reference to several discussions held with the Defence Secretary on taking forward the Defence and Strategic relationship between the two countries.

Ms Rachel Noble, Deputy Secretary (Policy), Department of Immigration and Border Protection of Australia and Mr S Hettiarachchi, Addl. Secretary (Defence)/Ministry of Defence Co-Chaired the JWG Meeting. The Deputy Secretary said that Australia remained incredibly grateful to Sri Lanka, for the exceptional cooperation extended in combating people smuggling over the years, as one of Australia's strongest partners. She added that given the linkages between people smuggling ventures, organized crime and terrorism the two countries cannot afford to be complacent but must continue to keep alert.

The range of issues discussed at the Meeting included Counter-people smuggling cooperation including in areas such as Intelligence, Policy, Detection, Disruption and Returns, Strategic communications (public awareness), and the proposed expedited mechanism for removals from Australia; other Maritime Cooperation including combatting transnational crime at sea (including piracy), Search and Rescue and Safety of life at sea: Legal Cooperation in areas such as investigation and prosecution of people smugglers and strengthening and harmonizing anti-people smuggling legislation; Bali Process and Regional Cooperation including progress on the Colombo RILON process (Regional Immigration Liaison Officer Network), and Immigration and Border Management issues such as Border Management capacity building and opportunities for future cooperation. Discussions were also held on a proposed MoU in the field of People Smuggling and Other Transnational Crime.

The two sides acknowledged the extensive progress that has been made under the JWG and agreed to continue to strengthen cooperation in the future.

7th Xiangshan Forum, Beijing, China 11-12 October 2016

The Secretary/ Ministry of Defence Eng. Karunasena Hettiarachchi attended the 7th Xiangshan Forum in Beijing and delivered a speech at the second plenary session of the Conference on "The Role of Militaries in Global Governance".

The Xiangshan Forum , initiated by the China Association for Military Science (CAMS) in 2006 is a track 1.5 high-end dialogue platform on Asian

Security and defense issues. The theme for this year was 'Build a New Type of International Security Relations through Dialogue Cooperation' and the four topics for discussion at the plenary sessions were 'Role of Militaries in Global Governance', 'Responding to New Security Challenges in the Asia-Pacific through Cooperation', 'Maritime Security Cooperation' and 'International Terrorist Threats and Countermeasures'. This defence conclave is sponsored by Chinese Academy of Military Science and the China Institute for International Strategic Studies.

The Secretary paid a courtesy call on General Chang Wanquan, State Councilor and Minister of National Defense of the People's Republic of China on the sidelines of the Forum. The Secretary on behalf of the President and Minister of Defense of Sri Lanka extended an invitation to the Minister to undertake an early visit to Sri Lanka to strengthen cooperation in the defense sector.



Official Visit of the Secretary/Ministry of Defence and the 2nd China-Sri Lanka Defence Cooperation Dialogue 12-15 October 2016

The Secretary to the Ministry of Defence Eng. Karunasena Hettiarachchi undertook an Official Visit to China at the invitation of the Chinese Government. During the visit the Secretary and

During the visit the Secretary co-chaired the 2nd China - Sri Lanka Defence Cooperation Dialogue (held on 13th October 2016) together with Admiral Sun Jianguo, Deputy Chief of Joint Staff Department of China's Central Military Commission (CMC.

The entire gamut of defence cooperation between the two countries was reviewed at the meeting. The two sides reviewed the entire gamut of defense cooperation including high level exchanges, military assistance, training opportunities, collaboration between defense think tanks. intelligence cooperation, joint military exercises and participation in defense seminars, workshops and symposia. The delegations highlighted defense as an important pillar of cooperation in the overall bilateral relationship and agreed to continue to strengthen ties in this sphere.

During the meeting two agreements were entered into for the provision of an Offshore Patrol Vessel (modified from a Frigate) and provision of gratis military assistance to the value of RMB Yuan 120 million

Fourth Annual Sri Lanka-India Defence Dialogue, 3rd November 2016



The Fourth Annual Defence Dialogue (ADD) between Sri Lanka and India was held in Colombo on 3rd November 2016 at the Ministry of Defence. Shri G Mohan Kumar, Defence Secretary led the Indian delegation and Eng. Karunasena Hettiarachchi, Defence Secretary led the Sri Lanka delegation to the Meeting. The Defence Dialogue process was inaugurated in 2012 with a view to reviewing the entire gamut of Defence and Security

cooperation between the two countries on an annual basis.

Defence Secretary/Sri Lanka said that defence and security form a vital and integral part of the overall bilateral cooperation between Sri Lanka and India and highlighted the importance strategic cooperation in the Indian Ocean through the advancement of cooperative security. He emphasized the importance of the work undertaken within the Defence Dialogue mechanism in that context.

The Indian Defence Secretary referred to the unique relationship shared by India and Sri Lanka underpinned by shared historical, cultural, ethnic and civilizations ties and extensive people to people interactions. He said that the strategic and security interests and concerns of the two countries were closely interlinked and the common nature of security concerns formed the basis for continued cooperation in order to build stronger bilateral relations.

Extensive discussions were held in the areas of Training and Capacity Building; Strategic Discussion between the Armed Forces; Military to Military Cooperation; Maritime Domain Awareness; Maritime Surveillance along the IMBL; Defence Equipment; Defence Line of Credit, Coast Guard Cooperation and Dialogue between Strategic Communities and interactions between Defence Think Tanks.

The Indian delegation to the Dialogue included H E Y K Sinha, High Commissioner of India, Vice Admiral G Ashok Kumar Deputy Chief of Naval Staff, Indian Navy, Air Marshal R K S Bhadauria/Indian Air Force, Lt. Gen. S K Patyal/Indian Army, Mr Arindam Bagchi, Deputy High Commissioner of India, Shri Pradeep Kumar Director, Ministry of Defence and Captain Prakash Gopalan, Defence Advisor, Indian High Commission/Colombo.

- Compiling and issuing national security related news to the media.
- Identifying and neutralizing the threats related to national security through Media.
- Coordinate with respective sections of the security related matters.
- Strengthen the social relationships with the MOD, Tri Services, and other institutions under MOD.
- Maintain a newspaper archive/data base for future references.
- Coordinate with the Media in order to support and accomplish the MOD's expected goals.
- Coordinate written and verbal rebuttals, statements and releases when required.

10.2 Achievements in 2016

The MOD, MC has successfully activated 11 Press Conferences, 35 Press Releases, and 53 Media Coverage within the year.

A petty cash imprest worth of Rs.5000.00 is granted to meet with minor financial requirements and duly approved bills are produced to the MOD for reimbursing.




Chart: 10.1 Petty Cash Account-2016




Chart: 10.2 Defence Related Print Media News Summary- 2016




Chart: 10.3 National Security Related TV News Summary - 2016




Chart: 10.4 National Security Related Radio News Summary - 2016




Chart: 10.5 National Security Related Web News Summary -2016




Chart: 10.6 National Security Related Crime News Summary-2016

10.3 Issues and Challenges

- Media publicity and public relations are the most important at present. MOD Media Centre itself has identified several issues and challenges when achieving its goals. Media Centre could improve CIMIC and cater to present national interest. This enables the defence related institutions to obtain public support and adopt good governance policies.
- The MC runs on a limited scope of media related work compared with outside organizations and new opportunities are required to be explored in order to media related modern technology to get and pass news immediately.
- Sinhala and English Media personnel within the organization will benefit the organization for accurate analysis of defence related news published by media. The MC has only a Tamil media journalist at present.
- Unavailability of media related technicians/journalists and other essential media equipment such as video cameras and recorders within the institute.
- The critical and vital apparatus of Media and public relations is the cooperation with other organizations. Therefore, tailor-made training programs are required for the staff at the Media Centre to raise the professionalism.

10.4 Future Prospects

- ► Training the human resources at the Media Centre in required fields in coordination with National Media Training Institute.
- Publishing of news and issue of press releases in a speedy way in order to eradicate misconceptions and false propaganda against armed forces and national security.
- Coordination process should be developed with all print, electronic and web based media institutions though an effective and efficient media campaign.
- Training the human resources in media related activities for Tri-forces. Police, STF and CSD.
- Prepare a fully equipped task force to publish news and issue of press releases in a speedy way in order to eradicate misconceptions and false propaganda in emergency situations. (with necessary transport facilities)
- ▶ Giving a proper language Training course for the human resources at the Media Centre in coordination with National Languages Department.
- ▶ To publish a monthly/ ones in three month magazine on the activities of Tri-forces, Police STF CSD and Coast Guard Department.
- Obtaining necessary equipment to neutralize any cyber-attacks on national security related information sources.

11. MILITARY LIAISON OFFICE

11.1 Overview

The main role of this division is communicating notifications, decisions and orders issued by His Excellency the President as the Minister of Defence and Secretary of the Ministry of Defence through coordination between the Tri Services and other institutions for the purpose of affirming mutual understanding and active operation.

Implementation and supervision of policy decisions issued by the Government and the Ministry of Defence and execution of approved tasks and programmes without exceeding the allocated amount of resources.

11.1.1 Responsibilities

- Providing assistance in State functions and coordination.
- Providing assistance during visits of foreign delegates and coordination.
- Acting in cooperation with State Ministries for requirements of the Tri Services.
- Providing assistance for requirements of private/commercial institutions by utilizing the expertise and resources of the Tri Services and coordination.
- Coordinating in cooperation with diplomatic divisions, facilitating the provision of military assistance for programmes carried out by those divisions.
- Guiding Locals and Foreigners who approach military institutions and areas where touring is restricted and coordination.
- Studying subjects that could pose a threat to the national security.

11.1.2 Functions

- Coordinating the arrival of foreign delegates to the Army camps and Military groups institutions.
- Providing diplomatic clearance for ships and airplanes (for military and non-routing movements).
- Providing flight approval for military flights.

- Providing clearance for import/export/usage/transportation of air planes/airplanes spare parts, boats, OBMS/IBMS and special military equipment.
- Providing clearance for production/import/export and transportation of camouflage items and uniform material.
- Coordination of ceremonial functions related to the Tri Services and providing assistance during the arrival of foreign groups/diplomats/delegates from non-governmental organizations and foreign media and coordination.
- Conducting transactions with State Ministries regarding the requirements of the Tri Services.
- Providing assistance for requirements of private/commercial institutions, utilizing the expertise and resources of the Tri Services and coordination.
- Coordination with diplomatic divisions, facilitating provision of military assistance for diplomatic programmes and monthly meetings of defence officials.
- Providing assistance when requested by other divisions of the Minister of Defence.
- Coordinating the construction of the Sandahiru Seya at Mahamewnava Park in Anuradhapura.
- Coordinating with Sri Lanka Air Force/ Sri Lanka Navy for organizing the air/ sea movement of high - ranking government officials and State Ministers.
- Coordinating with Sri Lanka Customs for the clearance of restricted military equipment.
- Coordinating the attachment of military officers to the Ministry of Defence or to other institutions under the Ministry.
- In making arrangements for visits of foreign Heads of State, following assistance were provided after preliminary meetings held in the Ministry of Foreign Affairs and Presidential Secretariat.
- **H** Conducting the 19/21 gun salute marking ceremonial welcome.
- Coordinating the providing of ceremonial motor cycles.
- **H** Coordinating Tri-Services, CSD, Police Cultural Event Show.
- **■** Coordinating the ceremonial parade.

- **H** Making salutation arrangements for arrival and departure at the Bandaranaike International Airport.
- **±** Coordinating the ceremony of placing wreaths before the war hero monuments in the Parliamentary premises.
- **H** Attachment of a medical team during the stay of the dignitaries.
- **u** Coordinating suitable internal flights as needed for the dignitaries.
- granting permission for landing special aero planes and providing protection at the Katunayaka Sri Lanka Air Force premises.
- **±** Coordinating matters pertaining to the preliminary security check before the departure of the dignitaries flights.
- E Coordinating with the Ports Authority for obtaining the Gall Face premises for State functions.
- **H** Granting approval for Tele drama filming publicity and other photo shooting of special area in Colombo.
- **H** Granting approval for sights shooting at Gall Face premises and the lighthouse.
- Providing military expertise and labour for functions and construction matters for (The annual Buddha Rashmi programme/ programmes held for Wesak/ Poson Poya).
- **u** Coordinating the arrival of foreign military trainee groups while coordinating air movements/ meetings and other necessities.
- Issuance of security clearance certificates.
- **H** Providing assistance for commemoration ceremonies.
- **H** Administration of security arrangements at the Ministry of Defence.
- By Observation and coordination of matters pertaining to maintainance of walking paths in Colombo and Adjacent areas.
- **H** Invitation for His Excellency the President's ADC duties and social/civil functions and granting approval to service commandants for participation.
- Assisting in ceremonies by providing the Tri Services bands.
- Providing assistance in State functions and coordination.

- Preparation of invitations, arranging seating and coordination etc.
- Other tasks assigned by His Excellency the President/ the Secretary Defence.





11.2 Achievements in 2016

The construction of the Sandahiru Seya was coordinated by the Military Liaison Officer's Office and any visitor to the project site can witness the progress made during the last year and construction had been completed upto 47 feets.

Sandahiruseya Baraya Fund received Rs. 46,708,560.09 as donations during the year 2016 and Total expenditure during the same period is Rs. 30,858,649.01



Under Colombo city beautification unit, the Tri Services and the Civil Security Department have been in active operation and maintained following pathways under the supervision of this office.

In the event of official visits of the foreign VIP's and delegations, necessary measures were taken to arrange the air-movements with the Sri Lanka Air Force and fulfill the coordination matters which relevant to these visits.

Necessary actions were taken to arrange the sea movements for the VIP's as such through the coordination with the Sri Lanka Navy. Facilities were provided for the foreign delegations to visit the war effected areas through the coordination with the Sri Lanka Army. As well as similar facilities were provided for the foreign media organizations and for the persons relevant to those organizations accordance with the state requirements.

Provision by military support which required for the programmes of the foreign delegates and security Meetings with Defence Attaches, which conducted once in every two months throughout the year, were properly organized by the Military Liaison Office. Coordination maters were carried out together with the Sri Lanka Customs to obtain the custom clearance for the restricted items, which required to the Tri Forces. Accordingly, dangerous goods and imported uniforms were cleared from the customs and also coordinated the import of special military items, spares for aircraft & OBMS/ IBMS for boats with relevant agencies.

Provided approval to import, manufacture and transport of camouflage materials for the BOI approved companies and industries, as well as on requests made by the Ministry of Industry and commerce.

In addition to the above achievements following were achieved during the year.

- Provided the necessary support for the Independence Day celebrations held on 04.02.2016.
- Provided the assistance of the Civil Security Department and the Tri Forces for the construction of the Sandahiru Seya and conducted religious offerings relevant to construction of Stupha.
- Provide the assistance to the "Sanhidiyawe Piyasatahan" a cultural celebration which was held instead of the victory parade.
- provide the assistance of the Tri services for more than 100 of religious places and schools by covering the whole Island.
- Required security assistance provided with the coordination of Embassies and High Commission of relevant countries. This has enhanced the security bonding prevailed with other countries.

- Diplomatic clearance were provided for 149 foreign Air Force aircraft within the year 2016.
- Controlling & Monitoring of importation of services, materials and equipment which poses threats to National Security. This controlling and prevention procedure had been carried out from time to time as required.
- Necessary actions were taken to supervise the non-routine movements of vessels and aircrafts

- within the Sri Lankan sea and air limits. As well as the approval was granted to the flights with accordance to the nature of the request and the requirement. Approvals were given to the mapping and photography purposes.
- Provide assistance to the coordinate and organize conferences which were held at the Ministry of Defence in 2016 with the participation of the officers of other Institutions which are coming under the purview of the Ministry of Defence.
- Within the year 2016, provide the necessary assistance to fulfill the requirements of the Tri Forces, in the case of necessary coordination of external Institutions and other State Institutions are required.
- Coordinate the requests forwarded by the foreign diplomats and delegations in order to visit the Army Headquarters through-out the year.
- Administration matters of the officers of the Tri Forces who were attached to other state Institutions, appointments of these officers were carried out without affecting the duties of them.
- Within the year, approval to hold the various festivals in Galle Face premises were granted through the coordination with the Port Authority.
- Organized the annual trip of the other ranks of the MLO Office in Nuwara Eliya.

11.3 Future expectations

The assistance provided to the security matters coming under the purviews of the Military Liaison Officer's Office and for the endeavors of the present government should be maintained in parallel to a maximum level. Further it is necessary to coordinate the special projects and endeavors which are assigned to the Military Liaison Officer's Office based on the national requirement. Therefore it is necessary to maintain the active contribution towards the aforementioned great endeavors based on an unfeigned professional structure. Furthermore construction matters of the Sandahiru Seya should be continued with the assistance of the Tri Forces, Civil Security Forces and the general public.



12. OFFICE OF THE CHIEF OF DEFENCE STAFF (OCDS)

12.1 Overview

The origins of the Office of the Chief of Defence Staff could be traced back to the Joint Operations Command (JOC) established in 1985 to coordinate all operational aspects of the Tri-Services and Police. Thereafter the Joint Operations Bureau was created on 04 January 1999 replacing the Joint Operations Command and the Joint Operations Headquarters (JOH) replaced the Joint Operations Bureau in year 2000, which existed only for a short period. With the termination of the Humanitarian Operation, the duties of the Joint Operation Headquarters was expanded by the Chief of Defence Staff Act No. 35 of 2009, thereby the Office of the Chief of Defence Staff was established to address the post conflict challenges on 15 July 2009.

The Chief of the Defence Staff (CDS) is the highest ranking military officer in the Sri Lankan Armed Forces and His Excellency the President shall appoint from among the persons presently serving as Commander of the Army, the Commander of the Navy or the Commander of the Air Force as the case may be, an officer to be the Chief of Defence Staff to function under the direction, supervision and control of the Secretary to the Ministry of Defence.


The mission of the OCDS is to provide strategic directions and develop joint doctrine for the Armed Forces in Sri Lanka.

12.1.1 Responsibilities

- Assist in providing strategic directions and developing doctrines for joint employment.
- Coordinate matters in respect of the functions related to Intelligence, Planning and Implementation of Joint Operations.
- Advise on the extent to which the Programmes, Recommendations and budget proposals of the Armed Forces for a fiscal year conforms to the priorities.
- Advise on the extent to which the major programmes and policies of the Armed Forces related to manpower and equipment conforms to strategic plans.

- Formulation of policies for the joint training and peace-keeping operations.
- Assess military requirements with regards the proposed defence procurements.

The OCDS is segregated into 4 main branches along with an administrative branch for internal administration. Apart from that the CDS Secretariat Branch is the coordinating hub of the CDS. The under mentioned diagram shows the organization of the OCDS.

All expenses were made by the GCSP and an MOU was signed to continue similar programmes in future.







12.2.2.Operations and System Branch





PERFORMANCE OF INSTITUTIONS

13. DEPARTMENT OF COAST GUARD

13.1 Overview

Sri Lanka Coast Guard (SLCG) was established after enacting the Coast Guard Act. No 41 of 2009 by the parliament on 09th July 2009 to ensure the security, safety and serenity of the maritime environment. The Sri Lanka Coast Guard being the law enforcement agency at sea has been empowered with legal authority to search and arrest ships, craft and personnel engaged in illegal activities in all maritime zones of Sri Lanka and in High seas in order to constitute legal proceedings against the offenders. Every officer of the Department of Coast Guard shall deem to be a peace officer within the meaning for the purposes of the Code of Criminal Procedure Act No. 15 of 1979.

13.2 Achievements in 2016

13.2.1 Logistic Department

Recurrent and capital expenditures are attached herewith as annex "A".

13.2.2 Personnel and Administration Department

The progress of Personnel and Administration Directorate is attached herewith as annex "B" and land deployment which depicts Coast Guard bases, stations and life saving points is attached herewith as annex "C" to this report.

13.2.3 Operations Department

13.2.3.1 Life Saving Operations

- At the beginning of year 2016, SLCG had eleven Life Saving Points around the coast. Further, establishment of two new Life Saving Points at Unawatuna and Moragolla on 24th June 2016 and 29th July 2016 respectfully with the financial assistance of Marine Environment
- Protection Authority (MEPA), SLCG life saving deployment have enhanced up to 13 Life Saving points. All those life saving points are manned by professionally qualified SLCG life savers throughout the year.

■ It is worth mentioning that, 250 lives including 132 foreigners have been rescued by SLCG life guards. Details of the life rescues and Statistical analysis of the aforesaid life rescues carried out by the SLCG during the year 2016 is attached herewith as Annex 'D' to this report.

13.2.3.2 Coastal Surveillance to Deny Illicit Activities.

SLCG fleet units consist of 10 No's Fast Patrol Craft (FPC) and 10 No's Inshore Patrol Craft (IPC), are being utilized to deny illicit activities in territorial waters around the country. All Fast Patrol Craft (FPC) and 03 numbers of Inshore Patrol Craft (IPC) have been deployed in Northern waters and remaining IPC have been deployed at selected fishery harbours in western and southern regions. In addition to aforesaid tasks, some of the IPC have performed life guard duties and whale watching monitoring duties at the coastal area of Mirissa. Detailed description of the SLCG Fleet unit deployment is attached herewith as annex 'E' to this report.

13.2.3.3 Monitoring of Illegal, Unregulated and Unreported (IUU) fishing.

SLCG fishing monitoring units established in following fishery harbours were dedicated to support the National Plan of Action to deter IUU fishing by checking all the fishing vessels venturing for high sea fishing. Checking of vessels conduct before the departure to ensure the legality of fishing gears and equipment on board, and also on arrival to the harbours for any illegal catch.

13.2.3.5 Search and Rescue Operations

Assistances were rendered to Sri Lanka Navy and Sri Lanka Police to carryout search and rescue operations in coastal area using available resources.

13.2.3.6 Law Enforcement Operations

Law enforcement operations have been carried out in territorial waters and rendered necessary assistances to other national law enforcement agencies and government authorities to perform their respective duties. Eg; Department of Police, Department of Fisheries, and Department of Wild Life Conservation. SLCG Fleet units executed many repatriation operations in collaboration with Sri Lanka Navy and Indian Coast guard. Details of the repatriated fishermen during last year are as follows:




Chart:13.1 Search and Rescue Operations

13.2.3.10 Interaction with Foreign Delegations

Positive interactions have been made by the SLCG with foreign delegations from leading Coast Guards and Maritime Agencies around the world; such as Australian Boarder Protection Service, Indian Coast Guard, Japanese Coast Guard and US Coast Guard. It is worth mentioning that these interactions have paved the way to enhance regional as well as global maritime co-operations in many ways whilst enhancing the operational capabilities and capacities of SLCG in a progressive manner.

- Japanese Coast Guard assisted in establishing of a fully fledged, well qualified SLCG Strike Team (Oil Spill Response team) to mitigate any oil spill in Sri Lankan waters. Likewise, other Coast Guards have indicated their willingness to support SLCG in the same fashion.
- An official visit was paid by the Vice Admiral Hiroyuki Nakano, the Deputy Director General (Guard and Rescue) of the Japanese Coast Guard to Sri Lanka on 26th January 2016.
- The Director General of Indian Coast Guard, Director General Rajendra Singh visited the Sri Lanka on an official visit from 16th to 20th

August 2016. During his visit, The Director General of Indian Coast Guard (DGICG) ceremonially opened the Operations Room and Utility complex of Sri Lanka Coast Guard Headquarters on 17th August and indicated his willingness to provide necessary equipment to the operation room as a grant.

- The Commanding Officer, Deputy Inspector General Anand Prakash Badola of the Indian Coast Guard Ship "ICGS SAMARTH" visited Sri Lanka Coast Guard on 18th August 2016 and discussed the issues of mutual interest and the bilateral importance.

- Many training programmes on Coast Guard related subjects were conducted by the Sri Lanka Coast Guard in order to build up the skills, technical knowledge and the professionalism of the coast guard personnel. Moreover, considerable number of Officers and Coast Guardsmen has been undergone series of foreign training courses offered by many foreign countries.
- Life Saving courses have been conducted for sister services and civilian community to improve the awareness on life saving techniques.
- Further, foreign law enforcement agencies have conducted regional training programmes at ATC Mirissa in collaboration with SLCG instructors for maritime law enforcement officials in the region.




Chart: 13.2 Financial Progress – Recurrent Expenditure





Chart: 13.3 Financial Progress – Captal Expenditure




Chart: 13.4 No Of Personnel Rescued By Locations





Chart: 13.5 No of rescued by month

14. GENERAL SIR JOHN KOTELAWALA DEFENCE UNIVERSITY

14.1 Overview

General Sir John Kotelawala Defence University (KDU) was established under the Sir John Kotelawala Defence Academy Act No. 68 of 1981 and its scope of operation has been enhanced by several subsequent amendments. The Academy was elevated to University status by the (Amendment) Act. No. 27 of 1988 and renamed as General Sir John Kotelawala Defence University in terms of the (Amendment) Act No. 50 of 2007. Degrees awarded by the University are recognized by the University Grants Commission (UGC) Sri Lanka and KDU is also a member of the Commonwealth Association of Universities (United Kingdom) and the International Association of Universities (IAU).

The University is a state university that operates as an independent institution governed by a Board of Management under the Ministry of Defence, and it provides higher educational opportunities for triservice personnel, deserving youths in the country, foreign students and private and public sector personnel in respective subject disciplines at bachelor's and post-graduate levels.

14.2 Achievements in 2016

14.2.1 Financial progress




Chart 14.1 Budgetary Allocations

Further, the construction of the University Hospital was commenced in 2013. A Term Loan facility of USD 201.629 Million was granted by the National Savings Bank for the construction of the Hospital and for the medical equipment cost.

Construction activities of the Southern Campus commenced in early 2014 for the establishment of the Faculty of Built Environment and Spatial Sciences and the Faculty of Computing. The first phase of the project was estimated to be LKR 1,000 million and a total of LKR 600 million was granted from the Special Development Initiatives Fund in 2014 to commence the construction. Further, LKR 250 million was granted in 2015 by the Telecommunications Regulatory Commission.

14.2.2 Physical Progress of Main Capital Projects

There are four projects which can be identified as main capital projects undertaken by KDU. They are:

- **±** Construction of Medical Faculty Building.
- **u** Construction of Engineering Faculty Building.
- **u** Construction of University Hospital.
- **E** Establishment of Southern Campus at Suriyawewa.

14.2.2.1 Construction of Medical Faculty Building

The project commenced in year 2010 and a total estimated cost was LKR 1,477 million for the project. The first and the second phases of the project were completed in 2012 and 2013. The third phase of the Medical Faculty Building Complex is the construction of a well-equipped modern auditorium for the University. It is expected to complete the auditorium and the infrastructure development of the Medical Faculty Building Complex soon. However, limitation of budgetary allocation has led to the extension of the project completion period up to 2017.

A total of LKR 948.5 million was spent as at 31.12.2015 for the construction work. The percentage of physical progress of the construction as at 31.12.2015 was 65 percent.

14.2.2.2 Construction of Engineering Faculty Building

The construction of a new building for the Faculty of Engineering at a cost of LKR 500 million was commenced in 2013 and budgetary allocations have been granted annually for the construction. The Phase I of the building was completed on March 2015, and the construction work in the Phase II was continuing in 2016 and will be carried in to 2017 due to the limitation of Budgetary allocations. The new building complex accomplishes and contributes to ergonomics, economy, energy, environmental sustainability and enhancement of the Faculty Engineering to accommodate the increase in student strength in the future.

A total of LKR 252 million was disbursed as at 31.12.2015 for the construction work.

14.2.2.3 Construction of University Hospital



The University has already commenced the construction of the University Hospital to facilitate clinical teaching of the Faculty of Medicine at Werahera, Piliyandala at a cost of US\$ 201.629 million. This fully-equipped teaching hospital with

704 beds, 50 VIP rooms and five professorial units will commence its operations by August 2017.

Term loan facility of USD 201.629 million was granted by the National Savings Bank (NSB) to complete the construction of the Hospital and provide medical and other equipment to the Hospital. Servicing of the loan facility, i.e. repayment of Loan Interest and Capital installments are paid by the Treasury.

The construction of the University Hospital is rapidly progressing and it is done by a foreign contractor. The total cumulative cost of the project is US\$ 162 million.

By end of the year 2015, NSB disbursed a total of US\$ 128.3 million for the construction work and a total of US\$ 95 million was released to the contractor.

More than 58 percent of the construction work was completed by end of 2015 and the hospital will be functioning by May 2017.

14.2.2.4 Establishment of Southern Campus at Suriyawewa

Establishment of the Southern Campus was done by KDU with the contribution of the Sri Lanka Navy for construction work and the Sri Lanka Army for the construction of Road Network. By end of 2015, construction work of Phase I was completed (more than 90 percent). The academic activities of the Faculty of Build Environment and Spatial Sciences and Faculty of Computing were commenced in February 2015 having the ceremonial opening of the campus by His Excellency the President on 05th of May 2015.

14.2.3 Physical Progress of Main Capital Projects funded by Self-Generated Income

Before the year 2012, all capital projects were financed by the Government. Annual budgetary allocations were granted for all capital projects. The management of the university decided to open doors to day scholars including foreign students to obtain their higher educational qualifications from KDU, and since then the self-generated income has been increasing gradually. Accordingly, the self-generated funds are utilized to finance capital projects from 2012. Following projects were financed with the Self-Generated income.

- Six storied building complex for Sergeants and Petty Officers Mess and Accommodations worth of LKR 85 million.
- More than LKR 28 million was spent for three storied building for the Bank Branch and Accommodations.
- Construction of Building Complex for Faculty of Graduate Studies.
- Enhance Accommodation Facilities for Students and 20 Apartment Block for Staff.



KDU intends to construct a six-storied building with 20 apartments to provide accommodation for the academic staff members and a six-storied accommodation building complex for students who need that facility. This project was initiated in 2014.

A Term Loan facility of LKR 460 million by Sampath Bank Plc. Ltd. was agreed to be granted. The service of the loan is done with self-generated funds over a period of 15 years, and it is planned to be repaid from the self-generated funds.

All the proceedings for the project including the approval of the Cabinet of Ministers and the loan facility were finalized. Meanwhile, the piling works of the construction was already completed and the construction work of the Student Accommodation Buildings is in progress and it has been undertaken by reputed construction contractors. The procurement procedure is being finalized for the construction work of the Apartments.

- Competition to absorb and recruit the best academia.
- Negative perceptions and propaganda about KDU by competitors in higher education and anti-military organizations.
- Some civil students' reluctance to learn under disciplined environment.

16. CENTER FOR RESEARCH AND DEVELOPMENT

16.1 Overview

The objective of the Centre for Research and Development(CRD) is to design, develop and lead to production of indigenous solution for defence applications by establishing a world class science and technology base and equip for the defence forces as well as other government institutions with internationally competitive system and solutions.

16.1.1.Functions

- Acquire and design the best systems, based on the best practices and available resources in the defence sector.
- Design the necessary interfaces to integrate IT and Non-IT based systems operationally in the defence sector.
- Developing a full-fledged R & D organization to emulate and evaluate its effectiveness and suitability.
- Implementing a full-fledged R & D organization for the defence sector in Sri Lanka.

16.2 Achievements in 2016

16.2.1 Financial and Physical Progress

CRD at its initiation was located at the Regimental Headquarters Sri Lanka Signal Corps in Army Cantonment Panagoda and subsequently shifted to KotalawalaDefence University Premises. Afterwards CRD was shifted to a rented out office space at the BMICH Colombo 07 before being shifted to its own complex at Moragahena Road, Pitipana in 2015. Subsequently a two storey building was constructed to facilitate administrative functions and Other Rank accommodations. Under the third stage constructed another two storey building to provide accommodation for the Officers attached to CRD and the new building declared the open by the Secretary Ministry of Defence on 20th January 2017.



16.3 Issues and Challenges

■ CRD having required to procure items and equipments required for research projects only from registered suppliers of the MOD faced difficulties in sourcing such items and equipments due to high prices quoted, unavailability of suppliers for certain items and delays in supplying ordered items and equipments. It is therefore emphasized the need to adopt a mechanism to purchase such items from competitive suppliers in

- the open market. Items those are not available in the local market required to be imported directly and CRD faces difficulties in settling payments for such imports.
- Since the CRD is carrying out research project for three armed forces and the other government organization by using the latest technologies in large scale that the available infrastructure facilities not enough to accommodate them.

16.4 Future Prospects

- ▶ Commencement of construction of 6 storied building with modern laboratory facilities to enable the full functioning of all the wings to establish a fully-fledged research institute.
- Arrangements will be made to directly enlist specialized personnel for the CRD for better know how.
- Arrangements will be made to pay a special research allowance for research officers of the CRD

17. JOINT SERVICE LANGUAGE TRAINING INSTITUTE

The Joint Services Language Training Institute was established under the Ministry of Defence in 1986 as a training institute for the purpose of teaching Tamil for security personal, aiming of updating the knowledge to read, write and speak Tamil. ■ The institute has successfully completed three courses during the year 2016 and accommodating 395 students from Tri Services and Special Task Force.








Chart 17.1 number of officers and soldiers of Tri Servicers and Police followed by the Tamil courses in year 2016

Chart: 18.1 Revenue and related performance




Chart 18.2 Assets and Liabilities position




Chart 18.3 Ratio Analysis

19. INSTITUTE OF NATIONAL SECURITY STUDIES SRI LANKA (INSSSL)

19.1 Overview

The Institute of National Security Studies Sri Lanka (INSSSL) was established in August 2016 by His Excellency President Maithripala Sirisena, as a national security think tank under the Ministry of Defence. It was created to better understand the security environment and to work with the government to craft evidence-based policy options and strategies through debate and discussion, research and expertise with the aim of safeguarding national security. At its helm is Director General Asanga Abeyagoonasekera. Initially the institute consisted of a few temporary staff who carried out its limited functions. Following its launch on 2nd January 2017, now INSSSL has a permanent cadre of staff with two Directors, a Research Analyst, three Research Assistants and a few interns.

19.1.1 Vision

To improve policy and decision making through high quality research and analysis with excellence

19.1.2 Mission

From high quality research to continuously support the Ministry of Defence 's mission 'formulating and executing strategic plans and policies for a secure, safe and sovereign country with territorial integrity'

19.1.3 Objectives

- To provide sound and timely assessment on facets of national security to secure Sri Lanka from internal and external threats.
- To serve as a platform for government, private sector and the civil society to collaborate debate and discuss issues affecting Sri Lanka's security and stability to synergize and draw from a spectrum of thinkers and planners.
- To serve as a nucleus for deliberations and as a capacity builder for strengthening institutions on national security aspects
- To serve as a central repository of knowledge for both scholars and practitioners committed to the nation's unity and harmony

19.2 Achievements in 2016

19.2.1 Round Table Discussions INSSSL Security Salon

The INSSSL Security Salon is a closed-door roundtable event of a selected distinguished gathering held with the aim of generating a discussion on a timely and relevant topic of interest to national, regional and international security.



- The inaugural 'Security Salon' was held at the Ministry of Defence on Wednesday 5th October 2016. It created a space in Colombo to foster intellectual, diplomatic and political debate and deliberation on a specific topic by a select audience. The guest speaker on the topic "Indo-Pak Situation" was Professor Emeritus S.D. Muni, Distinguished Fellow at the Institute of Defence Studies and Analyses (IDSA), New Delhi. The first meeting of its kind in Colombo, the session was chaired by Secretary of Defence Sri Lanka Eng. Karunasena Hettiarachchi and was attended by scholars, members of the diplomatic community and armed forces.
- The Institute of Security Studies, Sri Lanka (INSSSL) held it's second 'Security Salon' on Friday, 28th October 2016 at the Ministry of Defence. The Executive Director at the Regional Centre for Strategic Studies (RCSS) delivered the guest speech on the topic, "Security in the age of Globalisation". The Secretary, Ministry of Defence, Eng. Karunasena Hettiarachchi Chaired the discussion and Director General of INSSSL, Asanga Abeyagoonesekara made the opening remarks. Dr. Ahmed spoke on a timely topic that is of much interest to all states and non-state actors in current geo-politics.

The Institute of Security Studies Sri Lanka (INSSSL) successfully concluded its third "Security Salon" on 18th November 2016 at the Ministry of Defence. The guest speaker on the occasion was Prof. Indra de Soysa, Professor of Political Science at the Norwegian Institute of Science and Technology who's presentation on "Violent Conflict: using theory to guide Sri Lanka's Defense Policy" enraptured the audience of scholars, practitioners, diplomats, and senior military officers alike as it was an extremely important and relevant topic to Sri Lanka's security landscape.

19.2.2 Publication INSSSL Defence Ouarterly

The INSSSL Defence Quarterly is a newsletter that is published once every three months with the intention of bringing together news and events that take place at the Institute. This includes events hosted by the institute, latest publications, international conferences attended by the Director General and staff, visits of international scholars to INSSSL and opinion pieces/articles. The quarterly bulletin is disseminated amongst local and international academia, think tanks and research institutes, government institutions and other interested persons.

INSSSL Defence Review 2017

"INSSSL Defence Review 2017" was published with the aim of providing a research platform on defence and security studies with a priority to enhance the understanding of national, regional, international security and geopolitics. The authors of the articles have been identified as those who could make a significant contribution with their expert views on recent events and occurrences in the national, regional and international security paradigm. Their writings focus on regional superpowers in the Indian Ocean region; the endless conflict in Afghanistan; theories of conflict and its relevance in the Sri Lankan context: security in the Gulf; India in the new world order; perspectives of security and power balance in the Taiwan strait; visions for smart air power in the region; Sino-Sri Lanka relations in the Indian Ocean; and insurgency and counter-insurgency strategies with regard to Sri Lanka. These enriching and very informative articles will be beneficial and create an interesting read for all

those with an interest in Defence and Security Studies.

19.2.3 Networks And Collaborations

Secretary to the Ministry of Defence Eng. Karunasena Hettiarachchi chaired the inaugural discussion on "Regional Security Perspectives" organised by INSSSL with the collaboration of the Consortium of South Asian Think Tanks (COSATT) at the Ministry premises on 26th August 2016. Fifteen distinguished scholars from the region participated at the discussion.

19.2.4 Official Visits

■ Director General INSSSL visited the National Institute for Defence Studies (NIDS)in Tokyo which was established in 1952. It was the first time a member of a SriLankan defence think tank has visited NIDS.Consequently, Ms Marie Yoshioka Izuyama from NIDS and Ms Arai Etsuyo from the Institute of Developing Economies paid an official visit to the institute in December 2016.



Director General INSSSL was invited for the Indian Ocean Conference 2016 at Shangri-La Hotel Singapore on 2nd September 2016. Hon. Ranil Wickremesinghe, Prime Minister of Sri Lanka delivered the inaugural address. There were many distinguished participants from the government, members of the region's top think tanks, distinguished military officers, former diplomats and scholars who participated in the conference.



- Research Fellow of INSSSL Ramla Wahab-Salman represented the institute at the international seminarian East Asian civilisations Exchange hosted by Beijing Normal University and the Nishan World Civilisations Forum in November 2016. Ramla's presentation titled "Historical Aspects to Sino-Sri Lanka Contacts through the Indian Ocean" highlighted exchanges religions, intellectual and cultural through the Silk and Spice Routes of the Sea.
- Gayathri de Zoysa, Research Analyst at INSSSL participated in the 1st National Science and Research Organisations Summit Forum on the Belt and Road Initiative, from 7-8 November 2016 in Beijing, China. Here, she tabled a paper co-authored with fellow INSSSL researcher Ganidhu Weerasinha titled "Towards Sustainable Development in Sri Lanka".
- COSATT had its planning meeting with heads of South Asian think tanks in Bangkok, Thailand on 28th November 2016. Director General of INSSSL participated. He was also invited by Horasis Asia Meeting to be part of a distinguished panel on Building Trust.
- Director General INSSSL contributed a chapter to a new book titled "The Modi Doctrine: New Paradigms in India's Foreign Policy. He attended its launch event on 13th August 2016.

19.3 Issues and Challenges

We are satisfied with the work carried out by the Institute in the short time (five months) since its inception. Immense progress has been made in its structure, activities and output.

Since its establishment in August 2016, INSSSL has been working towards achieving its objectives with limited resources, temporary staff and interns who worked on a voluntary basis. However, despite the preliminary obstacles, INSSSL was able to achieve all its intended objectives for the year 2016, having conducted several roundtable discussions, publishing an annual journal on national and regional security with contributions from security experts and a quarterly newsletter, creating a resource pool of eminent scholars and practitioners on security issues, and preparation to launch the official website in January 2017.

The institute also conducted its work with limited funding for the procurement of goods and services and implementing its work smoothly. Previously based at the Ministry of Defence, the INSSSL launched its new office on the 8th floor at 'Suhurupaya', Battaramulla on 2nd January 2017 and has since recruited research staff on a contract basis.

20. NATIONAL CADET CORPS

20.1 Overview

National Cadet Corps is an organization that train school cadets males and females and presently there are 1873 cadet platoons (46825 x cadets) actively functioning within the island covering all 9 provinces. The cadet corps officers are basically teachers whom will be mobilized for a short period and employ them for training of cadets and to perform other administrative and logistic duties in order to facilitate training.

The National Cadet Corps is organized as follows.

a. HQ NCC

Located at Pamankada and the strength is 35 x officers, 21 x other ranks and 34 x civilian staff. The main role is to liaise and obtain directions from the State Ministry of Defense on all policy matters, administrative duties and fulfill entire logistic requirements in the corps to ensure effective cadet training.

b. Rantambe Training Centre

The main Training Center to train cadets and considered the heart of the corps. There are 24 x officers, 54 x other rankers and 56 x Civilian staff.

c. 9x Provincial Headquarters

Located in 9 provinces. There are 07 x officers, 08 x other ranks and 07 x civilian staff.

d. 38 x Battalions

Located all over the island covering 9x provinces. The main objective is to organize and train cadet platoons in schools and to qualify to take part in competitions of Herman Loose and De Soysa Trophies. There are 104 x officers, 138 x other ranks and 56 x civilian staff available




Diagram 20.1:Organization of NCC




Figure 20.1:Deployment of NCC

Under this objective, a monthly allowance to war heroes to overcome economic difficulties and a special monthly financial aid for the parents of war heroes who face severe economic hardships is paid. Further, the relatives of the war heroes are directed to improve sports, arts and other skills and to engage in self employments.




Chart: 21.1 Progress of the Projects of the Authority

21.3 Future Prospects

Welfare activities for the war heroes implemented by Ranaviru Seva Authority were adjusted in line with contemporary requirements in 2015/2016. It is expected to implement the new minute and the programmes in year 2017 and Ranaviru Seva Authority will be working towards achieving below mentioned targets.

- ▶ Taking actions to widen the target group and benefits by revising Ranaviru Seva Authority Act no 54 of 1999.
- ► Taking actions to provide 4 wheel vehicles to war hero families to go in line with life styles.
- ► Completing the construction of first phase of Yakabedda Elders' Home and commencing the work of the Second Phase.
- ► Taking actions to convince and practice thrift in spending money through financial management.
- ▶ Taking actions to empower the war hero women in economic, social and cultural levels with the aim of freeing them from dependent situation.
- ▶ Making the war heroes a part of the national economy by directing them towards entrepreneurship.

22. DEFENCE SERVICES COMMAND AND STAFF COLLEGE (DSCSC)

22.1 Overview

Defence Services Command and Staff College (DSCSC) is an institution that provides military education to the middle grade officers of the Tri services. DSCSC offers the first learning experience of joint operations in a joint environment. Year 2016 had been a successful year for DSCSC in terms of academic and administrative activities. It had continued to uphold the recognition as one of the leading institution for military studies in South Asia.

DSCSC is managed by a Board of Management. It is staffed by service personnel from the Tri services and civilian staff employed by Ministry of Defence. The CEO of DSCSC is the Commandant.

Course Number 10 was conducted during the year 2016. The course commenced on 03 January 2016 and concluded on 12 December 2016.

In the year 2016, the college has introduced many creative concepts and activated ten core values and a driving tenet in relation to those core values. The core values are emphasized in all spheres of activities of the college. Upholding of the core values is aimed at improving overall character of a person and makes his service contributive to the progress of the institution. The Core Values are:

22.2 Achievements - 2016

The Action Plan prepared for 2013 – 2017 had identified 3 major capital projects on 2016. Namely:

- Two storied Facility Centre.
- High Technology War Gaming Centre.
- Information Technology Projects.

Out of above, a two storied facility centre was constructed with a cost of Rs. 17 Mn and Rs 30.8 Mn was spent over the High Tech digital war gaming centre. Rs 13 Mn. has been spent for the construction of other Information Technology projects.

The academic programme was conducted in order to achieve aim and objectives of the DSCSC. The academic programme remained same as previous years and teaching methodology has been updated.

The treasury has allocated Rs 128.5 Mn as the capital expenditure and Rs 115.4 Mn on the recurrent expenditure for the year 2016.

When comparing the capital allocation received for the current year with 2015, there is a decline of Rs 3 Mn. Since the civil vacancies were filled during the year there was a considerable increase in expenditure upon salary and allowances but the college was able to manage the situation by controlling saving water and electricity consumption. The great effort made by the college authorities resulted in better management in the capital expenditure

Rs 115.4 Mn which was allocated as capital expenditure planned to utilize by August 2016. Projects which were planned to complete, recurrent and acquisition of fixed assets was able to be gainedwithin a satisfactory management.

The estimated amount for facility complex was Rs 17 Mn and it facilitates both local, foreign students and their families. These facilities reflects the standers of college hence it enhance the attraction of local and foreign officers to follow the course.

One of the significant projects that completed during the year is High Tech war game centre worth of Rs 43.4 Mn. It is utmost important that uplifting the training standards according to par with the modern world. This project sphere headed the military training transformation in Sri Lankan Army.Other than that the enhancement of library facilities and foundation for the development of elibrary system is also considered as achievements. College also adopted the same as the new world trend to work in a paperless environment.

Repairing of the college buildings were carried out in addition to the developments mentioned above. Within the cost of Rs 38.5 Mn 17 buildings were reconstructed in a condition to use for longer time. These particular buildings were old over 50 years, various government institutions had used for their various purposes. As a result of that most of these were severely damaged and not in a condition of use. Presently these buildings are fully furnished office complexes and uses for accommodations. All the allocations for repairs received from the Treasury in the year. The possibility of using the repaired buildings for longer period is an advantage, hence funds can be utilized for new construction of buildings.

The expenditure for the purchase of the capital goods was Rs 31.9 Mn. These were utilized for

restoration of depreciates and utilized for college requirements.

It was an advantage that the completion of annual planned projects by month of August hence it paved the way to initiate the projects of following year. In this back ground college was able to acquire additional allocations worth of Rs 10 Mn from MOD. Also college plans to utilize additional allocations for further repairs of buildings.

The staff course (Course No 10) conducted during the year 2016 consisted with 126 Student Officers. That included 63 from Army, 27 from Navy, 24 from Air Force and 12 foreign student officers representing 12 countries. 99% Student officers of the course obtained the coveted title of 'passed staff college' (psc). 78% Officers were selected for the Masters' Degree programme awarded by General Sir John Kotelawala Defence University. The graduation ceremony of Course Number 10 was held on 12 December 2015.

During the period under review, Rs 38.5 Mn was spent for rehabilitation of buildings in order to maintain them in proper standard suited to the College. A building of two storied facility complex was completed at a cost of Rs17 Mn.

Skill development of the staff is done on the concept of learning organization, where every member of the staff (teaching and administration) is subjected to a learning/training program. All the members of the teaching staff of the college were included along with student officers in the Overseas Study Tour conducted annually for each course. A total of 7 countries were visited in the year 2016. Further, in order to provide better exposure for the teaching staff, a reciprocal workshop program was conducted with Defence Services Command and Staff College Bangladesh. Teaching Staff from each college visited and interacted with their counterparts to conduct workshops. Another step in the same direction was the invitation extended to foreign Staff Colleges to send teams of their teaching staff to this college to obtain insight to the course curriculum of this College. Accordingly 2 members of each of the Directing Staff were received from Defence Services Command and Staff College of Pakistan and Malaysian Armed Forces Staff College.

A team from the Indian Armed Forces also visited to conduct a Military Technology Teaching Package, furthering the same effort in the latter part of the year. Internal training for Academic Staff and Administration Staff was conducted in order to develop their skills in their profession. Training for each category of staff was conducted on a schedule at least ones in a week in the form of training sessions and lectures.

In some instances external resource personnel had delivered lecturers/conducted workshops, and in some instances staff visited outside institutions to obtain a better insight. Both civilian and military staff included in the training.

The College was able to successfully adopt strict financial control with well planned and transparent procurement plan. Foresight was demanded from all executive officers who were responsible for projects. They were demanded of continuous awareness of their allocated, spent and remaining funds. This strict control of funds allowed flexibility which enhanced the efficiency and ROI of the College.

As a whole there were no financial issues during the year 2016 and due to the lesser payment of liquid cash of Rs 5.9 million, same worth of unpaid bills had to be carry forward.

22.3 Future Prospects

- ▶ <u>Organizational</u> The College is in need of an establishment to support the students on their research activities. It is intended to open an "Academic Branch "under the Coordinating Wing which may take on the research related activities. The vacancies of the staff, mainly of uniformed staff need to be filled. A dedicated number of troops for 'training support' are required to be incorporated in to the organization. An initial financial investment is not expected in both those projects.
- **Capital** Infrastructure development takes prominence in the medium term development plan of DSCSC. As the staff course is a residential course, the students need to be provided with married quarters for the period of the course along with other utility services. The investment for this requirement for the next three years, is expected to be Rs 120 Mn. The aim is to provide married quarters for at least 40 % of student officers within 3 years. A new Library building and exam hall is also in the planned projects. Its cost is estimated for Rs 127 Mn. Another medium term activity is to strengthen the vehicle fleet of the college with new vehicles as some vehicles are becoming obsolete and required replacement.

23. DEFENCE SERVICES COLLEGE

23.1 Overview

Defence Services College was established on 17th of January 2007 at Malay Street, Colombo 02, ease the challenges currently encountered by the members of the Armed Services and the Police, pertaining to admission of their children to popular schools. DSC directly operates under the direction of the Ministry of Education and its administration control is done by the State Ministry of Defence.

Later, a cabinet approval was granted to develop the concept of Defence Services College as a special educational project and to establish Defence Services Colleges in each district while the DSC Colombo as centralized hub of the system. Accordingly, DSC Colombo and DSC Kurunegala are functioned at present.

23.1.1 Vision

To be ranked among the best educational institutions in Sri Lanka, dedicated to the children of those in the armed services and the Police by year 2020 and continue to lead.

23.1.2 Mission

To groom a child in a disciplined environment, to meet confidently and courageously the varied challenges encountered and eventually emerge as a productive and successful youth in the society by harnessing proficiency and educational skills of the academic staff of the Ministry of Education and coopting the management skills, talents, resources and facilities made available with the Ministry of Defence, Sri Lanka Army, Navy, Air Force and Police.

23.1.3 Objectives

■ To ease the challenges currently encountered by the members of the Armed Services and the Police, pertaining to admission of their children to popular schools.

- To design, develop and testing of a new governing system that will assist the Government's effort to provide a high quality and equitable education, under a disciplined environment.
- To promote current educational trends, such as computer literacy, activity based studies, language skills, aesthetic studies, reading habits, sports activities and other facilities by soliciting inputs and management skills of the Tri Services and the Police.
- To provide a high quality education with the assistance of professional and experienced & academic staff drawn from the MOE.
- To pay special emphasis on students to achieve a high proficiency in English with a view to face future challenges of the rapidly developing world, confidently.

23.1.4 Defence Services College – Colombo

DSC – Colombo was established on 17th of January 2007 as a mixed school and later It was promoted as a National School. At present the students' population is over 2864 up to Grade 11 and the GCE (A/L) classes will commence in near future. The college is committed to a rigorous, comprehensive approach to promote all academic and extracurricular activities in accordance with the guidance of Ministry of Education and the Ministry of Defence.





23.1.5 Defence Services College -Kurunegala

Defence Services College, Kurunegala was established on 29th January 2009 and functioned as

a mixed school under the Department of Education of North Western Province. The student population is over 1023 up to Grade 9 at present.
