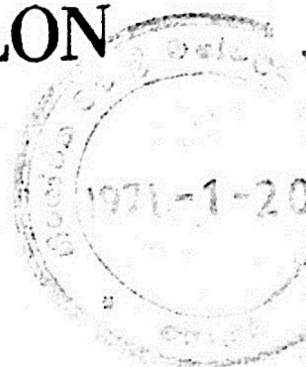

AN ACT TO ENABLE THE MINISTER OF LOCAL GOVERNMENT TO DELEGATE SOME OF HIS POWERS, FUNCTIONS AND DUTIES UNDER CERTAIN ENACTMENTS TO CERTAIN OFFICERS; AND TO MAKE PROVISION FOR ALL MATTERS CONNECTED THEREWITH OR INCIDENTAL THERETO.

[Date of Assent: December 24, 1970]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Ceylon in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Minister of Local Government (Delegation of Powers) Act, No. 31 of 1970.

Short title.

2. (1) The Minister may, by Notification published in the *Gazette*, delegate to the Permanent Secretary or to the Commissioner of Local Government any of the powers, duties or functions vested in or imposed or conferred upon such Minister by such of the provisions of written law as are set out in the Schedule hereto.

Delegation of powers, duties and functions.

(2) Any delegation made and published in the *Gazette* under sub-section (1) may, at any time, and in like manner, be revoked by the Minister.
