AN ACT TO AMEND THE RENT RESTRICTION ACT. Chapter 274,

[Date of Assent: January 9, 1964]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Ceylon in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Rent Restriction (Amendment) Act, No. 2 of 1964. Short title.

2. Section 12 of the Rent Restriction Act (hereinafter referred to as the "principal Act"), as amended by Act No. 10 of 1961, is hereby further amended as follows:— Amendment of
section 12 of
Chapter 274.

(1) in sub-section (1) of that section, by the substitution, for the words " the Board or the ", of the word " the ";

(2) in sub-section (3) of that section—

(a) by the substitution, for the words " paid to the Board or the authorised person, the Board or the authorised person, as the case may be, shall ", of the words " paid to the authorised person, the authorised person shall ", and

(b) by the substitution, for all the words from " issue to the Board " to the end of that sub-section, of the following—

" issue to the authorised person a receipt in acknowledgment of the amount so transmitted to him.".;
and

(3) in the marginal note to that section, by the omission of the words " Board or ".

Amendment of
section 22 of
principal Act.

3. Section 22 of the principal Act is hereby amended by the repeal of sub-section (1) of that section and the substitution therefor of the following sub-section:—

“(1) The remuneration and allowances payable to a member of the Board of Review or of any Rent Control Board or to an authorized officer within the meaning of sub-section (1) of section 25 and the travelling expenses payable to any person referred to in paragraph (c) of sub-section (2) of this section shall be paid out of moneys provided by Parliament for the purpose.

All other expenses incurred in the administration of this Act shall be met out of the funds of the local authority within the administrative limits of which such expenses are incurred.”
