AN ACT TO MAKE PROVISION FOR THE SERVICE OF THE FINANCIAL YEAR 1953-54, TO AUTHORISE THE PAYMENT BY WAY OF ADVANCE OUT OF THE CONSOLIDATED FUND OF MONEYS REQUIRED DURING THAT FINANCIAL YEAR FOR LOAN FUND EXPENDITURE, AND TO PROVIDE FOR THE REFUND OF SUCH MONEYS TO THE CONSOLIDATED FUND.

[Date of Assent: September 18, 1953.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Ceylon in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Appropriation Act, No. 37 of 1953.

Short title.

2. Without prejudice to any other law authorising any expenditure, sums not exceeding rupees seven hundred and twenty-five million seven hundred and ninety-four thousand five hundred and thirteen in the aggregate are hereby declared to be payable out of the Consolidated Fund for the service of the financial year beginning on October 1, 1953, and ending on September 30, 1954, and the said sums may be expended as specified in the First Schedule hereto.

Appropriation for financial year 1953-54.

3. (1) In addition to the sums mentioned in section 2, sums not exceeding rupees two hundred and forty-three million seven hundred and thirty-six thousand three hundred and twenty in the aggregate are hereby declared to be payable by way of advance out of the Consolidated Fund, during the financial year referred to in that section, for Loan Fund Expenditure, and the said sums may be expended as specified in the Second Schedule hereto.

Payment from and refund to Consolidated Fund of advances for Loan Fund Expenditure.

(2) Where the total sum paid under sub-section (1) by way of advance during the financial year beginning on October 1, 1953, and ending on September 30, 1954, has not been refunded to the Consolidated Fund out of the proceeds of any loan authorised to be raised under any written law, that sum or so much thereof as has not been so refunded shall be, and is hereby declared to be, chargeable as if it were expenditure out of the Consolidated Fund for the service of the financial year beginning on October 1, 1958, and ending on September 30, 1959, in addition to any other sums that may by law be payable, or may by any written law hereafter enacted be declared to be payable, for the service of that financial year.
