AN ACT TO AMEND THE LAW RELATING TO LOCAL AUTHORITIES FOR THE PURPOSE OF ENABLING THE EXTENSION OF THEIR TERM OF OFFICE FROM TIME TO TIME.

[Date of Assent: October 7, 1953]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Ceylon in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Local Authorities (Term of Office) Act, No. 38 of 1953. Short title.

2. The Municipal Councils Ordinance, No. 29 of 1947, the Urban Councils Ordinance, No. 61 of 1939, the Town Councils Ordinance, No. 3 of 1946, and the Local Authorities Elections Ordinance, No. 53 of 1946, are hereby amended in the manner specified in the Schedule to this Act.
