Chaminda Wijesiri,— Formulation of a proper methodology for the appointment of Labour Welfare Officers,— This Parliament resolves that the government should formulate a proper methodology in appointing Labor Welfare Officers responsible for the welfare of migrant workers, who make a significant contribution to the economy of Sri Lanka, in order to avoid the many issues that have arisen because of not adopting a proper methodology so far.

P.16/2024

Hon. Chaminda Wijesiri,— Formulating a programme to streamline the appointments made to the Sri Lanka Foreign Service,— That this Parliament resolves that the government prepare a programme to make all appointments to the foreign service, which is tasked with uplifting Sri Lanka's image before the international community, based on the results of competitive examinations and on merit in order to prevent political appointments made to the foreign service, which have led to the deterioration in the quality of the service leading to failure to achieve its desired objectives.

P.17/2024

Hon. Chaminda Wijesiri,— Formulating a proper procurement methodology for purchasing goods and services to depots of the Sri Lanka Transport Board,—This Parliament resolves that the government do formulate a proper procurement methodology for purchasing goods and services to depots of Sri Lanka Transport Board with a view to preventing corruption as the absence of such a methodology is the main cause of the corruption rampant in the Sri Lanka Transport Board.

P.18/2024

Hon. Chaminda Wijesiri,—Formulating a program to make school students aware of the University of Vocational Technology,— That this Parliament resolves that a program be developed by the government to make schoolchildren aware of the courses of the University of Vocational Technology, which targets at the job market and vocational technology, deviating from the traditional university framework in Sri Lanka.

P.19/2024

Hon. Chaminda Wijesiri,— Preparation of a course of action for the implementation of the recommendations given by the audit reports,— That this Parliament resolves that, as the audit reports reveal facts about various financial frauds occurring in various ministries, departments, and statutory bodies of the government, the government should prepare a programme to implement the recommendations given by the audit reports to prevent such acts of fraud and corruption from happening in the government institutions.

P.20/2024

Hon. Chaminda Wijesiri,— Preparing the subjects falling under the provincial councils in a scientific methodology,— That this Parliament resolves that the government should prepare an appropriate programme to allocate the subjects coming under the purview of the provincial councils according to a proper methodology based on a scientific basis to avoid the situation that has arisen since the subjects coming under the purview of the provincial councils have been currently allocated in a way that has no scientific basis, and that various problems have arisen because of this.

P.21/2024

Hon. Chaminda Wijesiri, — Developing a proper methodology to strengthen the Sri Lanka Transport Board, — That this Parliament resolves that the Government should develop a proper methodology to prevent fraud and corruption that occur during the procurement of goods and services by the Sri Lanka Transport Board, since strengthening the public transport service in Sri Lanka is an essential matter.

P.22/2024

Hon Chaminda Wijesiri,— Formulation of a programme to increase milk production,— That this Parliament resolves that a program to increase the milk production in Sri Lanka should be implemented by the government to avoid the substantial amount of foreign exchange outflow on the annual importation of milk.

P.23/2024

Hon. Chaminda Wijesiri, — Enhancing the contribution of the livestock sector to the national product, — That this Parliament resolves that the Government of Sri Lanka should develop a programme to enhance the contribution of the livestock sector to the country's national product.

P. 24/2024

Hon. Ravi Karunanayake,— Abolishing the Pension Scheme of the Members of Parliament of Sri Lanka,— That this Parliament resolves that the Pension Scheme of the Members of Parliament of Sri Lanka should be abolished with immediate effect as it is very apparent that Sri Lankan voters are very hostile for Parliament Members to receive pensions after the completion of their term of office.

P. 25/2024

Hon. Ravi Karunanayake,— Providing a house for every family in Sri Lanka to live in,— That this Parliament resolves that it is necessary to facilitate the chief householder by empowering him to buy, construct or rent a house for his safety, security and well being as every family in Sri Lanka should be entitled to a house to live in.

P. 26/2024

Hon. Ravi Karunanayake,— Making Sports Bodies in Sri Lanka free from politicization,— That this Parliament resolves that the elected politicians should be prohibited from contesting and holding leading positions in sports bodies, as it is evident that these organizations have become heavily politicised in Sri Lanka.

P. 27/2024

Hon. Ravi Karunanayake,— Making every Youth Member a gainfully employed person or self employed entrepreneur,— That this Parliament resolves that every youth member attaining the age of 18 years should have the right to gainful employment or if not employed, be provided with financial assistance to become a self- employed entrepreneur.

P.28/2024

Hon. Rauff Hakeem, Attorney at law,— Appointing a Select Committee of Parliament to investigate and make appropriate recommendations regarding the cremation, instead of burial, of the bodies of COVID-19 pandemic victims,— Whereas the remains of COVID-19 Pandemic victims were cremated without the consent of the relatives based on a policy decision by the government in 2020 to the effect that there was a risk of the virus mixing with underground water while the World Health Organization had issued instructions that the bodies of those who died due to the COVID-19 pandemic could be buried, whereas the government later extended an official apology stating the decision was incorrect, whereas the relatives of those who died in the pandemic lost the opportunity to perform their final

rites according to their religion or witness the bodies, whereas, instead of cremation, the bodies were buried in an isolated area called Oddamawadi, Majma Nagar in Batticaloa in the face of the protests and pressure locally and internationally, still depriving the relatives of the right to perform religious rites and pay their last respects, this parliament resolves that a select Committee of Parliament be appointed to investigate the above-mentioned serious mistakes on the part of the Government and to make recommendations, considering the need to do justice to the families and the next of kin of the deceased and considering the requests on the part of the general public.
