Risk register is not kept up to date.	Risk register updated.
Copies of internal audit reports not submitted to Management Audit Department after 01.08.2018 in terms of sub-section 40 (4) of National Audit Act No. 19 of 2018.	I am informed that with effect from 20.12.2023, all internal audits will be submitted to the Department and will continue in the same manner henceforth.
Not all vehicles are painted with government symbols.	Now all the vehicles have the government emblem affixed on them.
Dormant bank accounts not settled during the year under review or previous years.	Dormant bank accounts during the year under review or previous years have already been resolved.
According to M.R.94 (1), after applying the allocation made to the item of expenditure, the remaining allocation at the end of the year is included in liabilities in excess of the limit.	As per M.R.94 (1), provisions are made not to create bonds beyond the authorized limits in the coming years.
There were loan arrears for more than a year.	Those outstanding loan balances have already been settled.
No action is taken as per MR.571 in respect of overdue deposits in the General Deposit Account.	Regarding expired deposits, it has been settled in the year 2024 according to M.R.571.
