1.1 Introduction

The Administrative Appeals Tribunal was established under the Administrative Appeals Tribunal Act No. 4 of 2002, in pursuance of Article 59(1) amended by 17th amendment to the Constitution

1.2 Vision, Mission and Objective

1.2.1 Vision

To be an accessible and expert organization that delivers administrative justice.

1.2.2 Mission

To undertake high quality and independent review of an order or a decision made by the Public Service Commission and the National Police Commission in the exercise of its powers under Chapter IX of the Constitution in respect of a Public Officer or a Police Officer and deliver administrative justice.

1.3 Key Functions

1.3.1 To hear and determine any appeal made by an aggrieved Public or Police Officer against an order or a decision issued by the Public Service Commission and Audit Commission or the National Police Commission and Audit Commission.

1.3.2 Undertaking an appeal

Appeals shall be made in terms of the Section 4(1) and 4(2) of the Administrative Appeals Tribunal Act No. 4 of 2002

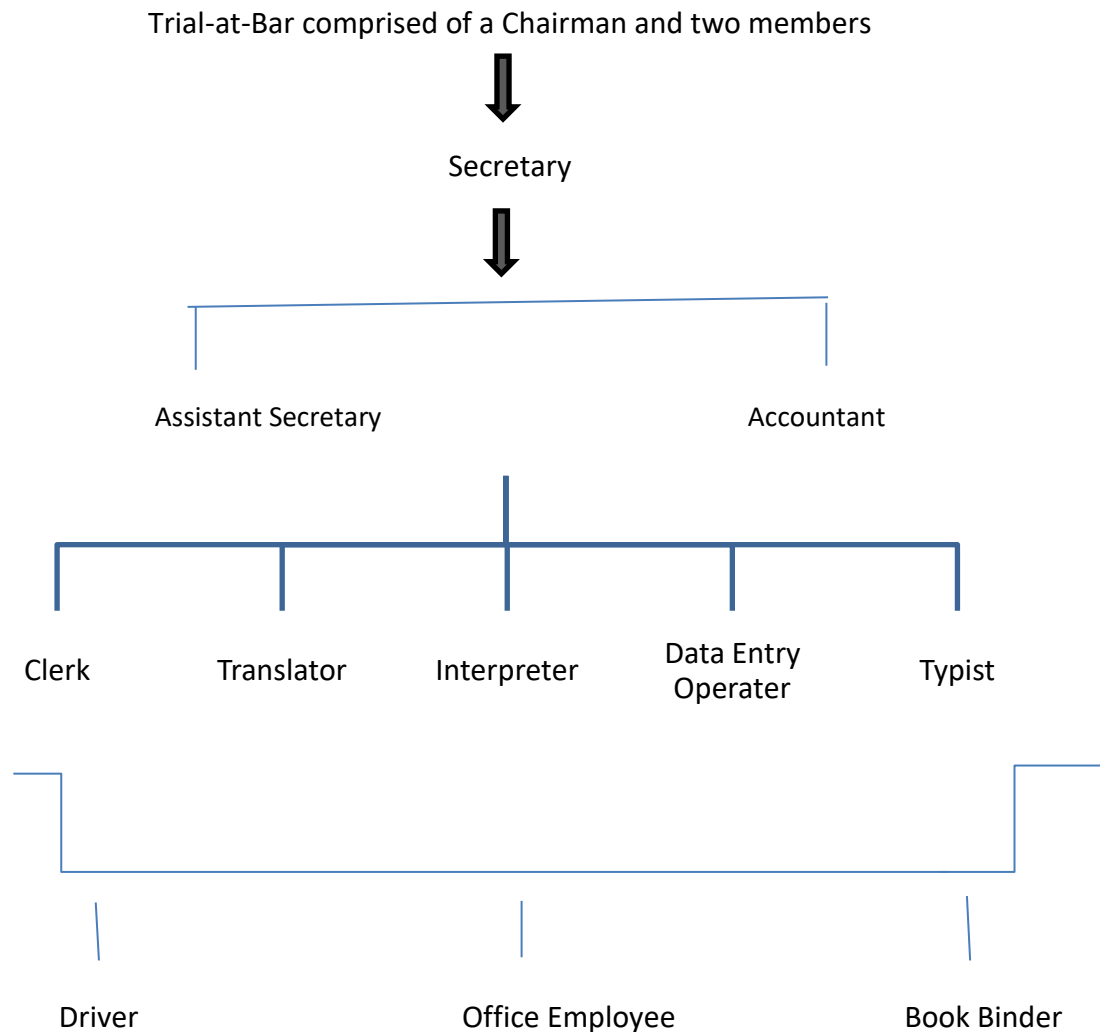
1.3.3 Actions to be taken upon the receipt of an appeal

Initial steps are taken in terms of the Section 5(1) and 5(2) of said Act and subsequently as per the Section 6 (a), (b), (c) and (d) of the same

1.3.4 In terms of the Section 7 of said Act, the Tribunal shall hear and finally dispose of any appeal preferred to it, within a period of two months from the date of receipt of such appeal

1.3.5 A case is heard in terms of the provisions stipulated in Section 8(1) of said Act, and as per the Section 8(2) of the same, a decision made by the Tribunal shall be final and conclusive and shall not be called in question in any suit or proceedings in a court of law.

Summary Report of the Auditor General in terms of the Section 11 (1) of the National Audit Act no 19 of 2018 regarding the Financial Statement of the Administrative Appeals Tribunal for the year ended on 31 December 2023-Head 009

1. Financial Statements

1.1 Qualified Opinion

The audit of the financial statements of the Administrative Appeals Tribunal for the year ended 31 December 2024 comprising the statement of financial position as at 31 December 2024 and the statement of financial performance and cash flow statement for the year then ended, was carried out under my direction in pursuance of the provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka. This Report includes my comments and observations on the financial statements of the Administrative Appeals Tribunal in terms of Section 11(1) of the National Audit Act No.19 of 2018. In terms of Section 11 (2) of National Audit Act No. 19 of 2018, a comprehensive report on Management Audit will be duly issued with the Chief Accounting Officer of the AAT. The Auditor General's Report will be duly issued in future which requires to be furnished to Parliament in terms of Article 154(6) of the Constitution of the Democratic Socialist Republic of Sri Lanka to be read in conjunction with Section 10 of the National Audit Act No.19 of 2018.

1.2 Basis for Opinion

I conducted my audit in accordance with Sri Lanka Auditing Standards (SLAUSs). My responsibilities, under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

1.3 Responsibility of the Chief Accounting Officer for the Financial Statements

The Chief Accounting Officer is responsible for the preparation of financial statements that give a true and fair view in accordance with Generally Accepted Accounting Principles and in accordance with the regulation made in Section 38 of the National Audit Act No. 19 of 2018 and for such control as the Chief Accounting Officer determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error. As per Section 16(1) of the National Audit Act No.19 of 2018, the Tribunal is required to maintain proper books and records of all its income, expenditure, assets and liabilities, to enable annual and periodic financial statements to be prepared of the Tribunal.

The Chief Accounting Officer should certify that an effective internal control system is prepared and maintained for the financial control of the Administrative Appeals Tribunal in terms of Sub-section 38(1)(c) of the National Audit Act and a review should be made from time to time on the effectiveness of that system and as such, necessary changes should be carried out to operate the system effectively.

1.4 Auditor's Responsibility for the Audit of the Financial Statements

My objective is to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's summary report that includes my opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Sri Lanka Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Sri Lanka Auditing Standards, I exercise professional judgment and maintain professional skepticism throughout the audit. I also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks and obtain audit evidence that is sufficient and appropriate to provide a basis for my opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from

error as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Tribunal's internal control.
- Evaluate the appropriateness of accounting policies and the reasonableness of accounting estimates related disclosures made by the management.
- Evaluate overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

I communicate with the Chief Accounting Officer regarding among other matters, significant audit findings, including any significant deficiencies in internal control that I identify during my audit.

1.5 Report on Other Legal Requirements

I state the following matters in terms of Section 6(1) of the National Audit Act No. 19 of 2018.

- (a) The Financial Statement correspond to the previous statement.

2. Financial Review

2.1 Expenditure Management

(a) The recurrent expenditure in 04 object codes remained 14% to 100% as balance - Rs. 636798/- for the reason of not preparing expenditure estimates in terms of Section 50 of Financial Regulation.

(b) The initial allocation for maintenance of machineries and equipment had been Rs. 250,000/- and later a sum of Rs. 200,000/- absorbed to said object code as the transfer under Section 66 of FR. However the reason for the transfer stated therein cannot be accepted in auditing.

2.3 Noncompliance with the Law, Rules and Regulations

Following are observed.

Reference to Law, Rules and Regulation

(a) Section 16.2 of National Audit Act No. 19 of 2018.

Non Compliances

The draft performance report for the review year not made to audit together with the Financial statement.

(b) Para 4 of Public Financial Circular No. 02/2020

Dated 28.08.2020

The procurement plan for the review year not been prepared

(c) Section 6 of the Guide Line of the Public Accounts

(i) The receipt of Rs. 663,300/-under Public Officers "B" Account stated as a receipt under Act 6 Form by the cross entries.

(ii) The Non-financial Assets Report (SA82) generated by the CIGAS Website instead of the Act 6 form was not attached to financial statement. Also in the financial statement at the end of year under review as non-financial assets of Rs. 21,014,390, but the Non-Financial Assets Report (SA82) was a blank report.

3. Good governance

3.1 Obligations to general public

As per the Section 10 of the Act of Right to information No. 12 of 2016 a website is to be created in order to either commend or comment on the performance of the Tribunal but such is not created so far by the Tribunal.

4. Human Resources Management

Following are observed.

(a) In accordance with provided information, the approved cadre of the Tribunal shall be 31 as at 31.12.2021 but the actual employed cadre has been 21, and out of 21 rendering 11 positions vacant. Even if duration of rendering 4 positions vacant has been 01-05 years no step taken to fill them so far, instead retired officers deployed in service on contract basis.

(b) In accordance with para 2(iv) of Public Management Circular No. 03/2018 of 20th February, 2018, no persons over 67 years of age shall appoint to an approved position in public service, such 04 officers have been deployed in service.

(c) An officer whom attached to the Tribunal by Judicial Service Commission, deployed in service so far by the Tribunal even though said officer has not completed required qualifications for the confirmation in the post within two years from 13th February, 2018.

(d) Though 21 years has passed from the years of establishment of the Tribunal no procedure for recruitment of officers for the Tribunal prepared.

(e) No Human Resources Development plan prepared for the review year as per the Public Administrative Circular No. 02/2018 dated 24.01.2018.
