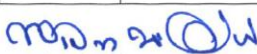

Number relating to the matter	Deficiencies identified by the Committee	Measures taken by the institution to fix the deficiencies/Current Position
02	Non-remittance of stamp duty recoveries to local authorities	A discussion was held in this regard with the Registrar General's Department and provincial commissioners of revenue of all provinces. It was revealed therein that collection of revenue has been obstructed due to the failure in the coordination between the institutions which connect with each other in the collection of stamp duty. It was proposed that this problem could be solved by the online system being presently used by the North Western Provincial Revenue Department and accordingly, all Provincial Chief Secretaries and Commissioners of Local Government were made aware of this online system at the Interprovincial Subject Coordinating Conference held on 06.02.2024. The Committee on Public Accounts has been informed by letter No. PL/6/7/4/SGP dated 30.06.2024 (Annexure 01) along with copies to Chief Secretaries as well, that the stamp revenue could be increased subsequent to implementing the said system in each province. Furthermore, the Committee on Public Accounts has been informed again by letter No. PL/6/7/4/EP dated 21.08.2025 (Annexure 02).
10	Control of Vehicles	Details of vehicles auctioned and removed as scrap during the 10 preceding years in the 9 provincial councils have been forwarded to the Committee on Public Accounts by covering letter No.PL/6/7/4/EP dated 23.11.2023 (Annexure 3) along with the relevant register.
