Shortcomings identified by the Committee	Actions taken by the Institution to rectify the shortcomings/current status
The Register of Risk was not maintained up-to-date basis.	Although the non-maintenance of the Register of Risk was identified as a shortcoming in the performance evaluation regarding the above matter, the institution has prepared the Register of Risk for the year 2023.
The emblem of the state had not been painted on all pool vehicles.	• This Commission conducts raids and investigations throughout the island, and in order to ensure the successful conduct of these raids and investigations and to maintain their confidentiality and security, it is necessary to prevent the vehicles used for raids and investigations from being identified as government vehicles, and this measure has been taken accordingly. • Furthermore, in addition to pool vehicles, official vehicles are used for raids and investigations where necessary, and the state emblem is therefore not painted on the official vehicles as well.
Ad hoc interim imprests issued as per FR370 were not settled within a period of one week.	The Commission mainly issues advances for raid purposes, and delays in settling such advances have occurred because the Investigation Officers involved are required to perform court-related duties of that raid, and because the same officers are sometimes assigned to other raids immediately after one raid is completed. However, in most cases, any remaining balance has been returned to the Shroff immediately after the task is completed. However, there have been delays in the preparation and submission of vouchers to the Accounts Division. Nevertheless, all officers have been instructed to settle the advances within one week.
