Parliament met pursuant to adjournment. The Speaker took the Chair.**1. Presentation of Papers :** (1) The Minister of Foreign presented the—

- (i) Annual Report Central Bank of Sri Lanka for the year 2019;
- (ii) Annual Report of the Ministry of Finance for the year 2019;
- (iii) Mid-Year Fiscal Position Report for the year 2020; and
- (iv) Pre-Election Budgetary Position Report for the year 2020

Ordered that the said Reports do lie upon the **Table**.

2. Legislative Standing Committee : The Leader of the House of Parliament moved,—That notwithstanding the provisions of Standing Order 113 of the Parliament, the Legislative Standing Committee shall consist of the Deputy Speaker as the Chair, the Deputy Chairperson of Committees and fifteen (15) other Members to be nominated by the Committee of Selection to serve in the First Session of the Ninth Parliament.

Question put, and agreed to

3. Committee on Standing Orders : The Leader of the House of Parliament moved,—That notwithstanding the provisions of Standing Order 116 of the Parliament, the Committee on Standing Orders shall consist of the Speaker as the Chair, the Deputy Speaker, the Deputy Chairperson of Committees and nine (9) other Members to be nominated by the Committee of Selection to serve in the First Session of the Ninth Parliament.

Question put, and agreed to.

4. House Committee : The Leader of the House of Parliament moved,— That notwithstanding the provisions of Standing Order 117 of the Parliament, the House Committee shall consist of the Speaker as the Chair and fourteen (14) other Members to be nominated by the Committee of Selection to serve in the First Session of the Ninth Parliament.

Question put, and agreed to.

5. Committee on Ethics and Privileges : The Leader of the House of Parliament moved,— That notwithstanding the provisions of Standing Order 118 of the Parliament, the Committee on Ethics and Privileges shall consist of sixteen (16) Members to be nominated by the Committee of Selection to serve in the First Session of the Ninth Parliament.

Question put, and agreed to.

6. Committee on Public Petitions : The Leader of the House of Parliament moved,— That notwithstanding the provisions of Standing Order 122 of the Parliament, the Committee on Public Petitions shall consist of twenty three (23) Members to be nominated by the Committee of Selection to serve in the First Session of the Ninth Parliament.

Question put, and agreed to.

7. Backbencher Committee : The Leader of the House of Parliament moved,— That notwithstanding the provisions of Standing Order 126 of the Parliament, the Backbencher Committee shall consist of the Chief Government Whip, the Chief Opposition Whip, eight (8) Backbenchers from the Government and eight (8) Backbenchers from the Opposition to be nominated by the Committee of Selection to serve in the First Session of the Ninth Parliament.

Question put, and agreed to.

8. Resolution under the Constitution of the Democratic Socialist Republic of Sri Lanka : Order read for resuming. Adjourned debate on question (27th August, 2020),— “In terms of paragraph (2) of Article 150 of the Constitution, that Parliament resolves that during the period commencing on September 1, 2020 and ending on the day immediately preceding the date of commencement of the Appropriation Act providing for the services of the financial year 2020 or ending on December 31, 2020 whichever date occurs first—

- (a) sums not exceeding rupees nine hundred forty nine billion seven hundred sixty three million four hundred sixteen thousand (Rs.949,763,416,000) shall be payable out of the Consolidated Fund of the Democratic Socialist Republic of Sri Lanka for the services specified in the First Schedule to this Resolution, (being services in respect of which provision for expenditure was made by the Appropriation Act, No. 6 of 2019 and by Supplementary Estimates) and that the said sums may be expended during the aforesaid period, in the manner specified in such Schedule; and
- (b) sums not exceeding rupees seven hundred ninety five billion nine hundred twenty four million eight hundred thirty seven thousand (Rs.795,924,837,000) shall be payable out of the Consolidated Fund of the Democratic Socialist Republic of Sri Lanka for the services specified in the Second Schedule to this Resolution (for expenditure pertaining to providing for the services authorized by laws to be charged to the Consolidated Fund) and that the said sums may be expended during the aforesaid period, in the manner specified in such Schedule; and
- (c) sums not exceeding rupees two billion (Rs.2,000,000,000) in the aggregate, shall be payable by way of advances out of the Consolidated Fund of the Democratic Socialist Republic of Sri Lanka for the services specified in Column I of the Third Schedule to this Resolution and that the debits incurred in respect of any such services during the aforesaid period, shall not exceed the maximum limits as specified in the corresponding entry in Column II of that Schedule; and
- (d) sums not exceeding rupees one thousand three hundred billion (Rs.1,300,000,000,000) shall be proceeds as loans to be raised in terms of relevant laws whether in or outside Sri Lanka, for and on behalf of the Government, in respect of which provision for expenditure for providing such services mentioned in the Schedules to this Resolution and the details of such loans shall be incorporated in the Final Budget Position Report which is required to be tabled in Parliament under Section 13 of the Fiscal Management (Responsibility) Act, No. 3 of 2003.
