Parliament met pursuant to adjournment. The Speaker took the Chair.

1. Announcements by the Speaker: The Speaker made the following announcement:—

“I wish to draw your attention to Article 41A(1)(f) of the Constitution of the Democratic Socialist Republic of Sri Lanka which stipulates the provisions for the appointment for a Member of Parliament nominated by the agreement of the Members of Parliament who do not represent the Government and those who do not belong to the political party or independent group to which the Leader of the Opposition belongs as a Member of the Constitutional Council.

In view of the above, I wish to convene a meeting on Friday, 06th December 2024 i.e. tomorrow at 11.00 a.m. in Committee Room No. 02 of Parliament to discuss and elect a Member for the above appointment, and I request all the Members of Parliament who do not represent the Government and who do not belong to the political party to which the Leader of the Opposition belongs, that is, the Samagi Jana Balawegaya, to attend the said meeting.

I also wish to inform you that any requests or nominations for the said appointment from the Honourable Members of Parliament who would not be present at the above meeting will not be considered.”

2. Presentation of Papers: (1) The Speaker presented the —

- (i) Sixth Installment – Part XXVI of the Report of the Auditor-General for the Financial Year 2022; and
- (ii) First Installment – Parts IX, X, XI, XII, XIII, XIV, XV, XVI, XVII, XVIII and XIX, Fourth Installment – Parts III, IV, V, VI, VII, VIII, IX, X, XI and XII, Fifth Installment – Parts V, VI, VII, VIII and IX and Sixth Installment – Parts I, II, III, IV, V, VI, VII, VIII, IX, X, XI, XII, XIII, XIV, XV, XVI, XVII, XVIII, XIX, XX, XXI and XXII of the Report of the Auditor-General for the Financial Year 2023

in terms of Article 154(6) of the Constitution of the Democratic Socialist Republic of Sri Lanka.

Ordered that the said Reports do lie upon the **Table** and be printed.

(2) The Speaker presented the Special Audit Report on the Scheme Implemented during 01 May 2022 – 15 September 2023 to provide Fully- Electric Vehicle Permits for Sri Lankans Employed Abroad Based on their Foreign Remittances – Tenth installment of the Report of the Auditor-General, in terms of Article 154(6) of the Constitution of the Democratic Socialist Republic of Sri Lanka.

Ordered that the said Reports do lie upon the **Table** and be printed.

(3) The Prime Minister and Minister of Education, Higher Education and Vocational Education presented the Supplementary Estimate No.14 of 2024 and moved that this Supplementary Estimate be referred to the Committee on Public Finance.

Question put, and agreed to.

(4) The Prime Minister and Minister of Education, Higher Education and Vocational Education presented the Report on the submission of observations and steps taken in terms of the Standing Order 119(4) of the Parliament with regard to the matters mentioned on the Election Commission in the report of the Committee on Public Accounts which was presented to Parliament and moved that this Report be referred to the Committee on Public Accounts.

Question put, and agreed to.

3. Sittings of the Parliament: The Leader of the House of Parliament moved,— That notwithstanding the provisions of Standing Order 8 of the Parliament, the hours of sitting of Parliament on this day shall be 9.30 a.m. to 12.30 p.m. and 1.00 p.m. to 5.30 p.m.. At 5.30 p.m. Mr. Speaker shall adjourn the Parliament without question put.

Question put, and agreed to.

4. Business of the Parliament: The Leader of the House of Parliament moved,— That the proceedings on Item Nos. 1 to 13 of Public Business appearing on the Order Paper be exempted at this day’s sitting from the provisions of Standing Orders 27 and 121(2) of the Parliament.

Question put, and agreed to.

5. Resolution under paragraph 02 of Article 150 of the Constitution of the Democratic Socialist Republic of Sri Lanka to submit a Vote on Account in terms of the subsection (1) of section 23 of the Public Financial Management Act, No. 44 of 2024: The Minister of Transport, Highways, Ports and Civil Aviation on behalf of the Prime Minister and Minister of Education, Higher Education and Vocational Education moved,— In terms of paragraph (2) of Article 150 of the Constitution, this Parliament resolves that during the period commencing on January 1, 2025 and ending on the day immediately preceding the date of commencement of the Appropriation Act providing for the services of the financial year 2025 or ending on April 30, 2025 whichever date occurs first—

- (a) sums not exceeding rupees one thousand four hundred and two billion eight hundred and eighty six million two hundred and sixty three thousand (Rs.1,402,886,263,000) shall be payable out of the Consolidated Fund of the Democratic Socialist Republic of Sri Lanka for the services specified in the First Schedule to this Resolution, (being services in respect of which provision for expenditure was made by the Appropriation Act, No. 34 of 2023 and by Supplementary Estimates) and that the said sums may be expended during the aforesaid period, in the manner specified in such schedule; and
- (b) sums not exceeding rupees four thousand one hundred and ninety seven billion one hundred and thirteen million seven hundred and thirty seven thousand (Rs.4,197,113,737,000) shall be payable out of the Consolidated Fund of the Democratic Socialist Republic of Sri Lanka for the services specified in the Second Schedule to this Resolution (for expenditure pertaining to providing for the services authorized by laws to be charged to the Consolidated Fund) and that the said sums may be expended during the aforesaid period, in the manner specified in such Schedule; and
- (c) sums not exceeding rupees five billion (Rs. 5,000,000,000) in the aggregate, shall be payable by way of advances out of the Consolidated Fund of the Democratic Socialist Republic of Sri Lanka for the services specified in Column I of the Third Schedule to this Resolution and that the debits incurred in respect of any such services during the aforesaid period, shall not exceed the maximum limits as specified in the corresponding entry in Column II of that Schedule; and
- (d) sums not exceeding rupees four thousand billion (Rs. 4,000,000,000,000) shall be proceeds as loans to be raised in terms of relevant laws whether in or outside Sri Lanka, for and on behalf of the Government, in respect of which provision for expenditure for providing such services mentioned in the schedules to this Resolution and the details of such loans shall be incorporated in the Reports which is required to be tabled in Parliament under paragraph (d) of subsection (2) of section 50 and paragraph (d) of subsection (2) of section 51 of the Public Financial Management Act, No. 44 of 2024; and
- (e) Any money allocated to Recurrent Expenditure or Capital Expenditure under the "Development Activities" Programme, appearing under the Head No 240 - "Department of National Budget" specified in the First Schedule of this

resolution, may be transferred subject to guidelines specified in the Fourth Schedule to this Resolution, to any other Programme under any other Head in that Schedule, by Order of the Secretary to the Treasury or by Order either of a Deputy Secretary to the Treasury or the Director General of the National Budget Department, who may be authorized in that behalf by the Secretary to the Treasury. The money so transferred shall be deemed to be a supplementary allocation made to the particular Ministry, and a report containing the amount of money so transferred and the reasons for the transfer, shall be submitted to Parliament within two months of the date of the said transfer.
