The Cabinet of Ministers has granted the approval for the Cabinet Memorandum dated 09.09.2022 submitted by the Prime Minister and Minister of Public Administration, Home Affairs, Provincial Councils and Local Government on reducing the age of compulsory retirement of public officers to 60 years by the Decision No:

⊕ 2/2/1403/605/014 and dated 12.09.2022;

Subsequently, the President and the Minister of Urban Development and Housing have submitted 02 Notes to the Cabinet dated 22.09.2022 to the Cabinet Ministers regarding the same.

According to the Cabinet Decision No. @@c/22/1480/601/012 and dated 03.10.2022 regarding the Cabinet Note dated 22.09.2022 submitted by the President, the Cabinet of Ministers has granted the approval to appoint a Ministerial Committee chaired by the Prime Minister to further examine the matters on revising the age of compulsory retirement pertaining to the Services/Posts mentioned in the said Note as proposed therein and submit appropriate recommendations to the Cabinet of Ministers.

The said Ministerial Committee chaired by the Prime Minister has examined the relevant matters and submitted the Report containing its recommendations to the Cabinet of Ministers through the Note to the Cabinet dated 10.10.2022 and by the Cabinet Decision No. @@/22/1632/602/009 and dated 17.10.2022, the Cabinet of Ministers has granted the approval to implement the following recommendations:—

1. Implementing the recommendations from (a) to (e) indicated in the Ministerial Committee Report, subject to taking action as stated at (II) (a) and (b) of the Cabinet Decision No: අමඏ/22/1632/602/009 and dated 17.10.2022 as applicable only to the Specialist Medical Officers, Government Medical Officers, Dental Surgeons and Government Registered Medical Officers, Dental Surgeons and Government Registered Medical Officers.

Sections (II) (a) and (b) of the Cabinet Decision No: අමප/22/1632/602/009 and dated 17.10.2022:—

- (a) Providing the opportunity to the Medical Officers whose date of birth fall during the period from 01st January to 30th June, to serve up to 30th June in the relevant year and retiring them;
- (b) Providing the opportunity to the Medical Officers whose date of birth fall during the period from 01st July to 31st December, to serve up to 31st December in the relevant year and retiring them;

Recommendations from (a) to (e) indicated in the Ministerial Committee Report:—

- (a) to retire the doctors who have already completed the age of 63 years before the upcoming December 31st,
- (b) to retire the doctors who have completed the age of 62 years at the time of attaining the age of 63 years,
- (c) to retire the doctors who have completed the age of 61 years of age on reaching the age of 62 years,
- (d) to retire the doctors who have completed the age of 60 years of age by now upon the completion of 61 years of age,
- (e) to retire the doctors who have completed 59 years of age by now upon the completion of 60 years of age similar to the other government officials.

According to the Note, the recommended interim measures for the retirement of doctors should end on December 31, 2023, and henceforth it is recommended that as well as all other government officers, medical officers should retire on completion of 60 years of age.

2. To amend the Minute on Pensions as appropriate pertaining to the implementation of the decision above, once the approval is received for the Resolution

That this Parliament resolves that the Cabinet Decision No. අමජ/22/1632/602/009 and dated 17.10.2022 should be implemented as stated in 1 and 2 above.
