(Mrs.) Rohini Kumari Wijerathna,— Eliminating physical punishment of children from Sri Lanka,— That this Parliament resolves that necessary steps be taken by the government to end the national crisis of child protection through speedy amendment of legislation and proper implementation of existing laws whereas a determination has been given on 12.02.2021 through Supreme Court Case No. SC/ FR/97/2017 condemning physical punishment and mental harassment of children and for repealing Section No.341 (i) of the Penal Code, implementation of Sections No.19, 28 (2) and 37 of the UNCRC and implementation of Circular No.12/2016 of the Ministry of Education, whereas significant steps were not taken in relation to the killing of an 08 year old girl child by caning her at home on 01.03.2020, at least based on the said Supreme Court determination even though that incident was paid attention by national and international media, whereas the crisis situation in relation to child protection, specially putting an end to physical punishment, has been emphasized in the monitoring report of the United Nations Committee on the Rights of the Child on Sri Lanka dated 02.02.2018 highlighting the possible long term consequences for children and whereas it has been stated by the Minister of Education that the service rendered by the National Child Protection Authority was not satisfactory in relation to extensively increasing incidents of child abuse as per Hansard No.304/2020 dated 06.10.2020.

(Mrs.) Rohini Kumari Wijerathna,— Establishing the Sri Lanka Grama Niladhari Service,— That this Parliament resolves that the Government should take appropriate steps to formulate a Service Minute and establish a service known as "Sri Lanka Grama Niladhari Service" for the Grama Niladharis who render an enormous service by representing the government and working closely with the rural people.

The Prime Minister and Minister of Public Administration, Home Affairs, Provincial Councils and Local Government,— Resolution for reducing the age of compulsory retirement of public servants up to 60 years - Implementation of the recommendations of the Report of the Ministerial Committee appointed to consider the mandatory retirement age limits with regard to special services/posts mentioned in the Note to the Cabinet CP No. 22/1480/601/012,—

The Cabinet of Ministers has granted the approval for the Cabinet Memorandum dated 09.09.2022 submitted by the Prime Minister and Minister of Public Administration, Home Affairs, Provincial Councils and Local Government on reducing the age of compulsory retirement of public officers to 60 years by the Decision No: № 20/22/1403/605/014 and dated 12.09.2022:

Subsequently, the President and the Minister of Urban Development and Housing have submitted 02 Notes to the Cabinet dated 22.09.2022 to the Cabinet Ministers regarding the same.

According to the Cabinet Decision No. @@c/22/1480/601/012 and dated 03.10.2022 regarding the Cabinet Note dated 22.09.2022 submitted by the President, the Cabinet of Ministers has granted the approval to appoint a Ministerial Committee chaired by the Prime Minister to further examine the matters on revising the age of compulsory retirement pertaining to the Services/Posts mentioned in the said Note as proposed therein and submit appropriate recommendations to the Cabinet of Ministers.

The said Ministerial Committee chaired by the Prime Minister has examined the relevant matters and submitted the Report containing its recommendations to the Cabinet of Ministers through the Note to the Cabinet dated 10.10.2022 and by the Cabinet Decision No. @@/22/1632/602/009 and dated 17.10.2022, the Cabinet of Ministers has granted the approval to implement the following recommendations:—

1. Implementing the recommendations from (a) to (e) indicated in the Ministerial Committee Report, subject to taking action as stated at (II) (a) and (b) of the Cabinet Decision No: අ⊕22/1632/602/009 and dated 17.10.2022 as applicable only to the Specialist Medical Officers, Government Medical Officers, Dental Surgeons and Government Registered Medical Officers, Dental Surgeons and Government Registered Medical Officers.

Sections (II) (a) and (b) of the Cabinet Decision No: අමප/22/1632/602/009 and dated 17.10.2022:—

- (a) Providing the opportunity to the Medical Officers whose date of birth fall during the period from 01st January to 30th June, to serve up to 30th June in the relevant year and retiring them;
- (b) Providing the opportunity to the Medical Officers whose date of birth fall during the period from 01st July to 31st December, to serve up to 31st December in the relevant year and retiring them;

Recommendations from (a) to (e) indicated in the Ministerial Committee Report:—

- (a) to retire the doctors who have already completed the age of 63 years before the upcoming December 31st,
- (b) to retire the doctors who have completed the age of 62 years at the time of attaining the age of 63 years,
- (c) to retire the doctors who have completed the age of 61 years of age on reaching the age of 62 years,
- (d) to retire the doctors who have completed the age of 60 years of age by now upon the completion of 61 years of age,
- (e) to retire the doctors who have completed 59 years of age by now upon the completion of 60 years of age similar to the other government officials.

According to the Note, the recommended interim measures for the retirement of doctors should end on December 31, 2023, and henceforth it is recommended that as well as all other government officers, medical officers should retire on completion of 60 years of age.

2. To amend the Minute on Pensions as appropriate pertaining to the implementation of the decision above, once the approval is received for the Resolution
