1. Introduction

The Rajarata University of Sri Lanka was established on 7th November 1995 by the Hon. Richard Pathirana, Minister of Education and Higher Education, under the provisions of the Universities Act. No. 16 of 1978 and was ceremonially inaugurated by Her Excellency the President on 31st January 1996. It was established for the purpose of providing, promoting and developing higher education in the fields of Social Sciences and Humanities, Management Studies, Agricultural Sciences, Applied Sciences subsequently expanded for Medical & Allied Sciences and Technology.

The University is the successor to the former Affiliated University Colleges at the Central, North-Western and North Central Provinces which were amalgamated to form the Rajarata University on the recommendations made by a committee appointed by the Hon. Minister of Education and Higher Education in 1995.

The University has its main campus located at beautiful surroundings of Mihintale, overlooking the Mihintale rock temple. This site is historically important as the center at which the Buddhist civilization was introduced. It is 10 km away from the ancient capital of Anuradhapura, the Centre of the world renowned hydraulic civilization. The University has six Faculties of which Faculties of Social Sciences and Humanities, Management Studies, Technology and Applied Sciences are located at Mihintale while other two, Faculty of Agriculture and Faculty of Medicine and Allied Sciences are located in Puliyanikulama and Saliyapura respectively.

This University has the strategic advantage of serving the higher educational needs of the entire North Central Province and the country with the resource based available.

17. FACULTY OF AGRICULTURE

A. Introduction

Faculty of Agriculture, Rajarata University of Sri Lanka was established in 2001 with 17 students. Faculty offers a special degree programme in Agriculture with the aim of developing sustainable agricultural systems particularly focused on the production environment of the Dry Zone of Sri Lanka. The degree programme comprises eight semesters, during which courses from different agriculture-based disciplines are offered. At present, faculty consists of four academic departments, namely Agricultural Engineering and Soil Science, Agricultural Systems, Animal and Food Sciences and Plant Sciences. In addition, faculty is equipped with a Computer Unit, English Language Teaching Unit, Faculty Farm and a library. Soil Science, Plant Science and Animal and Food Sciences and GIS laboratories together with Agricultural Engineering workshop provide opportunities for undergraduates to improve their analytical and other skills.

The annual intake of the faculty is 165 students and on-campus residential facilities are provided for all entitled students. The total number of academic and non-academic staff employed in the faculty at present is nearly 90. The degree programme consists of core programme and a specialization module. The core programme is compulsory for all students who are enrolled and spanning through the first five semesters. During the 6th and 7th semesters, students are allowed to select the specialization module on their preference. At the final semester, students should undertake an independent research project which carries six credits and required to submit a comprehensive research report based on their project and then has to undergo an industrial training.

B. Achievements

- 12th Annual Research Symposium was successfully conducted and proceedings were published.

- Enrolled first intake of students for the postgraduate degree programme “Master of Agriculture”.
- Completion of quarters for academic staff members.
- Faculty published the second volume of the E-journal “Sri Lankan Journal of Agriculture and Ecosystems”.
- Faculty E-journal “Sri Lankan Journal of Agriculture and Ecosystems” was recognized by the SLJOL of the NSF.
- Facilities of the lecture halls were improved.
- Winning of NRC grant of Rs. 4.9 million.
- Continuation of the Collaboration of research project (Rs. 12.63 million) with the Presidential Secretariat and the Ministry of Science, Technology and Research on “A multidisciplinary approach for developing a research platform for sustainable cropping systems in the Dry Zone of Sri Lanka”.
- Establishment of the Technology Incubator Centre at Faculty of Agriculture, RUSL with the collaboration of Sri Lanka Inventors Commission.
- “Arancia 2020” Nutrition Day organized by the students of year 3 semester 2 (2015/2016) who are specialized in the Department of Animal & Food Sciences was held successfully on 11th February 2020
- Establishment of Laboratory Services of the Department of Animal & Food Sciences.

C. Failure and Justifications

- Improvement of farm road system was not started due to lack of funds
- Establishment of a laboratory cum lecture halls complex was delayed due to COVID-19
- Purchasing of 600 lecture hall chairs was failed due to COVID-19

18. FACULTY OF APPLIED SCIENCES

A. Introduction

The Rajarata University of Sri Lanka (RUSL) was established in November 1995 by the Gazette Notification No: 896/2 of 7th November 1995 in the Administrative District of Anuradhapura. The Faculty of Applied Sciences (FASc) was inaugurated on 10th January, 1997 by amalgamating the Central Province Affiliated University College (CPAUC) in Polgolla with the immediate task of offering three year Degree Programme for upgrading all the students successfully completed their Diploma requirements, to the Graduate level with a batch of 102 students, who subsequently graduated in 1998. The first batch of students who were directly sent by the UGC to follow the degree programme was enrolled in November 1997.

The Faculty was finally established in the premises of the main campus at Mihintale, on 16th January 2006. With the continuous development, the Faculty envisions to be a dynamic, innovative and renowned centre of excellence in learning, research, training and consultancy with emphasis on national relevance and international recognition in different disciplines of Applied Sciences under 13 Undergraduate degree programmes through five Departments including the newly established Department of Chemical Sciences in 2020. In addition, Faculty intended to offer the Higher Degrees by research and Postgraduate Diploma Programme.

B. Achievements

- The Faculty submitted the Self Evaluation Reports on 30th June 2020 to the Quality Assurance Council, University Grants Commission.
- Ethic Review Committee initiated to give the ethical clearance to conduct the research including the external applications.
- Curriculum Development
 - Honours degree program in Mathematics developed are underway of modification according to the suggestions by the Curriculum Development Committee.
 - A syllabus for Statistics developed to be sent to the Curriculum Development committee
 - The curriculum revision of the B.Sc. in Health Promotion and B.Sc. Honours in Health Promotion programmes completed are under the approval of Curriculum Development Committee of the university.

20. FACULTY OF MEDICINE & ALLIED SCIENCES

A. Introduction

The Faculty of Medicine and Allied Sciences (FMAS), Rajarata University of Sri Lanka (RUSL) was established in July 2006 and comprises fifteen academic departments and 3 academic units. Anuradhapura Teaching Hospital (THA), which is the third-largest hospital in the country, serves as the main teaching hospital of the Faculty. THA houses the University Professorial Unit in the major clinical disciplines equipped with modern diagnostic and management facilities. The staff of all Clinical Departments provide services as honorary consultants at THA. The community practice area consists of a socio-economically diverse population that enables comprehensive training in primary and preventive care. Community care services that are provided by FMAS include services for mentally disabled children, outreach clinics, health promotional activities and maternal and infant care services, especially related to averting child malnutrition and improving maternal morbidity surveillance. The Faculty continually strives to uplift the standards of the institution, by paving the way for students to reach their full potential. Throughout the short history of the Faculty, our undergraduates have secured high ranks in the common merit order and excelled in various postgraduate courses.

21. FACULTY OF SOCIAL SCIENCE AND HUMANITIES

A. Introduction

The Faculty of Social Sciences and Humanities was established with the inception of the university in 1995. At present, the faculty comprises a student population of around 2135. In 2020, the faculty enrolled 434 students and the current intake is 434 students.

The faculty of Social Sciences and Humanities comprises 6 Departments. The faculty offers a BA (General) and BA (Hon.) Degree programs, each leading to their perspective study programs as follows,

 - Bachelor of Arts Honors in Environmental Management
- Department of Humanities

 - Bachelor of Arts Honors in Sinhala
- Department of Social Sciences
 - Bachelor of Arts Honors in Economics

The graduates will achieve these outcomes through the above mentioned study programs.

- Organized entertainment programmes related with art, aesthetic and literature.

 Due to the COVID 19 pandemic situation, there was a delay in new admission of the 2018/2019 intake. Once the admissions were done, there was a necessity of having parallel semesters. Therefore, the lectures were conducted for this intake in virtual sessions via ZOOM.

22. FACULTY OF TECHNOLOGY

A. Introduction

The Faculty of Technology was officially gazetted on the 14th of September 2017 as the 6th Faculty of the Rajarata University of Sri Lanka (RUSL). The initiative to launch the Faculty of Technology came from within the Faculty of Applied Sciences (FAS) of RUSL in January of 2015, with the intention of expanding the overall current academic structure of the institution. Through this initiative, it was hoped that the inadequately elaborated academic structure be improved as compared with other Sri Lankan universities of similar size and scope.

The Faculty of Technology comprises 5 Departments, each leading to their respective degree programmes: 1- Bioprocess Technology (BPT), 2- Electrical & Electronic Technology (EET), 3- Food Technology (FT), 4- Information & Communication Technology (ICT), 5- Materials Technology (MT). All degree programmes follow the SLQF 6 format spanning a study period of 4 years. Students who have sat for their G.C.E. A/Ls under the technology stream are selected for these degree programmes and are initially grouped into Biosystems Technology, Engineering Technology and Information & Communication Technology. The Biosystems Technology and Engineering Technology students are then branched out into Bioprocess and Food, and Electrical & Electronic and Materials Technology, respectively, during their second year of study, taking into account their preference, academic performance as well as the availability of resources and market demand.

Compared with existing courses in the country, the Technology degree programmes are more vocational, heavily focusing on nurturing hands-on skills. Industry tie-ups and collaborations were incorporated from the very beginning itself into the curricula. This is deemed an important aspect given that students from all degree programmes have to go for an industrial placement and a semester-long research project during their final few semesters of study.

In addition to the funding received from the University Grants Commission (UGC), the Faculty also receives financial support from the Asian Development Bank (ADB) for infrastructure and human resource development. The Faculty has taken in three batches of G.C.E. A/L Technology stream students to date, with the senior most students in their fourth year first semester having already completed their industrial training. Currently the faculty is hosting four batches added up to 1060 students while, there are 28 permanent staff members and 9 temporary staff members involved in teaching.

B. Achievements

Furnishing and electrical wiring of the ICT laboratory was completed and the network wiring is underway. The laboratory will be ready to use by the end of January 2021. Construction of phase II and III buildings are in progress. According to the constructors' time line the Engineering workshop and the Material Pilot Plant will be completed by the end of February. The three-storied building will be completed by end of April and the entire project will be completed by November 2021. The Science and Technology Human Resource Development (STHRD) project funded by the Asian Development Bank is progressing. Several sets of Laboratory, office and teaching equipment were purchased under the project. The financial bids of the civil work of the project were opened and will proceed to the cabinet appointed procurement committee for its approval. In addition to that the faculty managed to secure another LKR 25 million from the ADB for COVID 19 prevention and promote online teaching and learning. Out of 25 million, 13 million was allocated to provide Wi-Fi access to student hostels. Other amount was utilized to purchase online teaching and learning equipment and hand sanitizers, gloves, masks and soap for the usage of entire University. The faculty managed to successfully shift toward the online teaching due to the COVID 19 pandemic. Theoretical

components of all the courses have completed using online teaching and student participation of 60% was detected across all years. End semester exams and practical work of 3rd year 2nd semester 15/16 ICT batch were conducted after two weeks of quarantine period at the hostels. The 16/17 batch was brought into the University on December 2020 for their end semester exams and practical classes.

A 75kW solar PV system was installed on the stage I building of the Faculty under the STHRD project funded by the ADB and commissioned on September 2020. The income was deposited to the faculty development fund. A 300kW electricity generator was also installed for the faculty. The technology service center was established to provide instrument and consultant services to the outside institutes. The income was also deposited into the faculty development fund and to the University.

The Biosystem Technology students and Engineering Technology students of the 15/16 intake have completed their third year 1st semester and went for the industrial training. This is the first time the Technology faculty has applied for the industrial training and all the students were managed to secure industry placements in reputed companies relevant to their fields of studies. ICT students of the same batch was completed their 3rd year 2nd semester and moved into their final two semesters. The faculty admitted its 4th batch (18/19 intake), that consisted with 275 students. The total student number of the Faculty was increased to 1065 with the new intake. The faculty recruited two senior lecturers and six probationary lecturers increasing the total permanent cadre to 29.

The Department of Bioprocess Technology (BPT), Faculty of Technology was able to secure three (03) research grants from the ADB Science and Technology Human Resource Development Project, WHO-TDR research grants and IAEA/CRP GRANT SRL2020007 in 2020.

1. IAEA/CRP GRANT SRL2020007 (EUR 54,000) (2022-2023) - “Suppression of melon fly populations by integrating the sterile insect technique in isolated fruit and vegetable production areas of Sri Lanka.”
2. WHO/TDR CROWDFUNDING GRANT 2019 (5650 USD) - “Initiation of Mobile Vector Surveillance Unit (MVSU) and facilitation of Leishmaniasis vector surveillance in Madawachchiya MOH, Sri Lanka”.
3. ADB Science and Technology Human Resource Development Project - Proposal for development of a collaboration with Michigan State University, USA for capacity building, research collaborations, innovations and downstream applications in Smart Agriculture.

A on line webinar on “The Mentor Mentee Relationship” was conducted jointly by the Department of Bioprocess Technology, Faculty of Technology, Rajarata University of Sri Lanka and the TDR Global Asia in Philippines. Keynote speakers of the webinar included Dr. T.C. Bamunuarachchige, (Senior Lecturer, Department of Bioprocess Technology, Faculty of Technology, RUSL), Prof. Joseph Tucker (Associate Professor, University of North Carolina at Chapel Hill and London School of Hygiene and Tropical Medicine, UK) and Prof. Pradeepa Bandaranayake (Director, Agricultural Biotechnology Centre, Faculty of Agriculture, University of Peradeniya, Sri Lanka). There were 589 attendees and 3 panelists. Attendees joined from 34 countries including; Algeria, Bangladesh, Belgium, Bhutan, Burkino Faso, Cameroon, China, Colombia, Ethiopia, Faroe Islands, France, Germany, Ghana, India, Indonesia, Japan, Kenya, Madagascar, Malawi, Maldives, Myanmar, Nepal, Netherlands, Nigeria, Pakistan, Papua New Guinea, Sri Lanka, Switzerland, Tanzania, Thailand, Uganda, UK, USA, and Zimbabwe. Several guest talks were conducted by the department for students. Also seven research articles have been published in peer reviewed journals in

2020 from the department. The department has also purchased some major equipment through STHRD project. Those are Gene gun, Biocane canister system, Hand held PH 450 meter kit Shaker, Microwave oven, Shaking incubator SI 500, Shaking incubator SI 600.

Department of Electrical & Electronic Technology has managed to cover about 80% of the lab sessions related to Electrical and Power, Electronic, Telecommunications, Automation during first three months of the year. They have successfully finished first year first semester, second year first semester and third year first semester of studies through online in the academic program. The process of hiring consultants for the curriculum review process was started with the support of the ADB. The department managed to publish one paper at an IEEE conference in India. The department also hosted a program named travelling University with Trier University of Applied Sciences in Germany. In this program about 20 foreign students from more than 10 countries worked with 20 local students to promote green technologies and zero emission concepts among local industries. The program was also funded by the ADB under the STHRD project.

Department of Food Technology has purchased some major equipment under the STHRD project. Those included Texture analyzer, Refractometer, Viscometer, Water activity meter, Pharmaceutical refrigerator, Chest freezer and Vortex machine. Also the academic staff of the department has published 3 journal articles in 2020.

ICT department achieve success with development of different sectors. Especially with the new equipment. Department received high end workstations, laptops and servers required for practical classes and for the development of the ICT laboratory. New IOT equipment help students projects and enhance the students' knowledge according to the technological changes. Also, department conducted several workshops to enhance the students' knowledge level. One workshop was on the topic of artificial intelligence and the resource person was a doctoral candidate from Norway and another workshop on quality assurance was held with the resource person from a local industry. To enhance the design skills of students the department purchased 3d printers and a training program was carried out to train the staff.

The Department of Materials Technology managed to secure a grant for Developing Crayons and watercolors from naturally available local raw materials with an Industrial partnerships with Atlas Axillia Pvt Ltd, worth of Rs. 10 Million from the STHRD project.

Two probationary lecturers have been awarded the funding to follow their post graduate degrees under the STHRD Project in Australia and Korea.

C. Failure and Justification

Several failures occurred during the year due to the lack of enough academic and non-academic staff members. These include

- delays in regular duties
- poor resource management
- unavailability of consumables in labs for practical on time
- academic staff members spend majority of their time on administrative and nonacademic duties instead of academic duties
- Inability to conduct practical classes and examinations due to COVID 19

Being a newly established faculty, the present staff is struggling to manage the workload. In addition to the inadequate staff the faculty is also facing severe shortage of space for laboratories and office spaces. It also caused several failures, such as

- lack of proper work space for lecturers
- last minute cancellation of lectures due to lecture hall scheduling clashes with other faculties.
- Too much workload for the staff members as requested cadre was not approved
The faculty is struggling to cope up with the limited facilities to cater the increasing student numbers.
- Hostel facilities have become a major concern as the entire Mihintale area was occupied with students.
- Inadequate Canteen facilities causes delay in academic activities as students struggle to get their meals on time due to long ques.
- Lot of time was wasted as students had to walk across the campus from one lecture to another since we are conducting lectures in other faculties.
- Lectures, practical classes and exams were conducted until late night to finish the study program on time. Students and staff had to face several issues due to lack of proper transportation facilities in late hours.

D. Future Plan

Infra-Structure Development

- Constructing buildings: Phase II and III of the UGC funded building: Workshop and the pilot plant are planning to complete by the end of March 2021. ADB funded building complex: Planning to start the construction by October 2021.

Curriculum Development

- Curriculum revisions of all the departments will be completed within 2021.
- The accreditation visits of all the degree programs will be started by the mid 2021.
- Launch of business incubators.
- Organize the annual stakeholder meeting and industrial consultative committee meetings.

Human Resource Development

- Recruitment of Faculty members who have specialized in areas which are relevant to the Technology degree programs
- Probationary lecturers will be sent to their post graduate trainings using ADB financial assistance.
- Foreign experts will be invited to the faculty to conduct workshops on latest technologies available and train academic staff.

23. LIBRARY NETWORK

A. Introduction

History of the Library

The Rajarata University of Sri Lanka was established on the 31st January 1996 under the gazette notification No: 896/2 of 7th November 1995, and the University act 16.08.1978 by amalgamating resources of affiliated university colleges in the central, Northwestern, and north-central provinces. The library system of Rajarata University was started on 2nd September 1996. The first librarian of Rajarata University Library was Prof. Piyadasa Ranasinghe (1996-1998), followed by Mr. Kapila Jayalal Sirisena and Mr. Gamini De Silva (1999-2007). Mrs. Hema Wijethunga (on sabbatical placement -2007-2009) and Mrs. A.S Siriwardana is the present Librarian of the University from 2020 to date.

Library Profile

The library of the Rajarata University is the heart of the institution for the acquisition, organization, and dissemination of knowledge as a widespread tree. The library provides services to the university user community such as undergraduates, postgraduates, academic staff members, executive and non-academic staff members. In addition, the library serves the researchers and outside community in the region.

The Faculty Libraries

The library system of the Rajarata University of Sri Lanka consists of a main library and four faculty libraries in different locations. The main library, Faculty of Applied Sciences, and Faculty of Technology libraries are located within the Mihintale premises and serve the Faculties of Social sciences and Humanities, Management studies, Applied Sciences, Technology consecutively. The Agriculture Library is located in Puliyankulama and the Medical Faculty library is located in Saliyapura. The clinical library is located in Teaching Hospital, Anuradhapura.

Library Staff

Currently, the staff of the library consists of seven (07) Academics, one (01) Administrative officer, one (01) Library Academic Support Staff, and twenty-five (25) Paraprofessionals and Support staff.

Library Collections

Materials that can be found in the main library consist of textbooks, journals, magazines, newspapers, government documents, special collections, reference materials, past project reports, dissertations, past questions papers, and e-resources. All these are materials that have been acquired based on the subject curriculum. The library resources are available in both print and electronic formats.

Library provides the service of Online journal databases which can be assessed full-text journal titles in Medicine, Agriculture, Applied Sciences, Social Sciences, Computer Sciences, and Management disciplines through the "CONSAL". The library subscribed to many current journals and these are intended to help the users to keep up their novel knowledge with the current trends. The book collection comprises textbooks in various subjects disciplines and general knowledge which are mainly useful in all faculties of the Rajarata University.

Main Services of the Library

The main Services of the library include Lending facilities, Reference facilities and Inter-library Loan Systems, Current Awareness Programs, Information Literacy Programs, User Education Programs, Workshops, and Library Website Maintenance. Useful links for online resources are also provided through the library website. The library catalogs can be seen through Online Public Access Catalog (OPAC). The Library is maintaining the University's Institutional Repository. The open-access Institutional Repository preserves and makes available scholarly research by the university scholarly community. The Users can access the online past paper collection through the intranet. Moreover, Library provides community outreach services for North Central province. (e.g Building and re-arranging school and public libraries effectively, Book donation activities, Staff training programs for School and Public Library staff, Improving the reading skills of the user community of North Central Province.)

- **Providing Automated Library Facilities**

The Library has successfully converted the existing library database management system with the open-source software “KOHA”. The library system is using “KOHA” for the Circulation, ordering, budgeting accession, getting statistics and user suggestions. Especially Users can search the library catalog online through KOHA. The library could give remote access facility to the user community for finding e-resources.

- **An Institutional Repository (IR)**

An institutional repository is an online collection of an institution's research output. This repository is vitally important to increase the accessibility and visibility of Rajarata University research output and to increase citation rates and ranking of the University. Currently, it contains more than 2250 publications (Books, Book Chapters, Abstracts, and Full Texts).

- **Intranet Access information sources- Past Papers**

Library provides intranet access to past papers to obtain information for users. They can download share the above materials to fulfill their information needs. Users can search past papers according to their needs.

- **SDI/CAS Services & Research Support Service**

Users can get customized information for their specific information needs using the Selective Dissemination of Information Service (SDI). Current awareness services will notify users about new topics and information about their specific research needs via emails, through notices, and verbally. The library supports users to conduct their researches by providing the necessary information via emails and other ways.

- **Audio Visual resource service & Wi-Fi Access**

The Audio-Visual Unit of the main library provides access to the internet, electronic databases, CD/DVD collection, and other electronic equipment. It facilitates users to search, download and share information. They can also access full-text scholarly articles free of charge. It gives easy access to all electronic materials in the library. The center is equipped with a Wi-Fi surf area of the library building and it allows connecting student's laptops, smartphones, and other portable devices to access electronic information.

- **Photocopying Facility (Private)**

The Library offers photocopying facilities to users. All materials except research reports and theses could be photocopied by users. The scanning and bookbinding facilities are also providing by the Photocopy unit.

- **News Clipping Service**

Library maintains a paper clipping collection for series of subjects. Library planned to convert them to a digital archive by scanning those articles. It includes up-to-date information and users will be able to share, download information through that service.

B. Achievements

- **User Awareness Programs**

Ten (10) Orientation Programs and many User awareness sessions were conducted for the user communities of all faculties. i.e.- Faculty of Management Studies, Agriculture, Medicine, Social Sciences and Humanities, Applied Sciences, and Technology.

- **The Community Outreach Activities**

Workshops and Seminars are regularly organized by the Library system in the field of Library and Information Sciences to the library professionals in public, schools, Piriven Librarians. Library conducted three (03) series of workshops for Pregnant Mothers, Public Librarians, and Farmers of North Central Province. Workshops are delivered under the topics of "How to develop Reading Skills", "Professional Ethics" and "How to deliver information". Further, the library arranged a book exhibition for the outside user community.

- **The Staff Training Schedules**

Library attendants were participated in the workshop on "Library Housekeeping and Operation" which was conducted by University Librarian's Association (ULA).

Two Senior Assistant Librarians have participated in a Short Course on "SPSS Data Analysis" organized by the National Library and Documentation Service Board. In addition, Senior Assistant Librarians have participated in a two-day workshop on "Research Methods and Statistics" at the University of Kelaniya library/ Organized by the University Librarians Association (ULA) and "E-government, cybersecurity, and social media" workshop which was conducted by National Library and Documentation Services Board.

- **Distance Learning Services**

Library integrated with the university Learning Management System (Moodle). The library started to deliver scholarly contents, book chapters, past papers, and other bibliographical data to users via Moodle. Users can access this service by clicking Moodle link on the library website.

C. Failure and Justification

- 1) Time allocation for the library is not sufficient for undergraduates to continue their library activities.
- 2) Inadequate budget allocation for the Library services
- 3) COVID-19 pandemic directly affected to the day today library services.

D. Future Plans

- **RFID Technology/CCTV security systems for Libraries**

The main objective of the Security system is to provide high security to the collection and become the most user-friendly and efficient library within the Sri Lankan University Library Systems.

- **Green Library Environments**

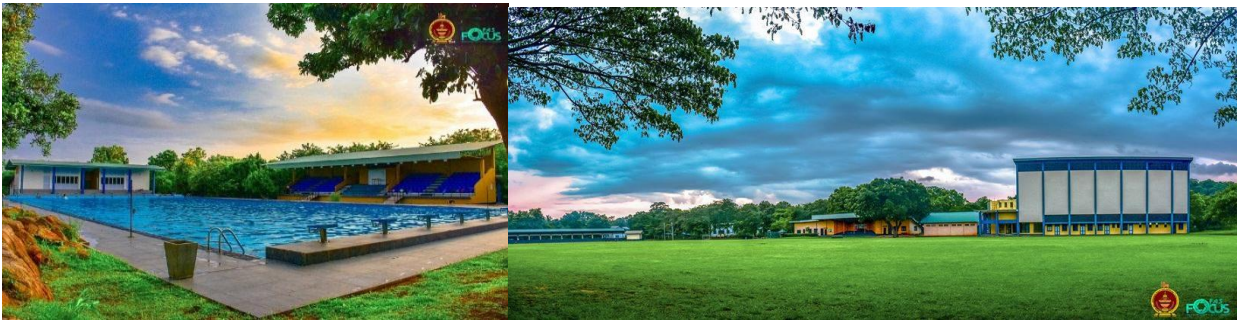
The library is planning to convert the content of electronic resources to a greenstone open-source software environment. It planned to start the digitalization of collection to create an archive of information.

26. CENTRE FOR DISTANCE AND CONTINUING EDUCATION

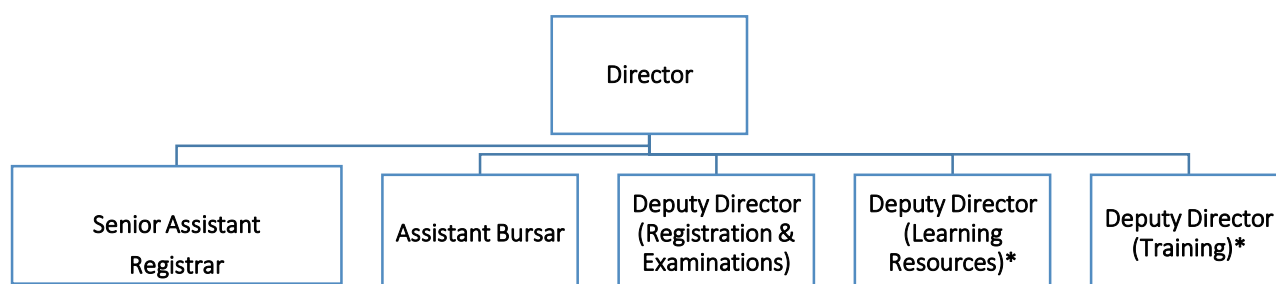
A. Introduction

The University Grants Commission (UGC) and the Ministry of Higher Education have prepared certain guidelines in order to provide learning opportunities to a wider spectrum of students through external programs, with the intention of producing skilled, knowledgeable and employable Graduates, Diplomats and Certificate holders. Universities were requested to establish a separate administrative structure to handle activities of external academic programs effectively and efficiently, this reducing the workload normally handled by the academic departments and faculties. Different faculties of this university offer a number of external degree programs and extension courses at certificate and diploma levels.

The Centre for Distance and Continuing Education (CDCE) of Rajarata University of Sri Lanka is the independent administrative body established to coordinate activities of the external academic programs. The CDCE was established as per the UGC Circular No. 932 with the approval of the Council of the University on 24th October 2011 (155th Council Meeting). Since then, the CDCE was functioned at the Faculty of Applied Sciences until 31st March 2014. The CDCE was shifted to the main administrative building with effect from 1st April 2014.

The administrative Structure of the CDCE, as per the guidelines of the UGC, is given below.

27. STAFF DEVELOPMENT CENTRE

A. Introduction

The Staff Development Centre (SDC) at the Rajarata University of Sri Lanka was established in the year 2015. The vision of the centre is “To be a hub of excellence in professional development”. SDC is in the mission of providing continuous, need based learning and professional development opportunities for all categories of staff within RUSL. SDC, RUSL is managed by a Director and supported by university appointed management committee, including senior academics representing all faculties and chaired by the Vice Chancellor.

B. Workshops and training programs conducted in year 2020

In the year 2020, three workshops and two training programs were completed aiming staff development. And also other two workshops planned for non-academic staff had to be postponed after planning. The major activity conducted in year 2020 was the Certificate in Teaching in Higher Education (CTHE) program. This program started in 11th February 2020. Thirty three (33) participants from five faculties participated for the program and that number was the maximum capacity for one program. CTHE program was planned to continue all five working days in the week in every other week.. Although the program was to compete in 20 days, the completion of the program was delayed until late May due to Covid-19 situation. As the CTHE program was not conducted in 2019, there were large number of RUSL academics and applicants from other higher educational institutes in the waiting list. Hence, preparations were done to start a second CTHE program in 2020, starting from November. But the plans had to be put on hold due to Covid-19 restrictions. Hence, the next CTHE program will be commenced early 2021.

Staff Development Center organized a training program for academic department heads and executive officers on university administrative and financial procedures. This was a five day program conducted one day per week for five weeks and attended by 27 participants from all the faculties and administrative departments.

To support academic staff to keep up with the sudden change of university education to online mode, the SDC organized two workshops on online teaching methods for academic staff members. These workshops were conducted in collaborative with the Department of Computer Engineering of the University of Peradeniya and attended by more than 100 academic staff members.

SDC conducted a workshop for management assistants on office procedures. Thirty five (35) MAs from all faculties and units participated for the workshop which is conducted by a resource person from the University of Peradeniya.

SDC has collaborated with the career guidance unit to conduct monthly sessions of university toast master club. There was one session in January with the participation of a resource person from toast master international.

C. Progress of the Staff Development Center in 2020

The action plan of SDC has approved by the by the university administration for year 2020. The SDC could complete majority of the planned programs despite the restriction with Covid-19 pandemic and introduced new programs based on the need of the staff. And also, the long delayed CTHE program was successfully completed amid the challenges with Covid-19 pandemic. Hence SDC can be recognized as achieved 90% success in year 2020.

The introduction of a new training program for academic department heads and executive officers on university administrative and financial regulations in 2020 was a new value addition to SDC. This program will be continued annually from this year.

D. Challenges during year 2020

The plans to conduct more workshops could not be executed as the university closed down in March 2020 due to Covid-19 and remained closed for months. Even after the university opened, there were travel and gathering restrictions which effected SDC activities. Plans for number of activities organized for year 2020 for both academic and non-academic staff had to be put on hold. This included workshops for academic staff on academic writing, research competencies, students centered teaching and learning and writing SER for program review. Workshops organized for non-academic staff on official letter writing, career guidance counseling, and laboratory safety training had to be put on hold too. A workshop for drivers on “becoming a professional driver” was planned in December but had to be postponed to January 2021 after making all the preparations.

Under those circumstances, the completion of CTHE program was delayed and the last few sessions of CTHE program were conducted using online mode. Furthermore, plans to conduct second CTHE programs was delayed and postponed to 2021. Although some programs could be completed using online platform, difficulty of conducting online sessions for some topics forced SDC to postpone those programs to the next year.

E. Activities for 2021

The SDC, RUSL has also proposed to organize several workshops and training program for academics and non-academics in the year 2021. The major program will be the CTHE which is to be started in early 2021. In addition to that the training for academic department heads and executive officers will also be continued as an annual program in 2021. Staff development activities for 2021 will be planned to provide career development opportunities for both academic and non-academic staff members.

28. COMPUTER CENTER

A. Introduction

The Information Technology Centre of Rajarata University of Sri Lanka was established along with the establishment of the university in 1996, in view of enhancing ICT skills of undergraduates. The center was administered directly by the vice chancellor and its functions were supervised by a director appointed by the vice chancellor. The Information Technology Centre initially focused on conducting basic computer awareness programs for undergraduates of Faculty of Management Studies and Faculty of Social Sciences and Humanities. As the university expanded, the Information Technology Centre became the prime ICT service provider of the university. Since the initial scope of the center had been expanded, and to reduce the administrative burden, starting from 2011, the council of the university appointed a director to look after academic and administrative matters. The director is an academic member with sound knowledge in ICT. The term of the director is three years.

The center opens from 8:00 am to 6:00 pm during week days and from 8:00 am to 4:00 pm on Saturdays. Apart from the normal opening hours, on special requests, with the approval of the vice chancellor, the center opens till 8:00 pm during study leave and examination periods. The staff of the Information Technology Centre consist of an Instructor in Computer Technology, a Systems Analyst, an Asst. Network Manager, a Technical Officer, a Lab Attendant and a Laborer

Resources and Services

Computer Laboratories

The Information Technology Center maintains two main computer laboratories each having 100 modern personal computers. One laboratory is reserved for conducting lectures and demonstration sessions related to ICT subjects. The other laboratory is available for undergraduates for their study related activities.

Video Conference Unit

A dedicated video conference system was installed at Information Technology Centre so that any academic or administrative officer can make use of it to remotely participate in official events provided that other party has facilities to connect remotely.

Computer Maintenance, Assembling and Repairing Unit (CMAU)

The CMAU runs under the supervision of the Director/ Information Technology Centre. Repair of IT equipment such as Computers, UPS Devices and Printers are undertaken. Software installation and troubleshooting services are also provided. Two technical officers have been assigned on temporary basis to carry out duties and they are working after normal duty hours and weekends.

Internet and Intranet Services

LEARN is the main ISP of the University and the subscribed Internet bandwidth of Mihintale premises is 400 Mbps. A high speed fiber optics backbone has been laid to cover most of the buildings at Mihintale premises. Inside the buildings, UTP cables have been laid and connected them to the main backbone via LANs. Other than newly constructed buildings and few lecture halls, the Information Technology Center has provided Internet and Intranet facility.

B. Achievements

Information Technology center was able to facilitate all related academic works of the faculties situated Minintale premises in the year. Apart from the providing infrastructure facilities, the existing computer

laboratories were upgraded by replacing 25 computers with new machines in order to provide an efficient service.

1. Started Certificate in ICT and Diploma in ICT extension programs having 77 and 110 students each.
2. Computer Maintenance and Assembling Unit (CMAU) performed its duties as usual.
3. WiFi facilities were provided for New Pandula I, New Pandula II and Somadevi student hostels.
4. Wi-Fi and cabling network of Faculty of Social Sciences and Humanities was completed up to around 80%
5. Even though the university is closed for physical access due to COVID-19, we have implemented the Zoom Video Conferencing facility with the help of LEARN from April 2020. Zoom is providing all the necessary tools to access learning and research curriculums online, allowing remote working for an extended period with minimal disruption to operations.

C. Future Plans

1. Shifting server room from the administrative building to the building presently Information Technology Center established.
2. Getting separate entrance to the IT center.
3. Creating a new website for the University.

29. Centre for Quality Assurance

A. Introduction

The Internal Quality Assurance (IQA) is streamlined under the Centre for Quality Assurance (CQA) and Internal Quality Assurance Cells (IQACs) and are guided by the by-laws on IQA activities, which are in line with IQA Manual (2013). IQACs are being revamped to extend their role across all possible spheres of work with a view of enhancing quality. Each activity will be a responsibility of a member of the IQAC and she/he carries out the functions with a working committee approved by the Faculty Board or CDCE, to make the functioning more efficient and to involve as many staff in all sectors in IQA. CQA has taken the lead of preparation of several policy documents such as Quality Assurance and Enhancement Policy, Curriculum Development Policy, Human Resource Development Policy, Student Assessment Policy. It is also in the process of preparing several other policy documents. CQA takes the initiatives and guides the processes of External Quality assurance (EQA). The CQA Faculty coordinators and Deans of the Faculties are responsible for IQA within Faculties. The IQAC of CDCE also operates in a similar mode, Director/ CDCE replacing the Dean. The management committee has been converted to the Senate Standing Committee of the CQA chaired by Vice-chancellor. CQA matters appear as a different item in the Senate that is documented under Centers and Units of the university.

30. University Business Linkage Cell

A. Introduction

The University Business Linkage Cell of the University of Rajarata was established in 2018, through the initiative of the University Grants Commission (UGC) Circular No 10 /2016 funded by AHEAD Accelerating Higher Education Expansion and Development which is a World Bank-funded Sri Lankan government operation to support the higher education sector. The cell functions directly under the Vice-Chancellor. It is located on University main premises at Mihintale as each faculty has quick access. It is on the ground floor senate building, next to the CDCE unit. The cell well functions under the director, manager, UBL Advisory board, and supported coordinators from each faculty.

Current Director of UBL Cell is Prof. (Mrs) G.A.S Ginigaddara and under her a UBL Manager Mrs. E.N Liyanage and a UBL Trainee, Ms. R.R Mohamed on contract basis are employing as the cell staff.

With the guidance of UBL Director there are six number of faculty coordinators from each faculty to smoothen the collaboration and communication of faculties with the UBL Cell. To advise the UBL Cell there is a UBL Advisory board which include Vice Chancellor, industrial representatives as well as faculty deans and University administrative staff.

B. Achievements

Faculty Awareness Sessions

Awareness programs about UBL were organized and conducted at the faculty level throughout 2020 and separate sessions were there for faculty staff and students. That was a successful session series since the university community could obtain a much broader idea on University Business Linkage Cell.

Five number of awareness sessions were conducted in five faculties (Agriculture, Management, Social Sciences, Technology and Applied Sciences) with total of 250 students and academic staff participants.

Startup Weekend

The program was organized basing the courses, Entrepreneurship (ICT 3208) and Entrepreneurship Development (IDC 3201) of the Faculty of Applied Sciences with 30experts identified by the faculty including 4 experts from the European Union. Selected 80 students participated in this 03-day program. #StartupweekendRajarata University Edition 2.0 Systemized on 6th, 7th and 8th March 2020, accumulated enthusiastic young expertise students, split into teams with 54 hours of teamwork.

StartupXfoundry Collaboration

To promote RUSL commercializable research outcomes locally and internationally, the StartupXfoundry organization collaborated with signing an MOU with RUSL through UBL. StartupXfoundry is working with the European Union – Sri Lanka Innovation Partnership project (EU-SLIP) programme to figure out ways to build the capacities of UBLCs launched the first virtual workshop for UBL Staff on creating impactful university - business collaborations held on 6th November 2020 from 1.00 PM to 4.30 PM. The idea here was to understand how UBLCs/TTOs can engage with corporates and other businesses while drawing inspiration from successful engagements that took place in Germany, Lithuania, and India. Also, this programme was the precursor to a larger project that they intend to launch to facilitate UBLCs to create collaborations between Sri Lanka and the EU.

North Central Province Chamber of Commerce, Industry and Agriculture Collaboration

NCPCCIA and RUSL collaborated through UBL finalized an MOU to have industrial collaboration shortly

Startup Webinar Programs

01.NOTES TO THE FINANCIAL STATEMENTS

1.1 CORPORATE INFORMATION

Rajarata University of Sri Lanka is a fully Government owned higher educational institute established under the Universities Act No 16 of 1978 and subsequent amendments thereto. Rajarata University of Sri Lanka currently operates with six faculties and situated in North Central Province, Anuradhapura district, in Sri Lanka.

1.2 BASIS OF PREPARATION

The Financial Statements of the Rajarata University of Sri Lanka have been prepared on accrual basis and under the historical cost convention unless stated otherwise. The Financial Statements are presented in Sri Lankan Rupees (Rs), which is the University functional and presentation currency and all values are rounded to the nearest rupee value.

The significant accounting policies are disclosed in note 1.3 and 1.4.

The Statement of Financial Position, Statement of Financial Performance, Statement of Changes in Equity and the Cash Flow Statement together with the accounting policies and notes have been prepared in compliance with the Sri Lanka Public Sector Accounting Standards (SLPSAS) issued by the Institute of Chartered Accountants of Sri Lanka and the requirement of the Universities Act No 16 of 1978 and subsequent amendments thereto.

The net financial result of the ordinary course of business of the University for the year under review is shown in the Statement of Financial Performance. All assets and liabilities of the University are shown in the Statement of Financial Position. In addition, the Cash Flow Statement includes the cash inflows and outflows of cash and cash equivalents of the University.

1.3 ACCOUNTING POLICIES

1.3.1 APPLICATION OF SLPSAS

The University has followed the Sri Lanka Public Sector Accounting Standards (SLPSAS) when preparing and presenting financial statements for the year 2020. In this contexts, all SLPSAS mentioned in the Statutory Report have been followed unless stated otherwise.

1.3.2 CHANGES IN ACCOUNTING POLICIES

The University has adopted the Public Sector Accounting Standards when preparing and presenting the Financial Statements of the University unless stated otherwise. No significant changes in accounting policies have been taken place during the year under review.

1.3.3 SIGNIFICANT ACCOUNTING JUDGEMENTS, ESTIMATES AND ASSUMPTIONS

Preparation of the Financial Statements of the University requires the management to make Judgements, Estimates and Assumptions, which may affect the Income, Expenditure, Assets, Liabilities and disclosure of Contingent Liabilities, as at the end of the financial year. When applying the accounting policies the key assumptions made relating to the future estimates and other aspects are discussed below.

1.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1.4.1 FOREIGN CURRENCY TRANSACTIONS AND BALANCES

All foreign currency transactions recognised to functional currency at the rates of exchange rates prevailing at the time the transactions occurred. Monetary assets and liabilities denominated in foreign currency are translated to functional currency (Rupees) at equivalent exchange rates prevailing as at 31/12/2020. The balances of Residential Foreign Currency (RFC) account as at reporting date recognised into functional currency at the rates of the same date. The gain/loss recognized on foreign currency is shown separately in the note no 31 and net result credited to the respective fund account separately.

1.4.2 TAX

Income tax

University is not liable to pay income tax on its income of the ordinary course of the business according to the prevailing tax regulations.

PAYE tax

University currently remits PAYE tax deducted from monthly salaries of the employees who are liable for payment of income tax which are not a part of the University expenditure. Hence, payment of PAYE tax is not accounted in the separate accounts of the University.

1.4.3 PROPERTY ,PLANT AND EQUIPMENT (PPE)

LAND, BUILDINGS, MOTOR VEHICLES & OTHER CATEGORIES OF PPE

The SLPSAS 07 requires an entity to review the residual value and the useful life of an asset at least at each annual reporting date and, if expectations differ from previous estimates, the change (s) shall be accounted for as a change in Sri Lanka Public Sector Accounting Standards an accounting estimate in accordance with SLPSAS 3, Accounting Policies, Changes in Accounting Estimates and Errors.

DEPRECIATION

Depreciation is calculated by using straight-line method at following rates on the cost or revaluation value of all Property, Plant and Equipment, books and periodicals and cloaks.

1.4.4 BIOLOGICAL ASSETS

The treatment for the biological assets has been made in terms of SLPSAS 18, Agriculture. Biological assets of the University shown as a separate asset in the Statement of financial position. Biological assets are measured on initial recognition and at subsequent reporting dates at fair value less estimated point of sale costs, unless fair value cannot be reliably measured. The gain on initial recognition of biological assets at fair value, and change in fair value of biological asset during the period in net surplus/deficit.

1.4.5 SHORT TERM INVESTMENTS

The University has invested its unutilised funds that were received for research, projects and other ancillary activities temporally on term deposits at the State Banks on the competitive interest rates. The interest accrued for same has been adjusted to the respective ledger accounts and shown as income in the statements of financial performance. Similarly, the funds received for scholarships and medal awarding have also been invested in term deposits at the State Banks. Further, details on investments and interests income on investments are disclosed in note 13.

1.4.6 INVENTORIES

Inventories of the University have been physically verified and valued at cost on First in First Out basis (FIFO) as at 31st December 2020. The inventory of the University classifies mainly in to Stationery, Building materials, Chemicals and glassware and other inventories. The cost of chemicals and glassware purchased from research grants are fully charged to the respective research grants as expenditure at the time of purchasing. However, material inventory balances remained at the end of the year as per the physical verification reports have been adjusted to the respective accounts.

Further details on inventories are disclosed in Note 09 of the Accounts

1.4.7 TRADE AND OTHER RECEIVABLES

Trade and other receivables are stated at the estimated amount as per SLPSAS 01 that it is due to be received within twelve months after the reporting date. No provision has been made for bad and doubtful receivables and payments.

1.4.8 CASH AND CASH EQUIVALENT

Cash and cash equivalents are disclosed in the statement of financial position and the cash flow statement comprises balances of Current and Residential Foreign Currency (RFC) accounts. Further details on cash and cash equivalents are disclosed in the Note No 2 of the statement of accounts.

1.4.9 GRATUITY

The liability recognised in the statement of financial position is the present value of the gratuity obligation calculated according to the Projected Unit Credit Method indicates in the SLPSAS 19, Employee Benefits. According to the Commission Circular 05/2019 Academic allowance and Compensatory allowance were also considered for gratuity provision as at 31/12/2020. The payment of gratuity is made according to the provisions stipulated in the Gratuity Act No 12 of 1983.

1.4.10 UNIVERSITY PROVIDENT FUND AND EMPLOYEES' TRUST FUND

Employees of the University are entitled for University Provident Fund (UPF) contributions and Employees Trust Fund (ETF) contributions in line with respective statutes and regulations. The University contributes defined percentages of (15%) and (3%) on gross emoluments of employees to an approved employees' provident fund and to the employees' trust fund respectively, which are operated externally.

Further, Employees' pension scheme is also operated as a retirement benefit to the University employees in contributing 8% to the pension fund from the University.

1.4.11 GOVERNMENT GRANTS

Government grants for capital and recurrent expenditure recognised only when they are received by the University keeping in line with the provisions of the SLPSAS 01. The recurrent grant received for the year has been recognised as income in the statement of financial performance and capital grant received by the University has been recognised and accounted in the capital accounts through capital grant spent and unspent accounts and the effect of that are directly incorporated with the statement of financial position.

1.4.12 PROVISIONS FOR CONTINGENT LIABILITIES

Provisions are recognised when the University has a present obligation as a result of a past event and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligations and reliable estimate can be made of the amount of the obligation. No provisions for contingent liabilities have been made as there were no cases where the legal obligations have been accurately estimated. Therefore, the liabilities in connection with the legal cases for which the financial obligations are not estimated clearly and exactly are shown as a note and all the adjustments and disclosures are made in keeping with the provisions of the SLPSAS 08. The contingent liabilities in connection with legal cases instituted against the University as at 31st December 2020 are amounting to Rs. 38.5 million. However, the amount of compensation cannot be estimated reliably and thus no provisions have been made the financial statements.

The details of contingent liabilities are given in Annex – 01.

1.4.13 CONTINGENT ASSETS

The details of contingent assets are given in Annex – 02.

1.4.14 REVENUE RECOGNITION

The Government grant for recurrent expenditure and income from research grants, projects and other academic assignments have been recognized as revenue when they received and all other revenues are recognised on an accrual basis.

1.4.15 EXPENDITURE RECOGNITION

Expenses are recognised in the income and expenditure statement on the basis of a direct association between the cost incurred and the earning of specific items of income. All expenditure incurred in running of the University and in maintaining the properties in a state of efficiency has been charged to the income and expenditure statement.

1.4.16 ACCELERATING HIGHER EDUCATION EXPANSION AND DEVELOPMENT PROGRAM (AHEAD)

During the year ended 31st December 2020, University has received totalling of Rs. 62,533,160.00 and out of which amounted to Rs. 63,888,791.76 has been incurred for the purpose of the project and the balance money of the project was remained in the bank account operated by the University. The accounts of the project were maintained separately under the supervision of the ministry and UGC and which were not associated with the University accounts.

1.1.18 SCIENCE AND TECHNOLOGY HUMAN RESOURCES DEVELOPMENT PROJECT

The project funded by Asian Development Bank will support the university in developing the technology faculty to nurture a new breed of technology-oriented graduates equipped with market relevant skills and entrepreneurial spirit. It will address lack of financing for priority degree programs, which are in high demand from students and industry. The project will provide innovative and industry-relevant technology education and research facilities, help quality curriculum design and academic staffing aligned with international standards, and provide competitive grant scheme and capacity development opportunities. The total amount of the grant is 25.0 million US dollars and out of this LKR. 147.0 million was spent in 2020 to purchase equipment and to conduct workshops and for the faculty of Technology. Total expenditure of the project up to now is LKR.197.0. Since these assets are under the project not include in this financial statement.

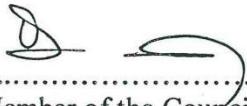

Report of the Auditor General on the Financial Statement of the Rajarata University of Sri Lanka for the year ended 31st December 2020 and the other legal and regulations required for that in terms of section 12 of the National Audit Act, No 19 of 2018.

1. FINANCIAL STATEMENT

1.1. QUALIFIED OPINION

The Audit of financial statements of the Rajarata University of Sri Lanka for the year ended 31st December 2020, comprising the statement of financial performance, statement of the change in equity, cash flow statement for the year ended, summary of the significant accounting policies and other explanatory information of financial statements for the year ending 31st December 2020 was carried out under my directions in pursuance of provisions in the article 154 (1) of the constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with No 19 of 2018 National Audit Act and No 38 of 1971 Financial Act. This report would be tabled at the parliament in due course in accordance with the 154 (6) of the constitution.

The Financial Statements of Rajarata University as at 31st December 2020 and the statement of financial performance and the cash flow statement for the year ended have indicated true and fair state in accordance with the Sri Lanka Public Accounting Standards is the my opinion except the matters affected explained in the basis for qualified opinion in my report.

1.2. BASIS FOR QUALIFIED OPINION

- (A) In accordance with the para 65 of No 07 of Sri Lanka Public Sector Accounting Standards, although the value amounting to Rs. 540,145,707 Assets have been 100% depreciated, the Assets are still utilizing due to non - reviewing the effective life of the noncurrent Assets annually. Therefore, the estimated error has not been revised in accordance with the No 03 of Sri Lanka State Accounting Standards even during the reviewing year.
- (B) In accordance with the para 15 of Sri Lanka Public Sector accounting standards 09, the stocks have to be measured to the lowest value of either the cost or the net realization value, whereas the total value of Rs. 5,194,264 stocks which was expired and beyond usage have been added to the stock cost and accounted.
- (C) An amount of Rs. 18,540,803 to be recovered from a senior lecture of the reviewing year who had left the service due to violation of bond has not been accounted.
- (D) The direct credit total of Rs. 2,799,794 which has been credited to the University bank account for a period of 01 to 04 years, has been included in the miscellaneous deposit without being correctly identifying and accounting.
- (E) An amount of Rs. 1,805,250 of examination paper inspection fee of the year 2019 has been accounted as reviewing year expenditure instead of adjusting to the previous year profit, thereby increasing the deficit by the same amount showed in the financial statements.
- (F) Total value of Rs. 70,979,225 of completed and currently using building accounted as working-in-progress instead of accounted as property, Plant and equipment in the non-current

assets, due to this, the value of working- in-progress has been increased by the same amount and decreasing the value of property Plant and equipment by the same amount have been shown in the financial statements and also the depreciation value of the building of Rs. 4,370,534 and Rs. 6,413,200 for relevant to reviewing and previous years respectively have not been accounted.

The auditing has been carried out in accordance with the Sri Lanka Auditing standards. Further to the responsibility under these auditing standards has been explained in the responsibility of an auditor in relation to the auditing of the financial statements. I have faith that the auditing evidences obtained were sufficient and appropriate for the making basis to my qualified opinion.

1.3. OTHER INFORMATION INCLUDED IN THE 2020 UNIVERSITY ANNUAL REPORT

The other information means that the information which has been included in the annual report of the year 2020 which is expected to be handed over to me after the date of audit report and the same information not been included in the financial statements and the Audit Report. The management is responsible for this other information.

The other information does not cover from my opinion given with regard to the financial statements and do not authenticate or state any opinion to that effect.

According to the auditing of the financial statements, my responsibility is to read the identified other information received and by doing so the knowledge obtained through other financial statement, auditing or other means to see the in appropriateness in quantitatively.

When reading the university Annual report 2020 , if I conclude that there are qualitative errors, those matters shall communicate to the controlling authority for correction. Further, those errors are existing without correction, those would be included in the report which is table at the parliament in due course in accordance with the 154 (6) of the constitution.

1.4. MANAGEMENT'S AND ADMINISTER'S RESPONSIBILITY REGARDING THE FINANCIAL STATEMENT

The management is responsible for the preparation and fair presentation of these financial statements in accordance with the Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements whether due to fraud or error.

It is the responsibility of the management to decide whether to continue of maintaining the University when preparing the financial statements. If the management is in the opinion of that the University of Rajarata to be handed over to the government or lease the operation when there is no alternative for except that, the accounts should be maintained on the basis of continuance and the disclosure of the matter whether to maintain the university continuously is also the responsibility of the management.

The responsibility of the financial reporting process finance should be taken by the Governing authority of the university.

In accordance with the sub – para 16 (1) of No 19 of 2018 National Audit Act, the university should maintain the books and record of all income, expenditure, assets and liabilities in order to enable the preparation of annual and timely financial statements of the university.

1.5 **AUDITOR'S RESPONSIBILITY TOWARDS THE AUDITING FINANCIAL STATEMENTS**

As a whole, an audit involves performing procedures to obtain audit evidence about the amounts and disclosure in the financial statements. It is intended to give reasonable opinion as the financial statements do not reflect true and fair picture due to fraud and errors.

When carrying out auditing according to the Sri Lanka Auditing standards, it always does not mean that qualitative disclosure about the financial statements could confirm. Further, the economic decision taken by following this report definitely could affect their decision.

I have been carried out auditing with the professional judgment and suspiciously according to Sri Lanka Auditing Standards. Furthermore,

- ❖ When finding a base to declare the audit opinion, whether due to fraud or error in making those risk assessments, including the assessment of the risk of material misstatements of financial statements. This could be stopped by adopting sufficient and appropriate suitable audit evidences. The damage to the fraud is higher than the damage caused by misrepresentation when those preparation of fake documents, ignoring purposely, misrepresenting or the ignoring internal controls.
- ❖ In order to planning the suitable periodically auditing system, study carried out about the internal control of the university not to give an opinion about the effectiveness of the internal control.
- ❖ It has been appreciated that adopting of reasonable accounting policies and estimates and the relative disclosures by the management.
- ❖ In order to consider the continuance of the university activities due to the incidents and reasons through the audit evidence obtained, it is decided to adopt the basis of continuance process for accounting. If there is a reasonable doubt the basis of continuance in operation, it should be disclosed in the final statement and if those disclosures not enough the auditor's opinions to be highlighted. However, continuance in operation would be closed due to future incidents and situations.
- ❖ The presentation of financial statements with disclosures structure and content were appreciated. The transactions and the incidents for those affected have been included in the final statements.

Identified the important audit observations, main mistakes in the internal control and other weaknesses informed to those who control the activities.

2. REPORT ON OTHER LEGAL AND REGULATIONS REQUIREMENTS

2.1 The special provisions have been included for the following requirements in the No 19 of 2018 National Audit Act.

2.1.1 As per the requirement of clause 12 (A) of No 19 of 2018 National Audit Act, I have obtained all other details and information for my auditing and it is my opinion that the University is maintaining proper financial report.

2.1.2 As per the requirement of clause 6 (i) (B) (iii) of No 19 of 2018 National Audit Act, the financial statements forwarded by the University is agreeable with the previous year.

2.1.3 As per the requirement of clause 6 (ii) (B) (IV) of No 19 of 2018 National Audit Act, the recommendations made in the previous year have been included in the forwarded financial statements.

2.2 There was no attention to express anything below due to the fact that the process followed, obtained evidences and limit to the important matters etc.

2.2.1 As per the requirement of section 12(D) of No 19 of 2018 National Audit Act except the following observation, a council member of University could directly deal with the same agreement or otherway if the connection deviation from the normal activities.

2.2.2 As per the requirement of section 12 (E) of No 19 of 2018 National Audit Act except the following observation, action has not taken in accordance to the relevant written Laws or the special or common orders issued by the council.

REFERENCE TO LAW, RULES AND REGULATIONS

OBSERVATIONS

(A) Financial regulation of the democratic
Socialist Republic of Sri Lanka
Financial regulation 571

Actions have not been taken according to the financial regulation regarding the tender deposit of Rs. 2,297,392 from year 2012 to 2017 and contract and miscellaneous retention money total Rs. 68,157,974 from 02 to 16 years.

(B) 3.1 para of XX chapter of university
Establishment Code.

Though, all employees in the higher Education institutions shall mark the arrival and departure times, the academic staff had not done so.

(C) 2 b para of 2015 July 14 No 3/2015
Public sector finance circular

Maximum of Rs. 100,000 advance could be given for a special activity to an executive officer where as advances from an Rs. 106,386 to Rs. 150,000 have been given in 03 occasions.

2.2.3 As per the requirement of the section 12 (h) No 19 of 2018 National Audit Act, the university has acted not according to the university authority, performance and the power.

2.2.4. According to the requirement of section 12 (h) of No 19 of 2018 National Audit Act, except following observations, the university has not utilized its resources efficiently, effectively

and carefully not following the procurement procedure in accordance with the rules and regulations periodically.

2.3 **OTHER MATTERS**

- (A) In order to establish an Engineering faculty for Rajarata University, an amount of Rs. 6,120,913 has been spent from university fund for planning, preparing subject syllabus and miscellaneous expenses from the year 2014. The secretary /University Grants Commission has informed the Vice Chancellor on 24th December 2019 to withhold the implementation of the project to establish an engineering faculty since the university has not prepared a special syllabus excepting a traditional syllabus. Further, according to the IV sector, section 21 (D) of No 16 of 1978, though the minister could hand over the faculty to university after consultation the commission, the minister's opinion to establishing of an engineering faculty has not been forwarded for auditing. Thereby, the amount spent from university fund has become a non-productive expenditure.
- (B) An accumulated amount of Rs. 2,662,233 given for eleven lectures as research grants have not been settled within the period of 90 days as per the 2.10 chapter of university research grants guidelines code. The advances have not been settled from 01st to 13 year up to 31st December of the reviewing year.
- (C) The eight (08) lectures who have taken leave with pay to follow the post graduate have not been completed the post graduate and reemployed. The total bond amounts of Rs. 35,621,947 of the eight (08) lectures have not been recovered until end of the reviewing year.
- (D) The bond amount of Rs. 411,844 to be recovered from a lecture who has left the service from 2016 and the bond amount of Rs. 3,784,401 to be recovered from a lecture who has taken academic leave to follow the degree of philosophy and whose service has been terminated due to not completing the degree have not been recovered until end of the reviewing year.
- (E) An amount of Rs. 7,108,000 was to be credited to the university fund by the central province council for data computerizing, analyzing and reporting the event of which the education division of social science faculty of the university with the collaboration of central province council organize the “.u” project has been credited to 03 officer's personal accounts and in that Rs, 150,000 has been included for using the laboratory facilities of the university.
- (F) Action has not been taken to settle the 49 miscellaneous creditors balance of Rs. 12,199,822 more than three years old and three balances of Rs. 3,782,650 of supply creditors during the reviewing the year.
- (G) Action has not been taken either to settle or credit to the university fund of the balance of Rs. 1,018,727 of 07 research project after completion of the research work more than two years.

The Auditor General's report dated 06th August 2021 was received by the University on 16th August 2021 for which clarifications and action taken already for the observations made in the report are listed below as per the sequences in the audit report.

1.2. THE BASIS FOR OPINION

(w)' Work – in – progress in order to establish the computer information system and one of the module of same is maintaining a fixed assets register. The existing assets need to be re- valued for this purpose and preliminary works such as identification, preparation of documents and coding have been completed. As instructed by the officer from the valuation department, the progress of re- valuation of assets by the valuation committee could not be completed in the year 2020 due to the prevailing COVID 19 epidemic. However, the action is being taken to complete the same during the year 2021.

(wd). These items do not value on net realizable value for this and value on cost basis. The activities will be done by the committee.

(we). Corrected through J/E 2021/066 (Annex 01)

(wE). There are direct deposits done for various activities and after proper identification of those values, action will be taken to adjust to the relevant accounts.

(b). Agreed.

2.1.3. The recommendations submitted by me for the previous year have been included in the Financial Statements in accordance with the requirement of clause (iv) of the 6 (i) we of the No 19 of 2018 National Audit Act.

2.2. There was no proof for my attention to make following statements on the process followed and evidence obtained or limitations to the quantitative matters.

2.2.1. In accordance with the requirements of clause 12 (wE) of No 19 of 2018 National Audit Act, whether the member of university council in respect of an agreement about the university have a directly or indirectly relationship except the normal business.

2.2.2. Except the following observations, in accordance with the requirement of clause 12 (B) of No 19 of 2018, the action has not been taken of any written laws or common or special orders issued by the university council member.

(wd) Action is being taken to pay from previous year retention money to contractors after consultation. A considerable amount has been redeemed from the year 2020 contract retention money. Action is being taken to release the balance amount in the near future.

(we) UNIVERSITY ESTABLISHMENT CODE CLAUSE 3.1 OF XX CHAPTER

01. The committee has been appointed to look after the project matters at the 243rd council meeting held on 20.06.2020.

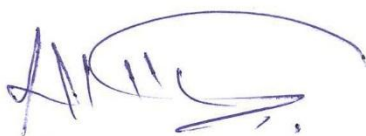
