

**Submission to the Parliament of the observations of the Hon. Minister and steps to be taken under Standing Order 119(4) as to the reports tabled by the Committee on Public Accounts of Parliament**

<b>Shortcomings identified by the Committee</b>	<b>Measures taken by the institution to address shortcomings/ Current progress</b>
<b>Part 1: 95.00</b> In terms of Public Accounts Circular No. 171/2004 dated 11.05.2004, the first, second and third passwords of the computer software relating to the preparation of government payroll had not been changed once in three months.	Necessary action for the change of GSP software passwords has been taken as of now and measures have been taken to make the relevant officers aware to carry out the process up to date.
Contrary to Financial Regulation 94(1), after utilizing the provisions appropriated for an item of expenditure, commitments had been incurred exceeding the limit of remaining provisions.	<p>The relevant liabilities exceeding the limit of provisions could not be prevented as vouchers therefore could not be obtained on time. This situation arose as action was taken with the expectation of transferring the relevant provisions under FR 66 and 69.</p> <p>Measures have been taken to educate the relevant officials to prevent recurrence of such situations in future.</p>
There were loan balances in arrears carried forward for more than a year.	<p>the following measures have been taken for the recovery of advance account loan balances.</p> <p><b>Mrs. W.D.G.C. Sugathadasa (Public Management Assistant)</b></p> <ol style="list-style-type: none"><li>1. The loan balance amount of Mrs. W.D.G.C. Sugathadasa is Rs. 139,900/= and only one installment of Rs.1,399 had been recovered.</li><li>2. As she has left the country without prior notice, the matter relating to the recovery of the loan balances has been referred to the Attorney General's Department and action has been taken to constitute legal proceedings against her.</li><li>3. Having regard to the preceding matters, necessary measures have</li></ol>

	<p>been taken by the Ministry to suspend the granting of loan on insurance policy guarantees and grant loans only on personal guarantees.</p> <p><b>V.P.C. De Mel (Karyala Karya Sahayaka)</b></p> <p>Necessary action is being pursued to recover the loan of Rs. 114,575 obtained by Mr. V.P. Chintaka De Mel. A vacation of post notice has been served on the said officer as he had failed to assume duties in the new office to which he was transferred. Accordingly, the said notice was posted to his personal address. Action is being taken to recover the loan balance with the assistance of the Divisional Secretary of the area in which he is a resident.</p> <p>The loan of Rs. 44,541/- receivable from driver Mr. P.B.S. Kuamra is being recovered in installments of Rs. 5000/- and as of 01 January 2023, it was possible to bring down the loan balance to Rs. 29,541/-.</p>
<p><b>Part Two : 83.00</b></p> <p>Performance agreements incorporating the entire staff had not been prepared.</p>	<p>Necessary measures are being adopted for the preparation of performance agreements in respect of the entire staff.</p>
