The performance reports to be submitted to Parliament for the year under review were not submitted on the due date.	According to the State Finance Circular No. 02/202 dated 28.08.2020, the performance reports of the Ministries, Departments and District Secretariats must be submitted to the Parliament under the prescribed procedures for tabling before 150 days after the end of the financial year. However, due to the COVID 19 pandemic situation in 2020, the date of tabling the performance reports in the Parliament had been extended to 2021.06.30 by the Treasury Secretary's Circular No. PFD/RED/REG/02/CC/01/2021. Accordingly, the performance report for the year 2020 was presented to the Parliament on 29.06.2021.
Staff had been recruited beyond the approved limit.	The issue of staff who had been recruited beyond the approved limit has been referred to the Department of Management Services to be approved as the staff of this Ministry under the F.R 71.

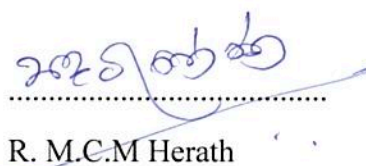
Citizen/client charter was not properly prepared.	In the year 2022, the Citizen / Client Charter has been prepared.
