Even though legal aid has not been introduced as a fundamental right under Chapter 3 of the 1978 Constitution, Articles 12 (1) and 13 (3) of the Constitution have drawn attention towards this matter.

Article 12(1) of the Constitution - All persons are equal before the law and are entitled to the equal protection of the law.

Article 13(3) of the Constitution - Any person charged with an offence shall be entitled to be heard, in person or by an attorney-at-law, at a fair trial by a competent court.

It has further been confirmed by the Rule No.44 of the Supreme Court Rules of Law of Sri Lanka in 1990.

Message of the Chairman



The Sri Lanka Legal Aid Commission, which has passed forty-three years since it started the space for the public to access justice, is passing this time in a background where the country and the people have faced severe challenges.

At a time when socio-economic and political crises, including the Covid-19 pandemic, the economic crisis and political instability, are further marginalizing people, protecting and expanding their access to justice is extremely important. 85 Legal Aid Centers scattered across the country and a Bar Council are working to fulfill their role in the midst of many challenges.

Lack of adequate funds and infrastructure to run legal aid services has become a major problem. The lack of even the required staff and the limitations in their recruitment have also made it challenging to maintain the existing legal aid centers. But at this time when the demand for legal aid services is increasing, our responsibility is very high.

Our staff should be appreciated for their diligent and responsible services despite facing all kinds of challenges that may be faced in the society or as a nation.

As in the previous years, this year also I gratefully recall the support and full sponsorship of the Ministry of Justice for all the activities of the Sri Lanka Legal Aid Commission. It was instrumental in the advancement of the legal aid sector. I am happy to say that the support received from all parties including the staff in this regard is very commendable.

Legal Aid Commission of Sri Lanka incorporated by the **Legal Aid Act No 27 of 1978**

The most provable feature of the Legal Aid Act No 27 of 1978 was to prepare a policy framework of legal aid facilitation to be launched within the country through a formal mechanism for the implementation of legal aid programme.

The establishment and setting up the operation of the Legal Aid Commission of Sri Lanka for the above objectives is the principal function of this Act.

Vision :-

**To facilitate an easy access to equity that would enable
administration of justice to all Sri Lankans.**

Mission :-

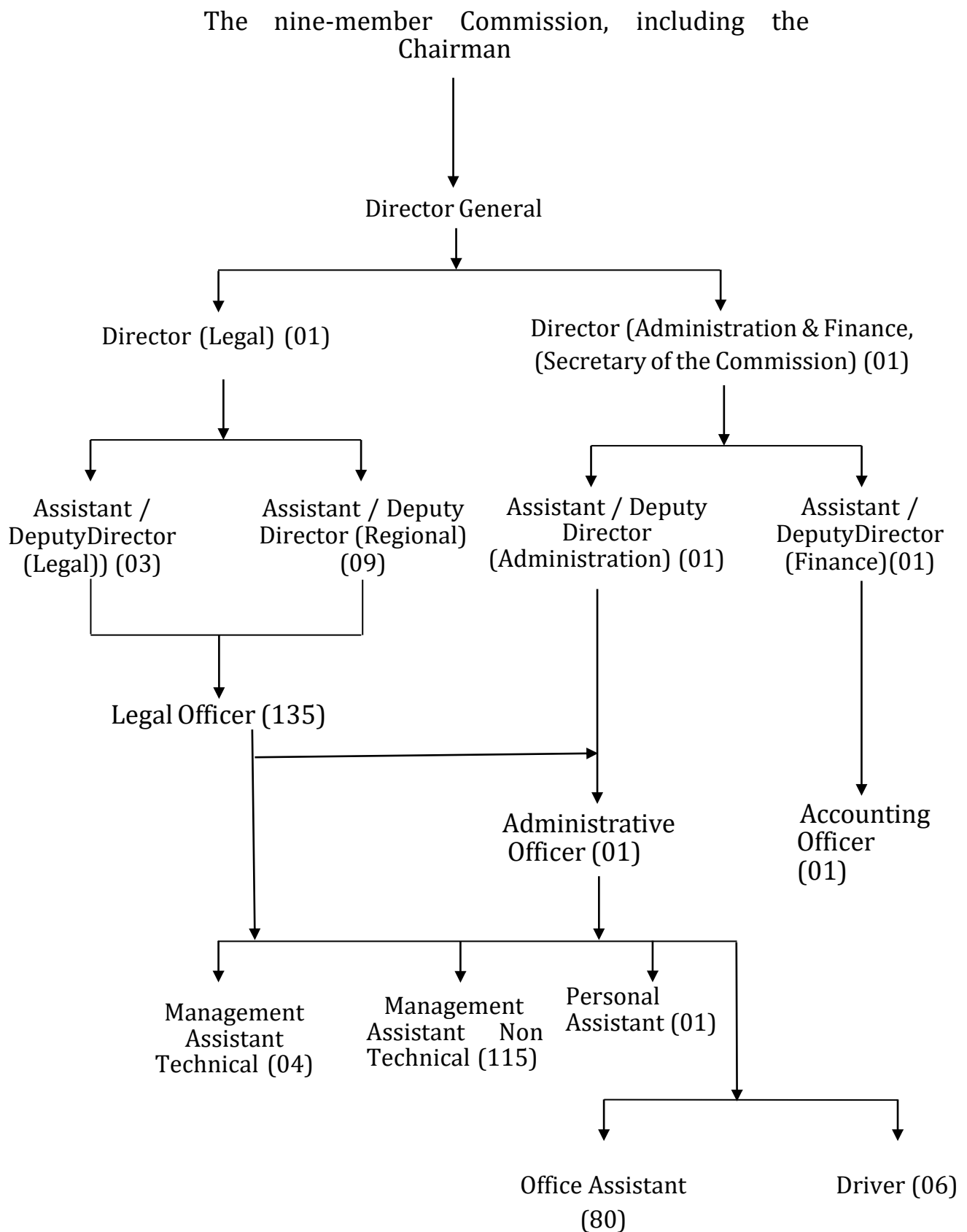
Providing legal aid for the impoverished communities in Sri Lanka who are unable to obtain justice due to poverty, providing free legal assistance to low income people, educating the entire society about the law, engaging in counseling services to the government during legislation of new laws and legal reforms, etc. in order to lead the public towards an easy access to justice.

Objectives of the Legal Aid Act No. 27 of 1978

Sections 3 and 4 of the Act No. 27 of 1978.

1. Providing legal advice to any person of any economic level who deserves assistance.
2. Providing services of attorneys for legal proceedings in the lower income tax tribunal.
3. Establishment of regional offices up to a certain amount that the Commission considers necessary to enable as many persons as possible to obtain legal aid.
4. To decide for which matters or types of cases that legal aid can be provided and determine such matters or types of cases.
5. Determining the outline procedures to follow in relation to the payment of fees and expenses by persons assisted, by taking into account the funds available at the time of which the cases have been resolved or settled and taking all relevant recommendations into consideration.
6. To take necessary action to expand the legal aid scheme through inquiry of the community-based professional, social and other groups that are involved in some aspect of providing government institutions and legal aid.
7. Promote, establish, finance and supervise research related to legal aid.
8. With the intention of raising awareness,
 - i. Educating the members of the legal profession regarding the need for a legal aid scheme and their responsibilities, duties and role in the maintenance and participation thereof.
 - ii. Commencement and implementation of educational programs for the people with special needs regarding their rights, powers, privileges and role, and entire community in general under the prevalent laws of Sri Lanka.
9. Employing the staff required for the establishment, development, implementation of research based programmes, problem solving centers and/or projects regarding a special division or divisions on legal aid provision.
10. Obtaining suggestions from the public for new programs and projects and encouraging them in that respect.
11. To cooperate with educational institutions and boards regarding the education and training of those who provide legal aid.
12. To provide information to the public on the ability to obtain legal aid.
13. Submission of information to legal reforms agencies in Sri Lanka and abroad and the government.

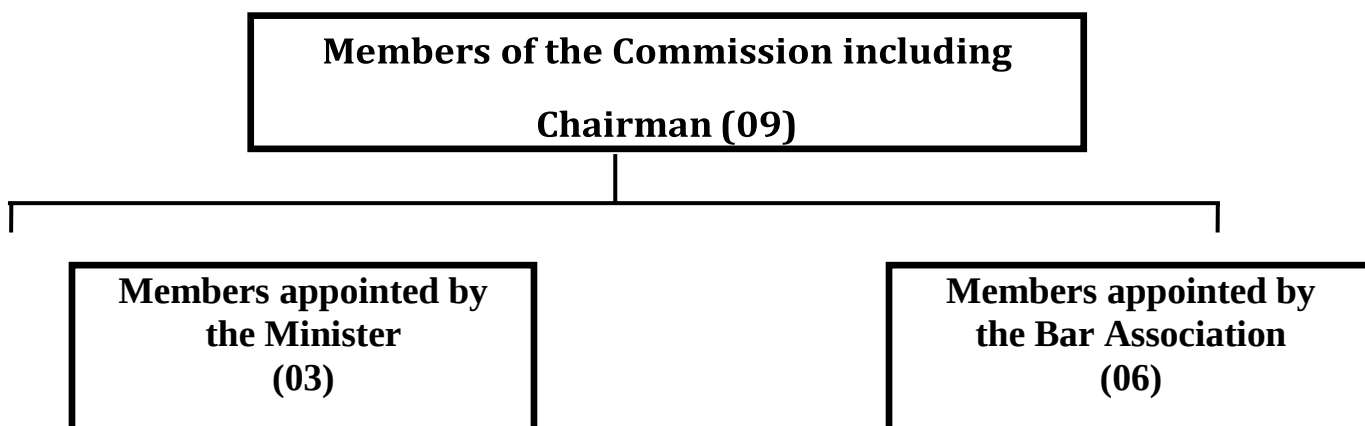
The Legal Aid Commission of Sri Lanka Organization plan

The Legal Aid Commission of Sri Lanka consists of three members appointed by the minister of justice and six members nominated by the Bar Association of Sri Lanka, each of them will be appointed for a period of three years. A member may be re-appointed as a member after the expiration of three years' service period. Also, the work of the Commission is monitored by the Legal Aid Board, which is headed by the Chief Justice. The Advisory Board consists of 30 members constituted by 09 members of the Legal Aid Commission of Sri Lanka, three members nominated by the Bar Association of Sri Lanka, 06 members to represent the Courts nominated by the Chief Justice, and 12 members nominated by the Minister of Justice to be involved in community, neighborhood, professional, social and other groups, which have a connection to the government, provincial bodies, educational institutions and legal aid sections.

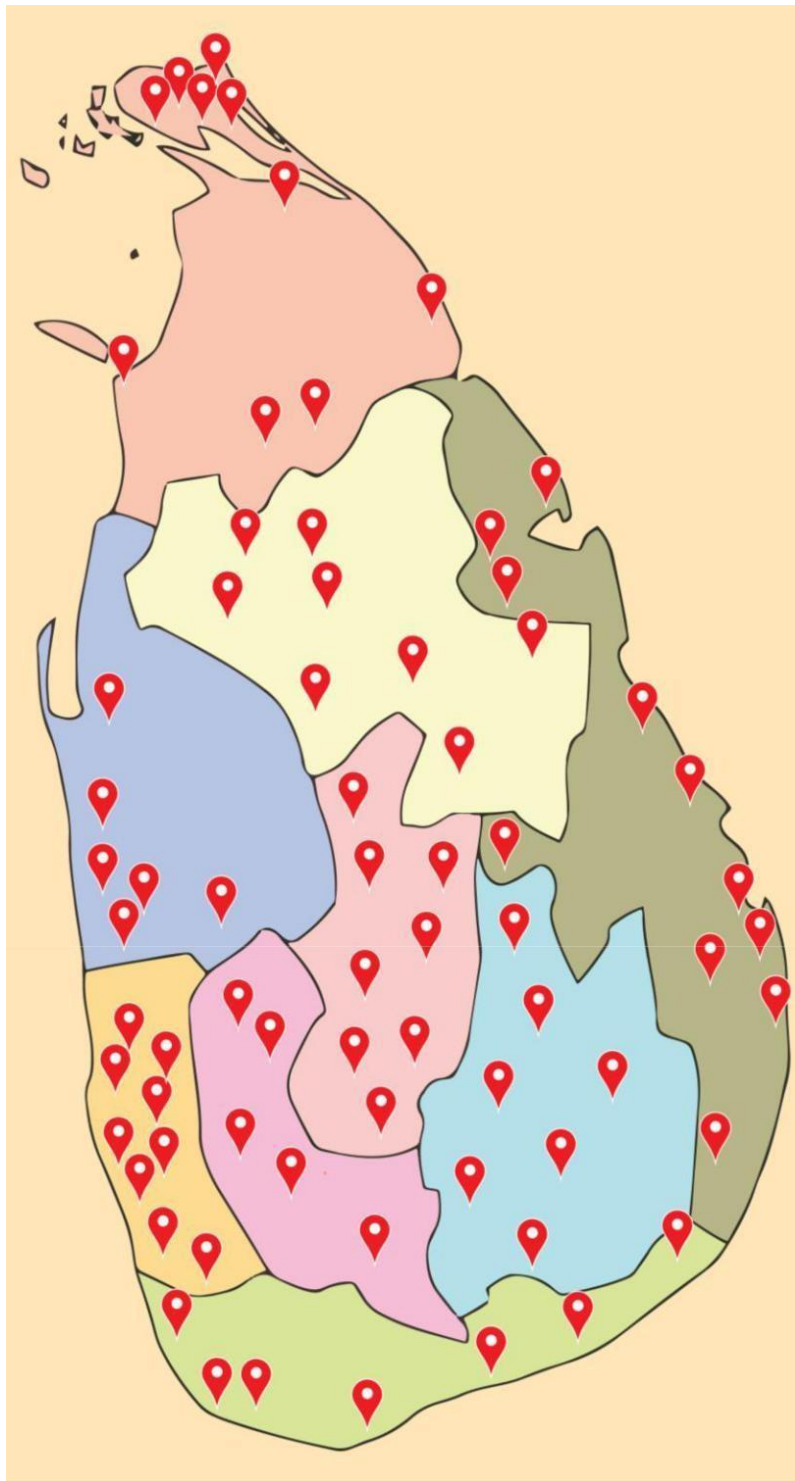
Establishment of Legal Aid Centres

Sri Lanka Legal Aid Commission completes its 44th year by 2022. During the past 44 years, the work was carried out by a network of 84 Regional Offices centered upon Colombo but without being limited to Colombo to achieve the desired objectives of the Commission. 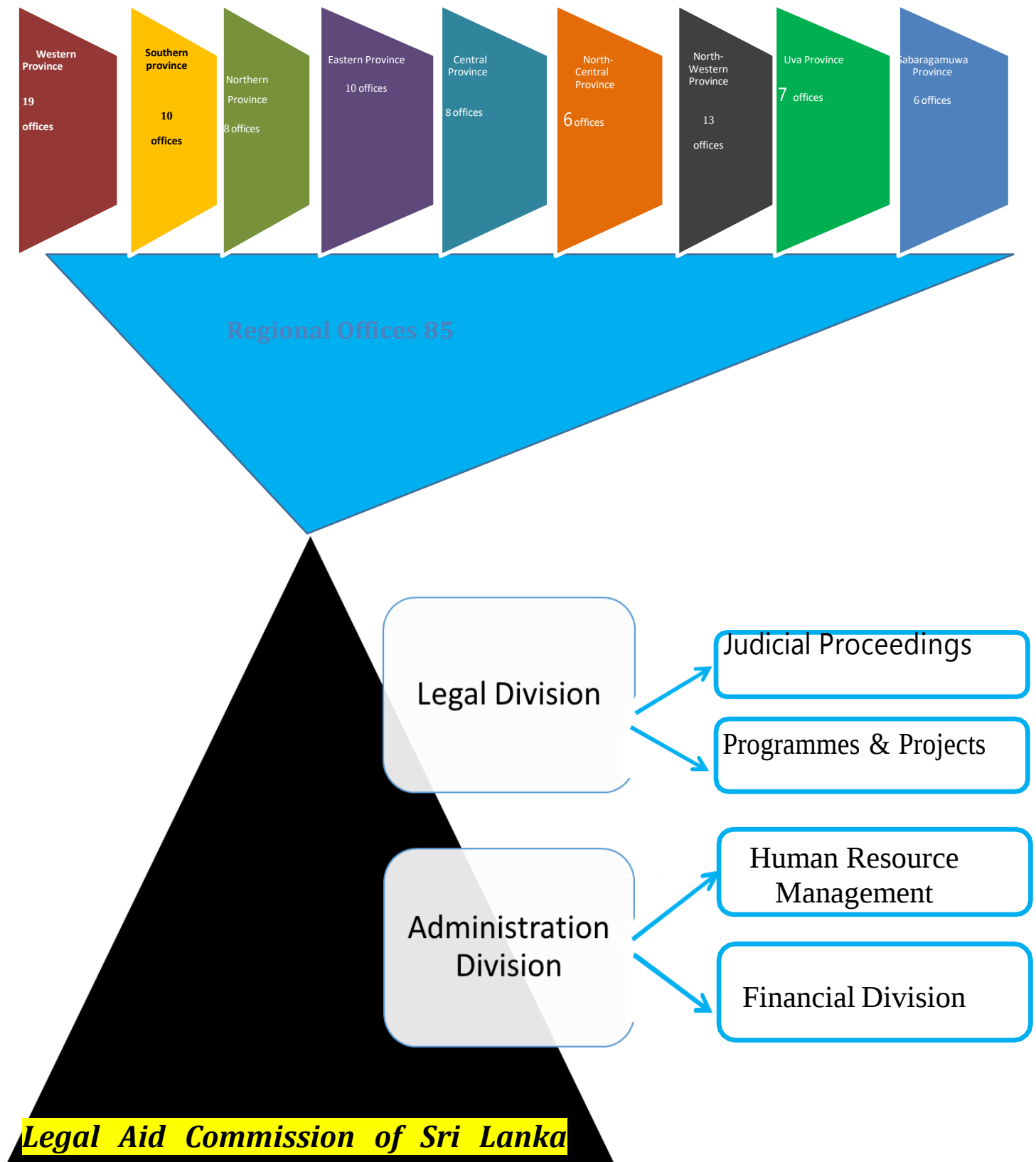

Legal Division

1. Role

Mainly the role of the Legal Division is twofold.

- 1.1 Conducting legal counselling.
- 1.2 Providing free legal assistance for cases of those with low income and incapacity.

Legal Counseling

Legal counseling is done in several ways. Clients who seek this do not necessarily need to come to our offices in person, but still they can turn to the counselling activities.

1. Issues encountered by clients who come in person to the locally established Legal Aid offices will be discussed and clarified and, where necessary, advice will be given on further action as well.
2. Similarly, when various villages or settlements are visited to conduct legal clinics, the legal counseling work is opportunely carried out to the public who reach us.
3. Further, the legal issues of Sinhala readers are answered through Lankadeepa newspaper under the column, "Neethi Sarana", whereas, those of English readers are answered through Daily News newspaper once every two weeks.
4. Legal issues referred through mail by clients will also be replied by the post.
5. Clients who connect through the Legal Aid Commission Hot Line are responded via telephone.

In providing this service, the Legal Aid Commission will not consider the income or the citizenship of the clients. Our legal officers will carry out the necessary legal counselling work regardless of the rank of any person who comes to our office or mobile clinic or anyone who contacts us through phone or postal mail. Hence, this is not an exclusive privilege to be obtained by just one group of individuals based on the economic disparity. This is a service that anyone can obtain.

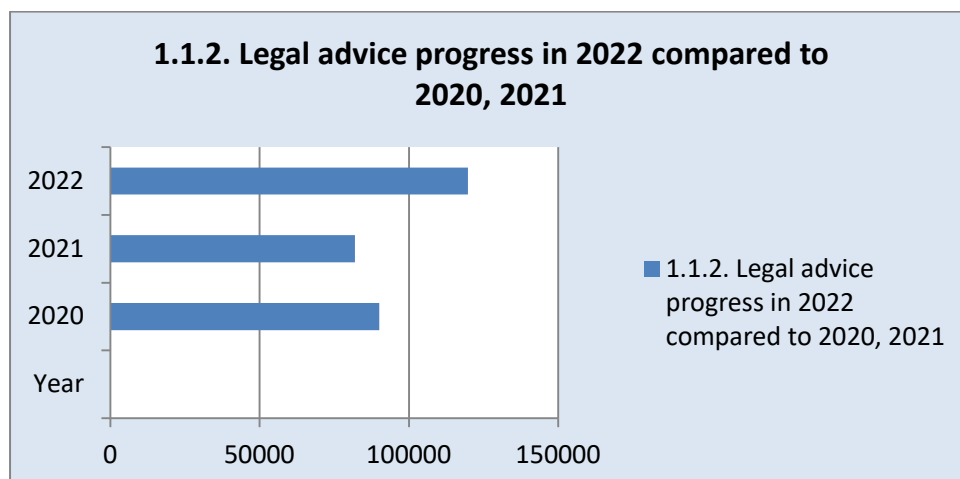

1.1.3. Public Grievance Handling

In this regard, a mandate was given to implement the Public Grievance Management Program implemented by the Presidential Secretariat. Apart from this, public grievances have also been forwarded to the Prime Minister's Office, the Ministry of Justice, the Attorney General's Department and the Chairman of the Sri Lanka Legal Aid Commission and counseling work has been done by mail for a total of 312 public issues.

1.2. Judicial Activities

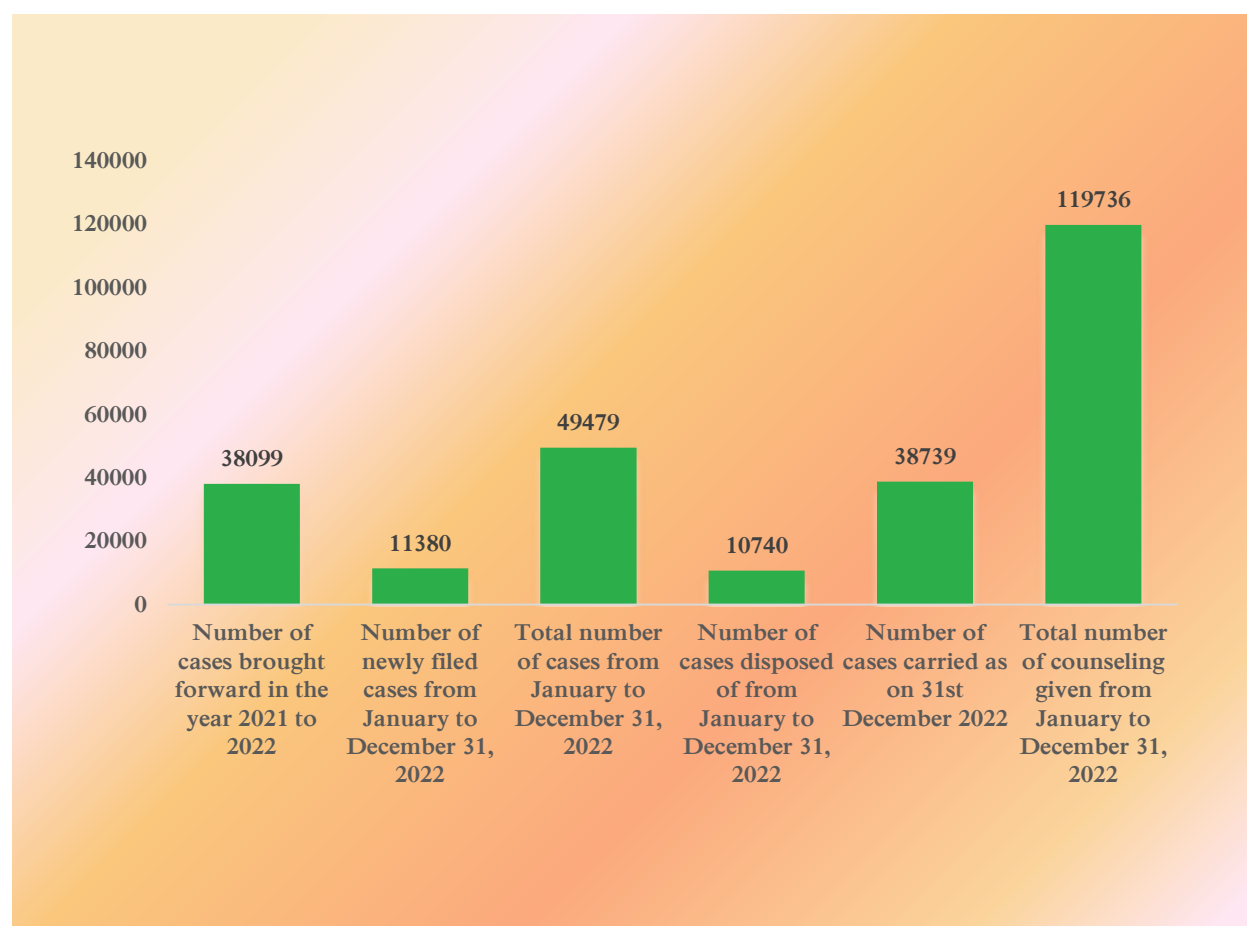
Providing legal assistance for judicial activities of individuals is the most vital part of the Legal Division. It is first examined whether legal aid can be provided for a person at a time when a case needs to proceed in a Court for a legal matter of a person. Through legal counselling, an access to the said purpose can be obtained. In the maintenance of legal aid cases, we first find out whether it is justifiable to provide free legal assistance for this client, and for this, his economic situation will be determined. Accordingly, initially, a report of Grama Niladhari on the monthly income of a person will be summoned.

In this respect,

- 1 The fact whether the relevant person is a low-income person according to the report on his monthly income which is obtained by the Grama Niladhari and countersigned by the Divisional Secretary, will be firstly checked. In such case, if he is proven to be a low income earner as per these reports, he will be provided with free legal assistance in terms of legal aid policies for court proceedings of such persons.
- 2 Is it possible to get the support of any attorney for the case of a person who earns a sufficient income? Will a lawyer be a party to a case? Would a party of one case influence the attorneys and prevent a lawyer representing the other party? At such juncture, the Legal Aid Commission pays constant attention to cooperate with the judiciary as necessary in assisting the administration of justice. In such case as this, the Legal Aid Commission acts in order to offer legal representation irrespective of the income of the party.
- 3 Similarly, even if a person has been in remand for more than one year but will not be able to obtain legal assistance, legal assistance of the Legal Aid Commission will be provided on behalf of such persons.
- 4 For the rights of the child, in cases involving children,
- 5 Action will be taken to grant legal assistance free of charge irrespective of the income of the applicant, for a litigation proceeded under the Maintenance Act and Elders' Rights Act.

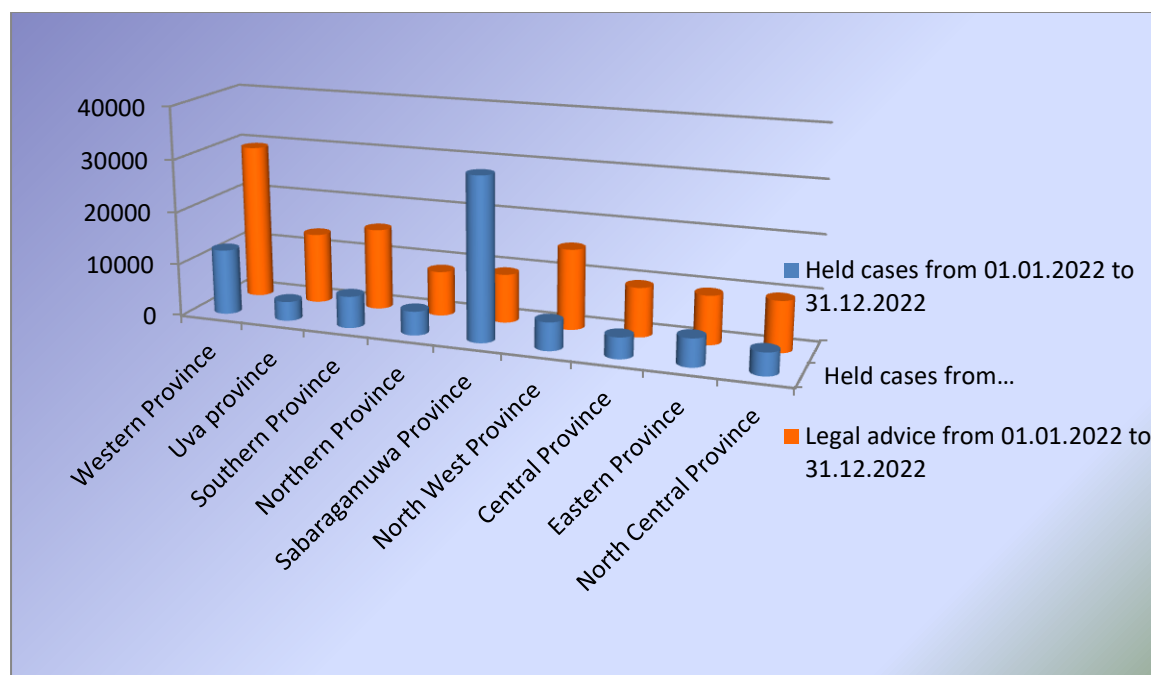

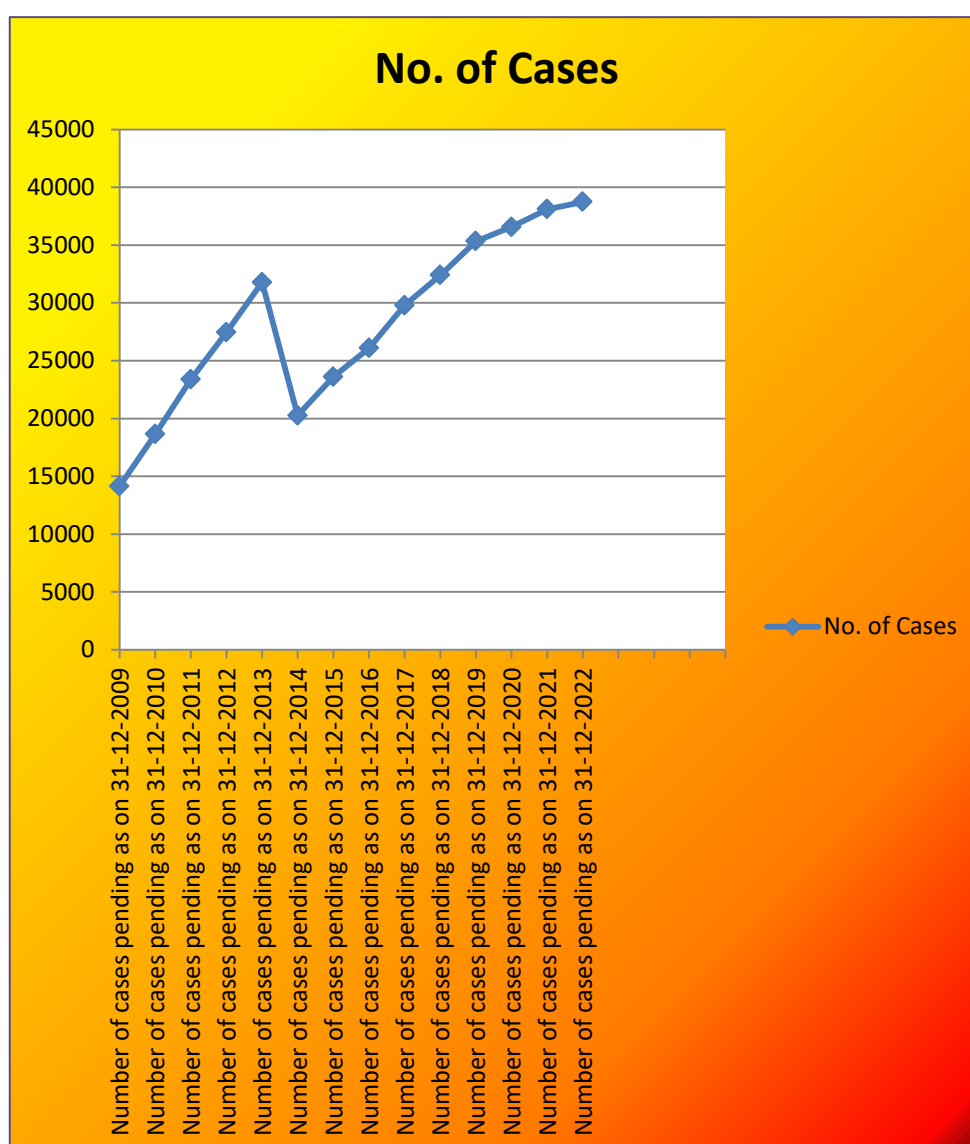

1.2.10. Progress in the number of cases completed in 2022 compared to 2021

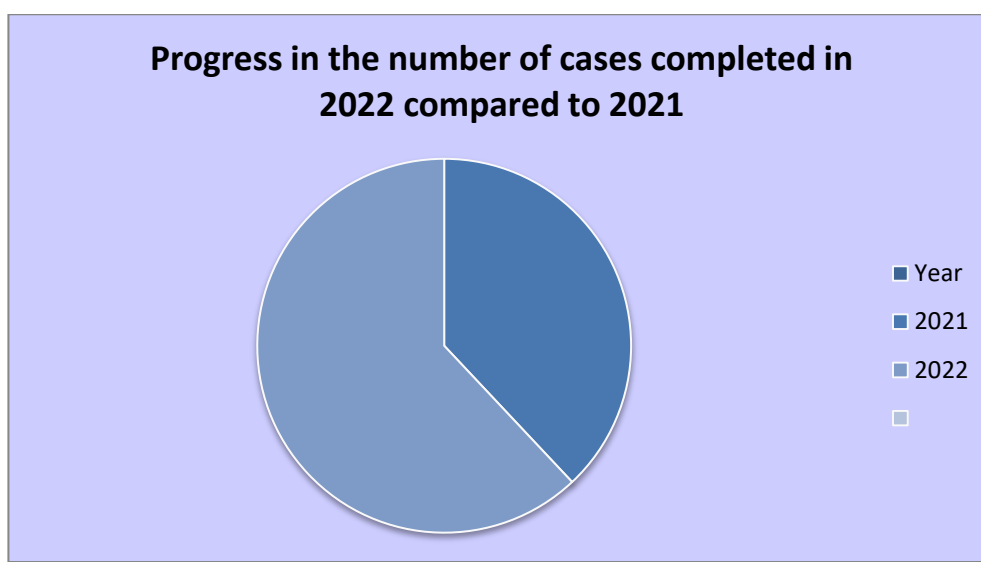

Accordingly, the number of cases closed in 2022 compared to 2021 is 24.2%.

In the year 2021, compared to the year 2020, there is a clear decrease in the risk, but in the year 2022, it is seen that there is a very clear growth value. Accordingly, compared to the growth of the number of clients seeking justice, there is clearly a progress in the number of clients who have taken recourse to justice.

2.1. National Policy on Legal Aid in Sri Lanka

With the establishment of the Legal Aid Act number 27 of 1978 and the establishment and running of the Sri Lanka Legal Aid Commission, it became apparent that the provision of legal aid should be made more formal and effective. The compilers wanted to prepare public policies that would be able to supervise these activities in order to reduce the problems arising in the various activities of the government as well as other non-governmental organizations in the country regarding the provision of legal aid and to get an effective service that is more important to the public.

Attention was paid to the way legal aid should be provided in Sri Lanka, the mechanism for facilitating it, monitoring and reforming the existing legal aid system. Legal aid is a universal fundamental right of all citizens and its provision should be equitable to all. To create an efficient and effective professional mechanism by working to provide an easy access to justice so that all Sri Lankans can do justice and thus to make the state legal aid program more formal in the civil society, gender, disability, age, nationality, It is a revolutionary act in the field of law to bring out a national precedent for legal aid, which would treat all situations equally regardless of religion, caste, geographical location or other socially sensitive influences. The Cabinet of Ministers has approved the preparation of the said national plan. This National Action Plan is being developed and is currently in its final stages.

In the year 2023, it is expected to popularize the national pride and implement the proposed programs as per the action plan.

2.2. Networking of Judicial Affairs (Google Sheet)

In order to maintain an efficient and formal legal aid mechanism, the Legal Aid Commission has strongly felt the need for some reasonable arrangement for the necessary supervision of the legal department. For that, it was decided that the most effective and appropriate way of doing the coordination and monitoring activities by networking the regional central points was to start and maintain the Google Sheet system in this year.

In the initial phase, the complete case file of each center was prepared as a data system and the maintenance of the system was carried out. This is expected to be more developed in the future.

Programmes & Projects

1.3 Programmes & Projects

During the period of 26 years since 1978 until 2004, the main focus of the Legal Aid Commission of Sri Lanka has been the concept of granting legal aid to maintain litigation. But since around 2004, the Commission has taken a number of steps to experiment with new methods of granting legal aid, hoping there is a possibility to grant the public an access to legal justice by instilling legal literacy into the public, going beyond this level.

Objective

Focusing on the parties involved in issues and helping to find solutions is an extremely significant task, whereas similarly, counseling on minimizing issues and maintaining living standards is a necessary part of it as well. If you act carefully and safely, the adverse consequences caused by many actions can be prevented. In order to function practically and intelligently in the course of everyday life, everybody should be enlightened of the feeling of the subtle knowledge required to act with knowledge and broad understanding. Comprehending this matter carefully, the Legal Aid Commission of Sri Lanka continues to initiate programmes and projects under the supervision of the Legal Division, in order to safeguard the security, protection and the rights of the people. Under this, planning, implementation and organization of legal knowledge and education programs are carried out.

1. In dispute resolution, a mediation without issues is more advantageous.
2. As it is a vain effort to apologies for an act committed on ignorance of law, for the purpose of protecting yourself from the consequences of any wrongdoing occurred or committed, "ignorance of law is not an excuse". Therefore, the socialization of legal knowledge is a matter with timely importance.
3. Further, contributing to the qualitative development, and increasing social inclusion for sustainable development by developing the lawfulness of society,
4. Examining the timely requirements and proposals that need to be made when imposing new laws
5. Advancement of personal legal literacy

are key objectives that are focused on, during the formulation and implementation of programmes and projects.

These programs are organized in collaboration with the Legal Division of the Legal Aid Commission, the staff of the local Legal Aid offices, various government institutions and NGOs, and the community participation. The programs were implemented with the cooperation of the government funds and various aid and assistance. We were able to implement some programs without any financial costs.

Resource contribution for the above programs has been given by legal officers working in the head office of the Legal Aid Commission as well as in various regional offices. A system has also been developed to provide answers.

A.2. By newspapers

The project of the Legal Aid Commission started in the year 2006 with the aim of providing answers to the public's problems through weekly newspapers and creating a readership among readers who want to acquire legal knowledge. Initially, this program was started by Lankadeepa newspaper in Sinhala media and then the Daily News newspaper of United Professional Paper Company Limited (Lake House) has been sponsored to continue this program in English media.

On the agreement of Lankadeepa newspaper and Daily News newspaper to provide their sponsorship free of charge, in the year 2022, once a fortnight on Tuesdays in Lankadeepa newspaper as "Legal refuge" to answer readers' problems, once a fortnight on Mondays in Daily News newspaper to answer problems for English readers. Apart from this, the society has been penetrated through Sirikatha, Dinamina, Tharuni and Diyaniya newspapers.

It appears that these programs have become extremely popular and appreciated among readers all over the island, regardless of age, in checking the daily telephone calls and mails received by the Sri Lanka Legal Aid Commission.

In the year 2022, in the year 2022, the "Guilt line right" of Maw Bima newspaper and "fight" for 38 issues and "Law check" for four issues of the Ceylon today newspaper, the Legal Aid Commission media unit has provided editorial contribution. Also, the Commission published a News Letter for the first time with the financial support of UNODC.

B. Social Participatory programs for raising awareness

The main objective is to focus on the empowerment of children, women and elderly people, who are generally considered vulnerable parties of society, and to safeguard their legal protection and security.

Further, government field officers, police officers and medical health officers have been identified as target groups in order to provide legal literacy to create a strong and efficient state mechanism.

In addition, as a welfare state, prison detainees, indigenous communities, migrant workers have been identified as distinct portions to be focused on.

B.1. School Programmes

The best age and group for socializing any kind of knowledge is the school children. It is quite easy to educate the adult society through the child, by motivating the curiosity, the thirst for knowledge and the interest within them to find new knowledge. Programmes were launched in several forms which were broadcast through this concept by the School Programme Division of the Legal Aid Commission of Sri Lanka.

Similarly, children's right to education, the right to love and care and giving the children the knowledge needed to protect themselves from crimes were covered during these programmes. The programmes were implemented in remote schools in different parts of the country.

The Special Unit for Children of the Sri Lanka Legal Aid Commission has focused on 27675 maintenance cases for children.

B.2. Programs for Women

These programs are centered on almost all rural women, semi-urban and urban women. The programs are focused on laws that protect women's rights as well as all forms of violence against her, and they are given legal protection when necessary.

A separate legal aid unit for women operates in the Legal Aid Commission. The unit provided legal advice to 23038 women in 2022.

Various programs have been implemented in several parts of Sri Lanka in collaboration with the Ministry of Women and Child Affairs, whereas special emphasis has been placed on the conditions of law affecting the day-to-day life and the Laws, Maintenance, Domestic Violence, Divorce, Fundamental Rights, Labor Laws related to the protection of property. Programmes imparting legal knowledge, various discourses and guidance for access to legal assistance as well have been carried out.

Likewise, the Legal Aid Commission of Sri Lanka was able to represent the National Committee on Women this year.

B.3. Programs for Senior Citizens

Sri Lanka, one of the countries with a rapidly aging population amongst the developing countries in the world, is experiencing a very significant demographic change. Demographers predict that the adult population, which is about 1/10 of the country's overall population, will double by 2050. Even though the increase of life expectancy of a country or increase of the aging population is one of the characteristics of a developed country, on the other hand, lack of improvement in other welfare facilities in comparison to the growing elderly population is a challenge.

It is practically proven that, just as being very strong in manpower, proven results can be obtained by empowering them with experience and knowledge.

In Sri Lanka, where there was a 30-year war, the number of senior citizens has increased significantly, and the security and protection of senior citizens must be guaranteed for the enforcement of the social welfare concept and the administration of justice. The senior citizen community, which constitutes 11% of the total population, constitutes 20% of the electorate. In that context, the Parliament of Sri Lanka has enacted the Protection of the Rights of Elders Act No. 9 of 2000, and thereby establishing this value.

In such backdrop, the Legal Aid Commission of Sri Lanka has carried out the affairs its Senior Citizen's Law Division in collaboration with the National Elders Secretariat. The Legal Aid Commission of Sri Lanka is in the process of helping the members of the Elders' Associations at the local level to obtain free solutions to their legal issues and to enforce the orders issued by the National Elders Secretariat regarding the claim of maintenance by elders, through the Magistrate's Court. Further, legal awareness programmes are also implemented for the members of the locally set up grass root elders' societies. In the year 2022, 04 senior citizen awareness programs have been conducted and 286 senior citizens have participated in it.

B.4. Programs for Public Officers

In general, the programs offered on legal knowledge are focused on all government officials, while providing legal knowledge for officers engaged in other specific fields as well. This is done as a task of the Legal Aid Commission for developing the professional capacity of public officers, forming an efficient state mechanism and creating a lawful, honest and contented public servant.

The project division of the Commission and the Regional Legal Aid Commission offices in collaboration with each other have conducted these programmes in various government, semi government, and provincial offices throughout the country. The areas covered in this respect are administrative law, human rights law, laws on lands, bribery and corruption law, labor law and family law. Arrangements have been made to conduct programs through lectures and transfer knowledge through training courses and tutorials.

As a whole, Grama Niladharis, Samurdhi officers, Agricultural Research and Production Assistants, Family Health Officers and field officers from Divisional Secretariats have been identified as targeted groups.

Accordingly, 25 programs were conducted through joint funds and 36 invited programs.

B.5. Programs for Police Officers

The police service is the statecraft who performs a major role in defending law and order. All officers who are engaged in the police service should have a good understanding and knowledge of the judiciary and legal field. Although an insight on the legal field is given at the recruitment of officers to the police service, the knowledge they gain on the legal changes made at different occasions and the new laws and regulations after the recruitment is rudimentary. The opportunity for gathering information is also rare.

Therefore, programs that provide an understanding on law should be carried out, in order to build professional skills of the police officers. An awareness and training programme on legal knowledge is being implemented jointly by the Legal Aid Commission and the Sri Lanka Police Department for the officers serving in various police stations island wide in this regard for a long while. Just as Criminal Law, the police officers will be given knowledge in civil and administrative fields as well.

One program was conducted for 51 police officers.

B.6. Programs for Medical Officers

Medical officers are a group of public officers who have little opportunity to gain legal knowledge when compared to other government officials, although they have to deal with law at all times in their profession. Even though on certain occasions, medical officers have to cooperate in Court procedures, only a few doctors are able to have a formal training on how to cooperate in such actions. It is a morbid question that many medico-legal officers are confronted with.

Medico-legal officers face serious challenges during autopsy, when appearing before Courts to give evidence regarding the same, on occasions where they obtain expertise evidence required for Court proceedings and, in collecting, presenting and analyzing the production of cases.

Similarly, although Medical Health Officers often need to assist in judicial work in their professional field, they lack knowledge in the legal field as well. Therefore, educating medical practitioners on law means improving their professionalisms well as an immense help in strengthening the process of administering social justice, welfare and equity.

Just as awareness programmes on the subject of law for medical practitioners are conducted, a special service has been done to the public through legal medical clinics. Officers from the centers of the Legal Aid Commission of Sri Lanka Island wide have joined hands with Medical Professionals in community health service on the prevention of non communicable diseases.

B.7. Mobile Legal Clinics

The Mobile Legal Aid Clinic is one of the most important projects when the realization of goals and objectives of the establishment of the Legal Aid Commission. This will help to broaden the legal aid program among grassroot communities and identify problems, enabling the general public to have an easy access to justice. This program is implemented at a grassroot level through the local legal aid offices in the country. It is made easier to identify suitable persons to provide free legal assistance for low-income people. 78 mobile legal clinics will be conducted. A mobile clinic is conducted at the end of each program.

C. Developmental legal aid programs

C.1. Program for Prison Inmates

Prisoners are human beings. Since 2002, the Legal Aid Commission of Sri Lanka has focused on this concept. Accordingly, the key objective of this program is to provide legal aid to the detainees who have been without bail or are unable to satisfy the bail conditions for a long period of time in jail. Accordingly, the Prisons Department and the Legal Aid Commission of Sri Lanka are conducting legal aid clinics for prison inmates throughout the country and collecting necessary information. After obtaining information, the inmates chosen for legal assistance will be given free attorneys' assistance for their cases. In the year 2022, 10 legal clinics have been conducted in prisons.

C.2.Program for Indigenous People

Aboriginal communities who inherit a history of many years live in different parts of the world. Notable among them are the Red Indians of America, the Pygmies of Africa, the Aborigines of Australia, and the Veddas of Sri Lanka.

Representing the earliest part of Sri Lankan history, these people are in the early stages of all kinds of conditions such as education, economic, health, employment and habitat. It is imperative that they develop legal literacy and provide them with legal aid to improve their living conditions in line with the new world. Further, the protection of the indigenous community is also a part of fulfilling the responsibility of protecting the historical heritage of our country.

The focus of the government should be on empowering the mechanism to facilitate easy and equal access to justice for the protection of indigenous peoples' heritage and the privileges granted to the public by the Constitution of Sri Lanka, and to make more flexible and effective legal reforms. The opportunity should be broadened for all communities to enjoy the rights of justice and equality. The main objective of this project is to draw the government's attention on these issues and make legal reforms.

One of the main objectives of this project is to meet the indigenous people living in different parts of Sri Lanka and to identify the current challenges associated with their homeland, traditional customs, their lives, livelihoods, educational levels and habitats. Accordingly, creating a discourse on legal issues affecting the everyday life of indigenous people takes a predominant place among the objectives of this project.

C.3.Program for Migrant Workers

Special security and protection of job security, safety of lives of migrant workers who contribute to the economy of Sri Lanka by bringing foreign exchange to the country should be ensured. The number of Sri Lankan migrant workers is increasing day by day, and new legal provisions have been established to ensure their safety and protection so that it prevents illegal migration and thereby the protection and security of migrant workers is strengthened. Most of our migrant workers are Sri Lankan women and this is due to their poverty and low- income level. Most of them in the Middle East are unskilled workers, housemaids and semi- skilled workers. The Middle East region has an opportune market and demand for most of those who are temporarily moving abroad. The market for skilled and qualified foreign workers has expanded to East Asia and West Asia.

Many Sri Lankan migrant women work as housemaids in the Middle East region. Most of these housemaids are victims of human rights violations, such as loss of

labor rights, abuse, physical and mental harassment at their workplace, due to lack of skills and efficiency. Likewise, some migrant women are embarrassed when they are faced with crimes and offenses abroad. Most people are ignorant about law enforcement in those countries.

This section provides self-service for expatriate workers who have faced problems. After providing the counseling service, the person will be referred to the consular section of the Ministry of Foreign Affairs or to the Sri Lanka Foreign Employment Bureau or, in necessary cases, for judicial purposes. This unit is working in conjunction with the Sri Lanka Foreign Employment Bureau to supervise the community initiative called "Gami Sansadaya" at the Divisional Secretary level to raise awareness programs for expatriate labor families, to collect their information.

C.4. Legal Education Programme

I. The formal legal education program

This is jointly operated with the Sri Lanka Law College. The aim is to train apprentice lawyers who will be sworn in as lawyers for a year. During the period from January to December this year, 650 apprentice lawyers have been trained in one group and for that the commission has obtained the external services of resource persons including senior expert presidential lawyers.

II. The informal legal education program

A program that has been conducted as a course to educate the public about the law. Here, people of different age levels who are engaged in different fields will study a 04-month academic course followed by an examination and a certificate. This legal education course has been conducted for a group of 30 people during this year.

C.5. Programmes focused on slum and shanty dwellers.

These programmes are conducted to raise awareness among the community which is required in order to seek compensation from the government by instituting court cases at the Honorable Court on behalf of the community who are unable to produce clear evidence on their rights on occasions where the houses and property of the urban community in Colombo are acquired by the government and a compensation is awarded on its behalf as a result of the project carried out by the Urban Development Authority.

1.3.6 Participation of the Legal Aid Commission in invitational programmes

Services provided by the Legal Aid Commission cover sexual assault, fundamental rights, child abuse, women's rights, sexual violence, laws for the majority, human trafficking, labor laws, land laws and civil documents, social issues of daily life. Resources have been provided on the basis of legal status, family law, war-affected women, Muslim women, foreign married women.

**Report of the Auditor General on the Financial Statements
and Other Legal and Regulatory Requirements of Legal Aid
Commission of Sri Lanka for the year ended 31 December
2022 in terms of the Section 12 of the National Audit Act
No: 19 of 2018**

1. Financial Statements

1.1 Qualified Opinion

The audit of the financial statements of the Legal Aid Commission of Sri Lanka for the year ended 31 December 2022 comprising the statement of financial position as at 31 December 2022 and the statement of comprehensive income, statement of changes in equity and cash flow statement for the year then ended and the notes in relation with the financial statements, including a summary of significant accounting policies was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with provisions of the National Audit Act No. 19 of 2018 and the provisions in the Finance Act No. 38 of 1971. My report in terms of the Article 154(6) of the Constitution will be tabled in the House of Parliament in due course.

In my opinion, except for the effects of the matters described in Basis for Qualified Opinion of this report, the financial statements prepared give a true and fair view of the financial position of the Commission as at 31 December 2022 and its financial performance and cash flow for the year then ended in accordance with Sri Lanka Public Sector Accounting Standards.

1.2 Basis for Disclaimer of Opinion

- (a) The Commission did not use the financial position statement form mentioned in Sri Lanka Public Sector Accounting Standard No. 01 in preparing the financial position statement.
- (b) According to the format of the statement of mass change mentioned in Sectoral Accounting Standard No. 01 to the State of Sri Lanka, the excess on the property inventory should be shown separately, but in the year 2012, the value of Rs.1,550,000, which is the surplus of the inventory of 03 vehicles, was not shown in the inventory.
- (c) Although the residual value and useful life of an asset should be reviewed at the end of each annual reporting period in accordance with Section 65 of Sri Lanka Government Sectoral Accounting Standard No. 07, the commission's fully depreciated assets worth Rs. 31,822,859 on December 31, 2021 had not been reviewed. Accordingly, the estimated error had not been rectified according to Sri Lanka Public Sector Accounting Standard No. 03.

(d According to paragraph 47 of Sri Lanka Public Sector Accounting Standard No. 07, property, plant and equipment items that have only insignificant changes in fair value should be recalculated every three to five classes. The commission has not done the inventory of other property, equipment and equipment worth Rs. 92,137,572 except motor vehicles on 31st December 2022 in the last 5 years.

(e According to Section 49 of Sri Lanka Public Sector Accounting Standard No. 07, when accounting for an item of property, plant and equipment, the class of property, plant and equipment to which the asset belongs must be fully accounted for, but only 03 motor vehicles with a value of Rs.1,220,000 for a value of Rs.1,550,000 02 vehicles costing Rs. 950,000 had not been audited.

(f According to paragraph 44 of Sri Lanka Public Accounting Standards No. 11, the grants made by the government should be recognized as assets and liabilities, but the grant receipts of Rs. 7,300,000 were not recognized in accordance with this accounting standard.

(g Pursuant to paragraph 80 (d) of Sri Lanka Public Sector Accounting Standard No. 01, the liabilities to be settled within 12 months from the reporting date should be recognized as current liabilities, but the Commission has recognized the total value related to gratuity allocations of Rs. 82,528,824 had been identified as non-current liabilities only.

- (h) The fixed deposit interest income receivable was not stated under current assets in the financial statements, and according to the calculations of the audit, the fixed deposit interest income and interest income related to the year were Rs. 533,292 and Rs. 357,079, respectively, which is Rs. 767,312 and Rs. 399,989, the interest income of the year is Rs. 234,020 more and the interest income receivable was Rs.42,910 more.
- (i) Schedules or other documents were not submitted for audit confirming the balances related to the assets of Rs. 15,619,085 computers, office equipment and furniture and books of Rs. 36,950 before 2014 included in the fixed assets mentioned in the financial status statement.

I conducted my audit in accordance with Sri Lanka Auditing Standards (SLAuSs). My responsibilities, under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified opinion.

1.3 Other information included in Annual Report-2022 of the Commission

Other information means the information that is included in the 2020 Annual Report of the Authority which was obtained by me before the date of this Audit report, but is not included in the financial statements and my audit report regarding it. The management is responsible for this other information.

Other information is not disclosed through my opinion on financial statements and, I do not express any assurance or opinion on that.

In relation to my audit of financial statements, it is my responsibility to read the other information identified above when available and, to consider whether

other information in accordance with my knowledge obtained with the financial statements or in the audit or otherwise, is quantitatively inconsistent.

Based on the other information obtained by me and tasks performed by me before the date of this audit report, if it is concluded by me that it contains quantitative errors, those matters should be communicated to the governing parties for correction. I have nothing to report in this relation

1.4 Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation of financial statements that give a true and fair view in accordance with Sri Lanka Public Sector Accounting Standards, and for such internal control as management determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Commission's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intend to liquidate the Commission or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Commission's financial reporting process.

As per Section 16 (1) of the National Audit Act No. 19 of 2018, the Commission is required to maintain proper books and records of all its income, expenditure, assets and liabilities, to enable annual and periodic financial statements to be prepared.

1.5. Auditor's Responsibility in Auditing Financial Statements

My objective is to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Sri Lanka Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Sri Lanka Auditing Standards, I exercise professional judgment and maintain professional skepticism throughout the audit. I also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for my opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtained an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the internal control.
- Evaluated the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the management.

- Concluded on the appropriateness of the Management's use of the going concern basis of accounting and based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Commission's ability to continue as a going concern. If I conclude that a material uncertainty exists, I am required to draw attention in my auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify my opinion. However, future events or conditions may cause to cease to continue as a going concern.

• Evaluated the structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

I would inform the ruling parties about significant audit findings, key internal controlling weaknesses and other matters identified during my audit.

2. Report on Other Legal and Regulatory Requirements

2.1 The National Audit Act No.19 of 2018 includes specific provisions for following requirements.

2.1.1 I have obtained all the information and explanation that were required for the Audit, and as it is disclosed by my audit, proper accounting records have been kept by the authority, as per the requirements of Section 12 (a) of the National Audit Act No.19 of 2018.

2.1.2 The financial statements presented is consistent with the preceding year as per the requirements of Section 6 (i) (d) (iii) of the National Audit Act No.19 of 2018.

2.1.3 The financial statements presented includes all the recommendations made by me in the previous year as per the requirements of Section 6 (i) (d) (iv) of the National Audit Act No.19 of 2018.

2.2 Based on the procedures performed and evidence obtained were limited to matters that were material nothing has come to my attention to make the following statements.

2.2.1 that any member of the governing body of the authority has any direct or indirect interest in any contract entered into by the Authority which are out of the normal cause of business as per the requirements of Section 12 (d) of the National Audit Act No.19 of 2018.

2.2.2 that the Authority has not compiled any applicable written law, general and special directions issued by the governing body of the authority , as per the requirements of Section 12(f) of the National Audit Act No.19 of 2018, except for following observations.

An internal audit had not been done for the year 2022 of the Commission, and the Ministry of Justice had done the internal audit.

The relevant approvals had not been taken for the fixed deposits of Rs. 7,447,775 invested in state banks.

Bank reconciliation statements were prepared by the officer who maintains the cash book against the cash regulations.

Even though the staff officer who receives an ad hoc interim agreement should settle the ad hoc interim agreement as soon as the work is completed, it took 29 days to 06 months to settle the advances worth Rs.815,225 given on 21 occasions.

According to the circular, the 2021 annual report was not tabled in the parliament.

The budget was not prepared as per the guidelines.

The Commission had not prepared a strategic plan as per the guidelines.

In accordance with the Bail Ordinance, no arrangements had been made to obtain bail from the officers who were required to post bail.

2.2.3 That actions have been taken in a way that is not complied with the powers, duties and functions of the Authority, as per the requirements of Section 12(g) of the National Audit Act No.19 of 2018

2.2.4. That the resources of the Authority have not been procured and utilized sparingly, efficiently and effectively in a timely manner in accordance with the applicable laws and regulations, as per the requirements of Section 12(h) of the National Audit Act No.19 of 2018.

2.3 Other Facts

- (a) According to Section 4.2.2 of the Procurement Guidelines, a procurement schedule showing the steps of each procurement process should be prepared by the procurement agency, but the agency did not prepare a procurement schedule.
- (b) According to the Commission's 2022 draft annual report, the number of cases brought forward for providing legal aid on January 01, 2022 was 38,099. From January to December 2022, the number of newly filed cases was 11,380, making the total number of cases to be dealt with during that period 49,470. Of these, 10,740 cases had been settled by December 31, and 38,739 cases were to be settled on that day. It was 78 percent of the total number of cases to be served.
- (c) An officer who worked in the commission had gone abroad for 5 years but had not reported back to work. Due to the violation of the terms of the agreement, although the officer should have taken steps to recover the amount due according to the agreement, although a period of 5 years has passed, an amount of Rs. 220,251 has not been recovered.
- (d) Although advances of Rs.1,217,830 were given to the contractors for the repair of buildings in the constituencies of Kalutara, Bibila and Negombo, although between 01 and 04 years had passed since the advance was given, the commission had not taken steps to recover this advance.
- (e) A budget document was prepared to show the total expenditure of the return year and an amount of Rs. 22,352,376 was spent on the 23 expenditure items included in the expenditure, but the expenditure was not estimated by the budget document.
- (f) There were vacancies for the three main posts of Director General, Director (Legal) and Director (Administration and Finance) as on 31st December 2022, and 29 vacancies as on 31st December 2022 for the post of Legal Officer belonging to the "Management" service category.
