1. ABOUT THE UNIVERSITY

The University of Kelaniya, the 3rd best University of Sri Lanka (as per the Webometric ranking) is located in the historical domain of the Kelaniya city outside the municipal limits of Colombo. It has seven different Academic Faculties, fifty-six (56) academic departments and three institutes with 565 academic staff members and 760 non-academic staff members. Also, the University has three other affiliated Institutes namely, Gampaha Wickramarachchi Ayurvedic Institute, Postgraduate Institute of Archaeology, Postgraduate Institute of Pali and Buddhist Studies.

Students of the University get various services under following categories such as Student Counselling Service, Career Guidance Unit, Personal Counselling Unit (Kalana Mithuru Sevana), Medical Centre, Physical Education, Cultural Center, Arts Council, Library (including Faculty Libraries), Information and Communication Technology Center and International Student Affairs Unit. Except for these centers and units, there are several others for different but specific services. For example, Quality Assurance Centre, University Statistics and Data Monitoring Unit (USD MU), Media Unit, Staff Development Center, Technology and Innovation Support Centre, Sustainable Development Centre, Centre for Distance and Continuing Education (CDCE), Centre of Excellence for Strategic Brand Identity Development (CESBID) and the Inter-Faculty Center for Coordinating the Modular System (ICCMS).

Ensuring the research culture of the University, the University has a research council which coordinates with research service center of each faculty. There are several other research centers such as the Centre for Heritage Studies, Centre for Gender Studies, Center for Chinese Studies, Centre for Japanese Studies, Centre for Korean Studies, Palm Leaf Manuscript Study and Research, Environment & Development Consultants (EDCON) and the Samakathana Research Centre.

Except for the Faculty of Medicine, which is located in Ragama premises, all the other faculties are located in Dalugama, twelve kilometers away from the capital city in a whole area of 55 acres. The main buildings in Dalugama premises are the Student Centre, Science Block, Humanities and Social Sciences Building Complex, Commerce and Management Studies Building Complex, Science Lecture Theatre Complex, Auditorium and Ancillary Building, Sri Dharmaloka Convocation Hall, Aquaculture and Microbiology Buildings, ICT Centre, the Library, and the Administrative Block. Sri Dharmaloka Convocation Hall has a seating capacity of 1,000, while the Science Faculty Auditorium and Professor Sunil Shantha Memorial auditorium of the Faculty

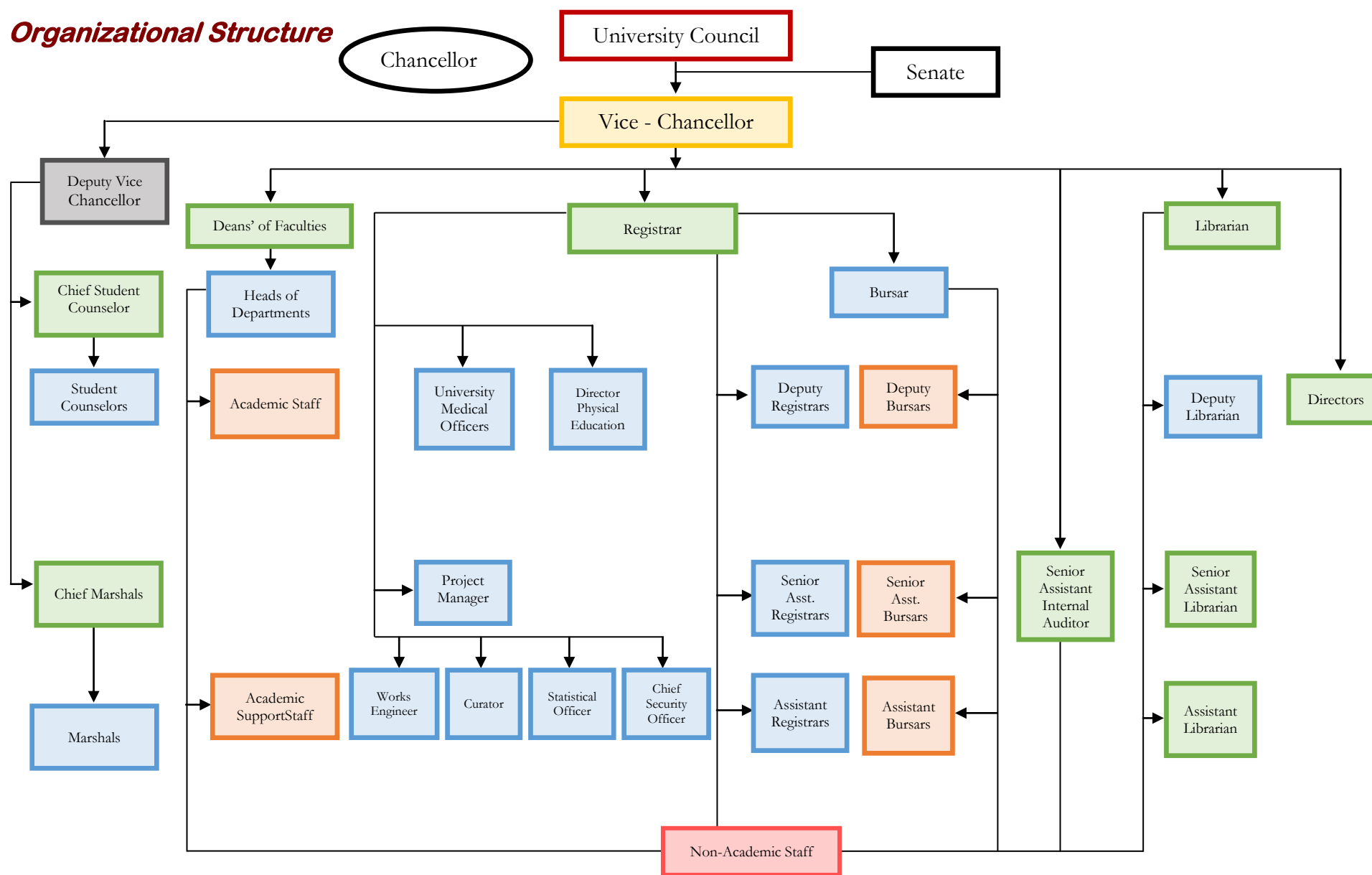
of Commerce and Management Studies can accommodate 250 & 300 persons respectively. Sri Dharmaloka Convocation hall and Social Sciences Auditorium were recently upgraded as state-of-art auditoriums with modern technology.

In terms of housing, the Bhikku Hostel and the Women's Hostel Complex are located within the Dalugama campus, while the Men's Hostels and some Women's Hostels are located nearby. Venerable Ratmalane Sri Dharmarama Girls' hostel complex was opened in December, providing accommodation facilities for 500 students. In providing IT facilities, in addition to the main ICT Centre, every faculty possesses well-equipped ICT Centers which are managed either by the faculty or by the department. To facilitate teaching, learning and research Wi-Fi facility have been expanded to cover the entire University and the hostels. Three language laboratories are located in the Faculty of Humanities. All departments of the Faculty of Science and Faculty of Commerce & Management Studies consist of research laboratories in addition to classroom facilities.

At Ragama, the buildings include the Administration Block, Lecture Theatres and Laboratories Complex, Disabilities Studies Unit Building, Molecular Medicine Unit building, Preclinical Buildings Complex, Auditorium with a seating capacity of 200 and men's and women's hostels. Construction of two lecture theatres and a students' hostel was commenced at the faculty premises recently.

The human resource of the University comprises, concisely, academic staff members, administrative staff, academic support staff, executive staff and non- academic staff. The following figure illustrates the organizational structure descriptively.

1.1. The Evolution

The origin of the University of Kelaniya begins with the establishment of historic Vidyalkara Pirivena in 1875 by Rathmalane Sri Dharmaloka Thero as a centre of learning for Buddhist clergy. Historic Vidyalkara Pirivena was one of the great national centres of higher learning and also was the forerunner of the national movement and resurgence. With the establishment of modern Universities in Sri Lanka in the 1940's, 1950's, the Vidyalkara Pirivena became the Vidyalkara University in 1959. Later, when the government gathered all the universities as one entity, the Vidyalkara University became Vidyalkara campus of the University of Ceylon in 1972 and under the University Act 1978, Vidyalkara campus renamed as the University of Kelaniya in 1978.

The University has pioneered a number of new developments in Higher Education during the last four decades. It is one of the first universities which began teaching Science in Sinhala, and also the first to restructure the traditional Arts Faculty into three separate Faculties of Humanities, Social Sciences and Commerce and Management. It also consists of several unique areas of study. For example, Linguistics, Fine Arts, Modern Languages, Hindi and Library and Information Sciences.

In keeping with its historical roots, the University is one of the national centers of excellence in Pali and Buddhist Studies and related fields. It has long established and well-developed Departments of Pali and Buddhist Studies (incorporating chairs in Buddhist Civilization and Buddhist Philosophy), Sanskrit, Linguistics, Philosophy, Sinhala, and Hindi, as well as the Postgraduate Institute of Pali & Buddhist Studies. Kelaniya also maintains close links with the Buddhist and Pali University of Sri Lanka whose Vice-Chancellors have often been drawn from the University of Kelaniya faculty. Thus, the University of Kelaniya forms the Centre of an academic complex, specializing in modern developments in traditional disciplines. It also retains a close link with its mother institution, the Vidyalkara Pirivena, whose Head is also the Chancellor of the University.

1.2. The Present

As per the academic calendar of the University, the academic year 2014/15 ended on February 19, 2017, and the academic activities of the year 2015/16 begun on February 20, 2017, and is scheduled to be completed on February 11, 2018. 2,968 students were registered as new enrollment in internal undergraduate degree programs in 2017. 1,771 students were enrolled for postgraduate studies during 2017. The international recognition of the university was enhanced by the enrollment of 50 international students for both undergraduate and postgraduate studies to the university in 2017. Today, the University of Kelaniya has ten thousand sixty (10,060) students studying for undergraduate degree programs, where about 1.5% of students are enrolled under the foreign category. There are two thousand seven hundred nine (2,709) students for postgraduate study programs and for external undergraduate programmes total of ninety-five thousand nine hundred six (95,906) students. University produced 2,431 internal graduates and 631 external graduates and 1,229 postgraduates in 2017.

The University of Kelaniya focuses not only on the quality of graduates, but also the well-being of the staff, for an example, by offering a free insurance scheme for students and staff. She is the first-ever University in the country who ever offers up to five million rupees for doctoral studies of the staff members. Also, it has allocated a greater amount of money for aesthetic and sports activities of the University. The University has concentrated on developing the soft skills of the staff and students and ensures the employability of graduates by organizing the career guidance activities and the career fair each year.

New enrollment of foreign students has been increased compared to previous years. The University has taken several steps to build up the international image of the University and a total of twelve international MoU's have been signed with several universities around the world with the purpose of research activities, staff and student exchange programmes. Total of six local MoU's has signed with corporate bodies. Centre of Excellence for Strategic Brand Identity Development (CESBID) has engaged in creating a strategic brand identity for the university.

Affording the research culture of the university, the university has provided funding for the academic staff for research activities and for research conferences and symposia organized within the university. Also, she is the first ever university who introduced the Senate awards for staff for publishing in internationally recognized peer-reviewed, indexed and refereed journal articles. Accordingly, to enhance the engagement in research and encourage researchers, 108 senate awards have been awarded to the academic staff in 2017.

1.3. Achievements

The University of Kelaniya secured the first place among Sri Lankan universities in green practices and 259th position in world rankings according to the UI GreenMetrics ranking in 2017. UI GreenMetric ranking is based broadly on the conceptual framework of Environment, Economy, and Equity. This year 619 universities in 76 countries participated, compared to last year 515 universities in 75 countries. The rankings look at six indicators of each university: setting and infrastructure, energy and climate change, waste, water, transportation and education.

According to the most recent Webometrix rankings carried out in January 2018, the University of Kelaniya has been ranked at the 2,691st position in the world and 924th in Asian Continent and 108th in the South Asian region. Compared to last year, the University has improved its world rank by 76 positions and ranking among Asian region by 22 positions. Also, it has improved their Sri Lankan ranking by one position and has become the 3rd best University in Sri Lanka.

Twenty-three Academic staff members of the Faculty of Medicine and two Academic staff members of the Faculty of Science received President's awards for Scientific publications.

Several academic symposia and research conferences were held to enhance the research culture of the university in 2017. The Annual Research Symposium, 18th International Postgraduate Research Conference 2017 organized by the Faculty of Graduate Studies was held on 08th December 2017, on the theme, "Research for sustainable development, applications beyond publications". In addition to this symposium, 19 international and national level Research Conferences and Symposia were organized and conducted by the faculties and academic departments for the advancement of the research culture within the university.

With the aim of enhancing the artistic and literary skills of the undergraduates of the University Performances, Media, Art and Literature Competition, Sprout (Kalana) 2017 was organized and conducted by the Arts Council. The awards were presented to the winners of the 1st place in each category, while valuable cash prizes and Certificates were awarded to all the winners of the 1st, 2nd and 3rd places in each category.

Celebrating the golden jubilee, 50th anniversary of the Faculty of Science, the "Vidya 2017" exhibition was organized and held on October 2-9 successfully. "Inventio 2017", motivating the undergraduates for innovations was organized by the Technology and Innovations Support Centre of the University of Kelaniya parallel to the exhibition.

Additional to these programs, 'Stylish Marketer' Fashion Show, The Inter-University Best Speaker Contest, Art Exhibitions, University Stage Drama Festivals, Photography exhibitions,

Media Festivals, Talent shows, Colors Awarding Ceremony, Tree Plantation Programmes, Career Fair 2017, Welfare Projects and several workshops were some of the extra-curricular programmes conducted in 2017.

Students from every Faculty participated in national and international games and competitions held during the year 2017 and the students of the University of Kelaniya won several national and international awards, bringing honour to the University.

The different events and activities organized by students and staff as departments, faculties or organizations within the university bested for the advancement of the University's reputation as well as the talents and skills of students of the University.

1.4. Ongoing Construction Projects

- Construction of six storied building complex for the Faculty of Science
- Construction of building for the Information & Communication Technology Center
- Construction of six storied building complex for examination halls & lecture halls - stage III (TCE of Stage I, II & III - 400 Million)
- Proposed modification for the existing gymnasium stage I
- Multipurpose building at the Faculty of Medicine at Ragama
- Proposed lecture theatre complex at the Faculty of Science

2. FACULTIES OF THE UNIVERSITY



The University of Kelaniya has seven different faculties in Dalugama premises and Ragama Premises. Each faculty is governed by respective Deans and each faculty conducts various degree programs.

2.1. Faculty of Commerce and Management Studies



a. Mission

The mission of the Faculty of Commerce and Management Studies of the University of Kelaniya is to “produce academically and professionally competent personnel to take up managerial positions in organizations, create an entrepreneurial culture, and broaden the horizon of knowledge pertaining to the discipline of Commerce & Management”.

b. Introduction to the Faculty

The Faculty of Commerce and Management Studies is one of the fastest developing faculties of the University of Kelaniya with unique features of becoming one of the finest Faculties in the country. The origin of the Faculty could be traced back to the point where the Department of Commerce was established under the Faculty of Social Sciences in 1976. With the commitment and untiring efforts of academic staff, students and other stakeholders, we achieved the Faculty status by converting the department into a Faculty in 1995.

c. Current Progress

Academic Programmes

Since then, the Faculty has been able to draw attention of the stakeholders and popularity within the university community in a rapid phase in terms of quality more than the quantity. Some of the best examples to prove the improvement of quality are, graduate employability rate of 85.5% of the Faculty which is the highest among the Management Faculties in the country, ISO

certification to the Department of Marketing which is the only department to have obtained this recognition among the Management fraternities in the island that currently offering an ISO certified degree programme and the recognition granted by Chartered Financial Analysts (CFA) Institute-USA in 2014 for the BBMgt (Finance) Special Degree programme offered by the Department of Finance.

The Faculty currently consists of five (5) departments, with the strength of 103 academic staff members, 26 non-academic staff members and 2228 undergraduate students. The five (5) departments namely; Commerce & Financial Management, Human Resource Management, Accountancy, Marketing Management and Finance are offering ten (10) undergraduate (special degree) courses, five (5) Master Degree programmes, two (2) Postgraduate Diplomas, four (4) Diplomas and four (4) Higher Diplomas in addition to a Doctor of Business Administration (DBA) programme. In 2017 the Department of Finance introduced new degree programmes - BBMgt Honors in insurance and BBMgt Honors in Banking for undergraduate, furthermore the department is also going to introduce a new degree programme - BBMgt Honors in Financial Engineering in 2019 and the Department of Accountancy is to introduce two new degree programmes - BBMgt Honors in Auditing & Forensic Accounting in 2018 and BBMgt Honors in Accounting Information System, in 2019.

The Faculty offers a semester based academic programmes and underwent a further revision of curriculum, the implementation of which was introduced from the academic year 2013/14 while catering to the latest trends of the subject field, interests of the academia and current demands of the dynamic job market. The Faculty is continuously in process of introducing new courses to be offered to the general public apart from main academic programme, as an additional service to the community.

Academic Staff

Academic staff of the faculty is genuinely enhancing their research interests and bring out their researches substantially in research publications which in turn contribute to the academic programme. In fact, in 2017 itself the Faculty staff has made approximately 365 publications, obtained 7 awards consisting of 1 international and 6 national awards. 32 members of the academic staff are having Doctoral Degrees (PhD) while 98 members are with Master Degrees, out of whom, 26 are currently reading for Doctorates.

Extra-Curricular Activities

All the departments of the Faculty have unique extracurricular activities conducted by the undergraduates. Some of the significant events so conducted are, Young entrepreneurs' Day organized by Department of Commerce and Financial Management, Investment week by Department of Finance, 'Stylish Marketer'- A Fashion show organized by Department of Marketing Management, '3D's' –Talent show by Department of HRM, and 'Idea Night'- an Internship certificate awarding ceremony and ICARE by Department of Accountancy.

With this capacity and in line with the mission, the Faculty has been rendering its distinctive services to prepare scholars and professionals with capability, skills and attitude, driving the economy, supporting civil society and government and make essential decisions in the interest of whole society. Accordingly, the Faculty of Commerce and Management Studies has so far produced more than 8,000 graduates and most of them are in the forefront of managerial ranks in public and private sector organizations, both locally and internationally with some of our graduates being prominent entrepreneurs in the country.

2.2. Faculty of Computing & Technology



a. Vision

To become a Centre of excellence in creation and dissemination of knowledge in Computing and Technology for sustainable development.

b. Mission

The Faculty of Computing and Technology strives for excellence in computing and technology through innovation and dissemination of knowledge and capacity building for socio-economic development of the nation.

c. Overview

The Faculty of Computing and Technology (FCT) was established on the 30th of December 2015 by the Gazette notification 1947/24 of the Government of Sri Lanka with three departments, namely, Department of Applied Computing, Department of Computer Systems Engineering and Department of Software Engineering. The new Faculty commenced its operations on January 18, 2016.

Academic registration of students in the FCT commenced from the academic year 2015/2016. The FCT started to offer degree programmes from the academic year 2015/16 for the technology stream students, namely, Bachelor of Information and Communication Technology (BICT) and Bachelor of Engineering Technology (BET). From the academic year 2016/17 the Faculty will offer B.Sc. Honours in Computer Science.

In addition, the faculty will cater to unique computing needs of other Faculties. This will help improve the computer literacy and the computer usage by undergraduates of other faculties, which is identified as a critical determinant of employability of the graduates.

The Faculty will offer the Postgraduate Programmes in the areas of Computer Science, Software Engineering, Information Technology and Engineering Technology. The Master of Information Technology in Education programme is developed for the Ministry of Education to train ICT teachers. This programme will commence from year 2018.

The faculty conducts research in diverse fields of significant impact. The research enterprise at FCT will expand from fundamental Computer Science research to the development of new technologies with applications to the industry and society as a whole. The discovery and creation of new technology are the essence of the doctoral programs in Computing and Technology. The Faculty is in the process of establishing several Research and Development Centers. The following two research centers are already established:

- Center for Nanotechnology
- National e-Learning Resource Centre (NELRC)

The FCT is planning to establish the following Research and Development Centers in near future:

- Language Engineering Research Centre
- Centre for Geoinformatics
- Centre for Computational Mathematics
- Centre for Data Science
- Centre for Cyber Security

Faculty of Computing and Technology has established the Industry Interaction Cell for Computing and Technology (II CfCT) with the following objectives:

- To encourage computing and technology experts in the university to contribute their knowledge/ experience for the development of national economy.
- To develop computer based systems necessary for the government sector and SMEs at an affordable cost.
- To provide training opportunities for the students with real world jobs.
- Encourage external experts to collaborate with FCT for R & D activities.

Bachelor of Information and Communication Technology Degree Programme

The Bachelor of Information and Communication Technology is a four-year degree programme. The proposed intake is 75. This degree programme will help students to build necessary skills, knowledge and attitudes required to function as software developers, network administrators and ICT professionals. Strong fundamental knowledge in electronics and data communication with supporting hands-on laboratory sessions will provide the necessary skills and knowledge required to design, build and maintain industry standard software and computer networks. Incorporation of specialized application areas such as Virtualization and Cloud Computing, Network Management, Wireless and Mobile Communications, Computer Security, Web Programming, Mobile Application Development, Computer Games and Animation, Virtual Reality to the curriculum provides ample flexibility for students to specialize in their own areas of interest. Students will get an opportunity to work in the industry for six months through the internship module in the 4th year. The medium of instructions and examinations is English.

Bachelor of Engineering Technology Degree Programme

The Bachelor of Engineering Technology is a four-year degree programme. The proposed intake for this degree programme is 75. This Engineering Technology degree programme will have a strong focus on practical applications of science and technology with the view of preparing the graduates for a wide variety of industry applications. The first two years of the curriculum aims at developing the common competencies expected of an engineering technologist while the final two years are devoted for developing specific competencies in chosen areas of specialization. The areas of specialization currently on offer are:

- Material and Process Engineering
- Robotics and Industrial Automation
- Environmental Engineering Technology

Students will get an opportunity to work in the industry for six months through the internship module in the 4th year. The medium of instructions and examinations is English.

Bachelor of Science Honours in Computer Science

The Bachelor of Science Honours in Computer Science which will be offered from the academic year 2016/17. This is a four-year degree programme. The proposed intake for this degree programme is 50. The course structure of the B.Sc. Honours in Computer Science Degree is designed to align with the recommendations of the Standing Committee on Computing of the

UGC, and the guidelines of the Association for Computing Machinery (ACM) and the Institute of Electrical and Electronics Engineers (IEEE). During the last two years of study a student will be able to choose an area of specialization on their wish. The areas of proposed specialization on offer are:

- Cyber Security
- Data Science
- Artificial Intelligence
- Scientific Computing

Students will get an opportunity to work in the industry for six months through the internship module in the 4th year.

Learning Centered Education

The Faculty has adopted the learning centered education pedagogy for its programme design and delivery for the first time in Sri Lanka. A series of workshops were conducted both in Sri Lanka and at the University of Oxford, UK under the guidance of Prof. Lynn Mc Alpine, Professor Emerita of University Education Development, Oxford Learning Institute, University of Oxford to train the staff and adopt the curriculum to reflect learning-centeredness.

The learning centered education approach promotes active learning where the emphasis is placed on creating and managing tasks and activities which will empower student learning, both inside and outside the class. The pedagogical style required to enable active learning is different to traditional lecturing. A different set of instructional and assessment strategies are adopted in the learning centered approach to facilitate independent learning by the students. The lecturer will select appropriate interactive techniques from a host of such techniques available, in addition to mini-lectures, to achieve the intended learning outcomes. The lecturer will also use a set of different assessment strategies, both formative and summative, to assess the level of achievement of the intended learning outcomes by each student, based on pre-defined rubrics, during the entire course module. This places less importance on the traditional end of the semester exams, and a considerable percentage of marks will be earned by the students through continuous assessment throughout the module.

Industry Advisory Board

The Faculty of Computing and Technology has established an Industry Advisory Board composed of eminent professionals from the industry, representatives from industry associations as well as representatives from professional associations.

The role of the Industry Advisory Board (IAB) of the Faculty of Computing and Technology (FCT) is to serve as a liaison between the FCT and the industry as well as other institutional stakeholders in order to support the FCT in the formulation and attainment of its Mission and Strategic Objectives. It plays a key role in providing inputs and recommendations to the FCT from an industry perspective and guiding the strategic directions of the FCT in terms of academic programs, research and partnerships.

Mr. Anuradha Tennakoon, Country Head/ Engineering Director, Zebra Technologies Lanka (Pvt.) Ltd was elected as the Chairman of the IAB at the inaugural meeting held on 29th September 2016.

Outbound Training (OBT)

The FCT has introduced an outbound training program for all its undergraduate students. Through the OBT programme, the faculty has taken another step towards changing the attitudes and mindset of students from the traditional class room environment, and providing a valuable learning experience for accomplishing the life challenges and making a positive impact on their work performance. This programme will be held annually.

The first outbound training program for the young leaders of the Faculty of Computing and Technology at University of Kelaniya was held successfully at the Police Training College – Kalutara on 16th and 17th of September 2017. The two-day interactive program was organized by the faculty to improve the group dynamics and personality development of the undergraduates of the first batch (2015/2016) of the faculty. The event was geared towards enhancing the skills in competent leadership, building energetic and high-performing teams, trust-building, personality and self-confidence building, effectively working in diverse environments, facing and succeeding the challenges, creating an open-mind, effective and efficient decision making, and various other important skills that are necessary in improving the quality of student's academic and personal lives.

KICTACT 2018 Conference

The Kelaniya International Conference on Advances in Computing and Technology (KICTACT) organized by the Faculty of Computing and Technology, University of Kelaniya was inaugurated in 2016 on November 25, 2016 at JAIC Hilton, Colombo. The second conference was held on July 25, 2017, at the University of Kelaniya. The 3rd conference of the series is planned to be held on July 27, 2018.

This conference is expected to bring together researchers, educators, students, practitioners, technocrats and policymakers from across academia, government, industry and non-governmental organizations to discuss, share and promote current works and recent accomplishments across all aspects of Computing, Nano Technology, Materials and Process Engineering, Robotics and Automation.

2.3. Faculty of Graduate Studies

Faculty of Graduate Studies offers a variety of programs, ranging from postgraduate diploma level to doctoral level. Currently, there are over fifty-two programs offered by the various Faculties and institutions. Some of the courses are based only on coursework, while others are based on research, and some others are amix of coursework and research. Coursework at FGS means face-to-face teaching as in a traditional university. These courses are usually conducted during weekends or evenings, to enable people who are already employed to enhance their knowledge and skills. Currently administration functions are operated by an online Management Information System. Further, the FGS has already in partnership with Bangladesh offering its Masters programs and building its collaborations with Australia and few other countries.

Postgraduate study at MPhil (Master of Philosophy), PhD (Doctor of Philosophy), MD (Doctor of Medicine) and DBA (Doctor of Business Administration) levels are possible in respective Boards of Study under Faculty of Graduate Studies, University of Kelaniya. These Programs tend to build on the skills acquired at undergraduate and Master's levels. They involve an applicant being assigned to a supervisor for guidance in conducting research. The applicant and supervisor/s work together to achieve the objectives of the research program.

2.4. Faculty of Humanities

The departments and units attached to the Faculty of Humanities comprise qualified and experienced academic staff including professors and other senior academics who have obtained their PhD qualifications from prestigious local and foreign universities. Under their guidance, our students have grown into qualified and critical adults who contribute to the development of the country in countless ways.

2.5. Faculty of Medicine



a. Vision

The Faculty aspires to be an internationally recognized institution of higher education in a culture of excellence and integrity that helps to generate and impart knowledge in the medical sciences

b. Mission

The Faculty of Medicine,

- Educates medical students, postgraduate doctors, allied health care professionals and the public,
- Provides patient oriented medical care to prevent, diagnose and treat human illness, and
- Conducts basic, applied and clinical research

in an environment of high quality education that nurtures a spirit of inquiry, initiative, equality and social responsibility.

Graduates of the Faculty will have the knowledge, the skills and attitudes to be successful in providing services to the community, country and beyond as individuals and opinion leaders in a globalized health care environment.

At the Faculty of Medicine, knowledge is advanced by an academic community with a passion for teaching, student training and scientific enquiry. By providing an excellent environment for learning and research, we will encourage scholarship at the highest level.

c. Overview

The Faculty of Medicine is situated in a spacious, 35acre campus at Ragama. It commenced activities in September 1991. In 2017, the 23rd batch of medical students (a total of 168) and the 5th batch of BSc (Speech & Hearing Sciences) students (51 Speech & Language Therapists and 13 Audiologists) graduated from the Faculty. The 29th batch of students for the MBBS degree programme, and the 9th batch of students for the BSc (SHS) degree programme were enrolled at the University in November 2017. The Faculty also offers two external degree programmes in conjunction with the Centre for Distance & Continuing Education: a BSc in Occupational Therapy, and a BSc in Physiotherapy. Postgraduate programmes include the Master of Public Health (Epidemiology) programme, and research degrees leading to award of MPhil and PhD in the medical sciences.

As of December 2017, the Faculty had 1224 undergraduate students: 840 female students and 384 male students. They include 49 students from overseas, mainly from other South Asian countries, who have been admitted on a fee-levying basis. The Faculty has 128 academic staff on the permanent cadre, as well as about 30 on the temporary cadre, and over 60 visiting staff that include consultants who are attached to the affiliated teaching hospitals. The Faculty prides itself on its research activities, and its output is amongst the highest in medical faculties in Sri Lanka. Twenty-three academic staff members received President's Awards for Scientific Publication in 2015, at the ceremony conducted in November 2017.

2.6. Faculty of Science



a. Mission

The mission of the Faculty of Science of the University of Kelaniya is to produce highly motivated graduates and postgraduates capable of making a significant contribution towards national development and the wellbeing of mankind, to conduct research and provide advice and consultancy services in various scientific disciplines to foster a better understanding of the environment for sustainable use and conservation of natural resources.

b. Introduction of the Faculty

The Faculty of Science, University of Kelaniya is one of the five Faculties of Vidyalankara University established at its inception in 1959. Now The Faculty of Science of the University of Kelaniya consists of eight academic departments, namely the Departments of Botany, Chemistry, Industrial Management, Mathematics, Microbiology, Physics, Statistics & Computer Science and Zoology and Environmental Management. The Faculty of Science now offers 7 Bachelor of Science Degree Programmes which, 3 Bachelor of Science Degree Programmes of 3 year duration and 4 Honors Degree Programmes of 4year duration. The Bachelor of Science Degree Programmes are Bachelor of Science Degree, Bachelor of Science Environmental Conservation and Management Degree (ENCM) and Bachelor of Science Physics and Electronics Degree (PHEL). The Honors Degree Programmes are Bachelor of Science Honors Degree, Bachelor of Science Honors in Environmental Conservation and Management Degree (ENCM), Bachelor of Science Honors in Management and Information Technology Degree (MIT) and Bachelor of Science Honors in Software Engineering Degree (SENG).

The Students admitted to the Biological Science and the Physical Science streams are 170 and 300 respectively and 50 students each are admitted for BSc Hons in MIT, BSc Hons in SENG, BSc in ENCM and BSc in PHEL Degree Programmes. Totaling up to an additional intake of 200 students each to the Faculty of Science. The present annual intake of students to the Faculty is 568 and the total undergraduate students population is 1,782. The present academic cadre attached to the Faculty is 120 and non-academic staff is 124.

In the year 2017, the Department of Physics introduced the new Degree programme BSc in Physics and Electronics (PHEL) for a special intake of 50 students in Physical Science stream. Students from Physical Science and Bio Science can also offer a range of Auxiliary courses from the Faculties of Humanities, Social Sciences and Commerce & Management Studies. At present, the Faculty of Science conducts 6 MSc Degree programmes and 3 Postgraduate Diploma Programmes.

c. Current Progress

Under the World Bank funded Higher Education for Twenty First Century (HETC) project the Faculty was awarded 3 competitive Quality and Innovation Grants (QIG) for Windows 1 & 2 for BSc in Environmental conservation and Management, BSc in Management and Technology and BSc in Physical Science study programmes. Each study programme was awarded LKR 25,000,000 for quality enhancement. Further, under HETC–QIG for Window 3, Faculty of Science has received a competitive grant of LKR 30,000,000 to promote postgraduate research programmes in various disciplines in the Faculty. With the support of this grant, a Central Research Laboratory with modern research facilities has been established in order to enhance the quality and effectiveness of the research activities in the University. In addition, the Faculty received a competitive grant under QIG for Window 4 (LKR 10,000,000) for research dissemination and commercialization projects. The Research Service Centre established under this project liaise with industry stakeholders to provide services and serves as venture to strengthen the research at the Faculty. Faculty of Science received an award in 2013 for being the recipient of highest number of competitive grants under QIG schemes of the HETC project among all the faculties of national Universities in Sri Lanka.

The Faculty of Science celebrated the 50th anniversary and have organized several activities mainly an exhibition, commemorative publication and research symposium to mark the anniversary. A new six-storied building is nearing completion, which will be used by the Departments of Physics, Statistics & Computer Science, Mathematics to conduct a Degree Programmes in Electronic and Computer Science. An eight-storied building is under

construction to conduct the BSc Hons Degree in Software Engineering. The foundation will be laid to construct a Lecture Theatre Complex for the Faculty of Science; which will be designed to facilitate student central lecturing.

With this capacity and in line with the mission, the Faculty has been rendering its distinctive services to prepare scholars and professionals with capability, skills and attitude, driving the economy, supporting civil society and government and make essential decisions in the interest of whole society.

2.7. Faculty of Social Sciences



Faculty of Social Sciences consists of twelve Departments including the newly established Departments of International Studies, Political Science and Social Statistics. The Faculty offers 18 subjects for the Bachelor's degree. Students are able to follow Bachelor of Arts (General) and Bachelor of Arts (Special) degree in these subjects. Lectures, seminars and workshops are held with the participation of specialists in various fields for the improvement of knowledge of the students, in addition to lectures and other tutorial classes relevant to degree courses by various departments of the Faculty. The newly commenced study program of the faculty is the Diploma in Library & Information Sciences conducted by the Department of Library & Information Science.

Also, certificates and Diploma courses, Postgraduate Diploma courses, MA (one year) and MSSc (two year) courses from selected subject streams in the Faculty of Social Sciences are conducted. Facilities to follow MPhil and PhD degrees based on research are available, including a research laboratory, Palm Leaf Manuscript Library, information technology facilities and other resources of the Faculty. The palm leaf manuscripts library contains more than 600 palm leaves and more than six hundred thousand copies of palm leaf which is the highest number of palm leaf collection of Sri Lanka. In 2017, a new building was opened for the Palm Leaf and Manuscript Library with the participation of chief incumbents of Malwathu Maha Viharaya and Asgiriya Maha Viharaya.

In 2017, several research symposiums were conducted by the faculty and its departments to enhance the research culture of the faculty including the annual National Symposium of Social Science Undergraduates. Also, it is planned to conduct International Conferences of Social Sciences for the 4th time in 2018 which will be organized by the Faculty and as well as a special research conference reflecting the Uva- Wellassa rebellion held on 1818 which will be organized by the Department of History.

3. STUDENT INFORMATION

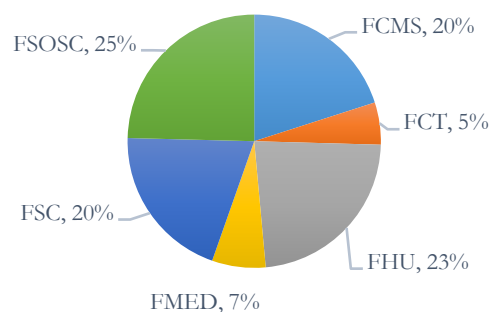

3.1. New Enrollment 2015/16 – Internal Undergraduate Degree Programmes

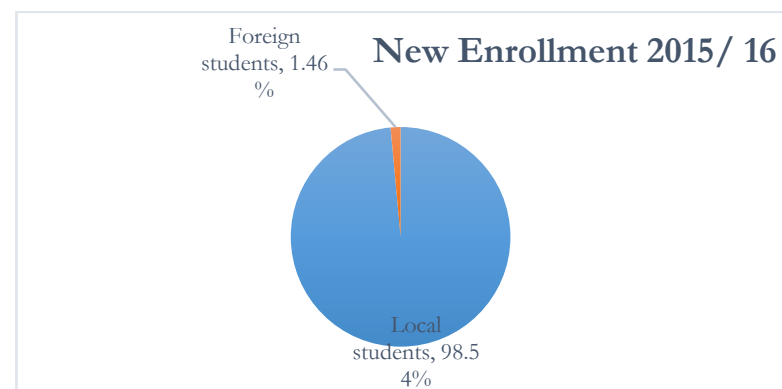
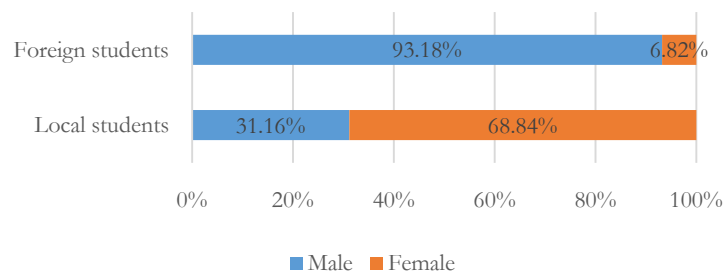

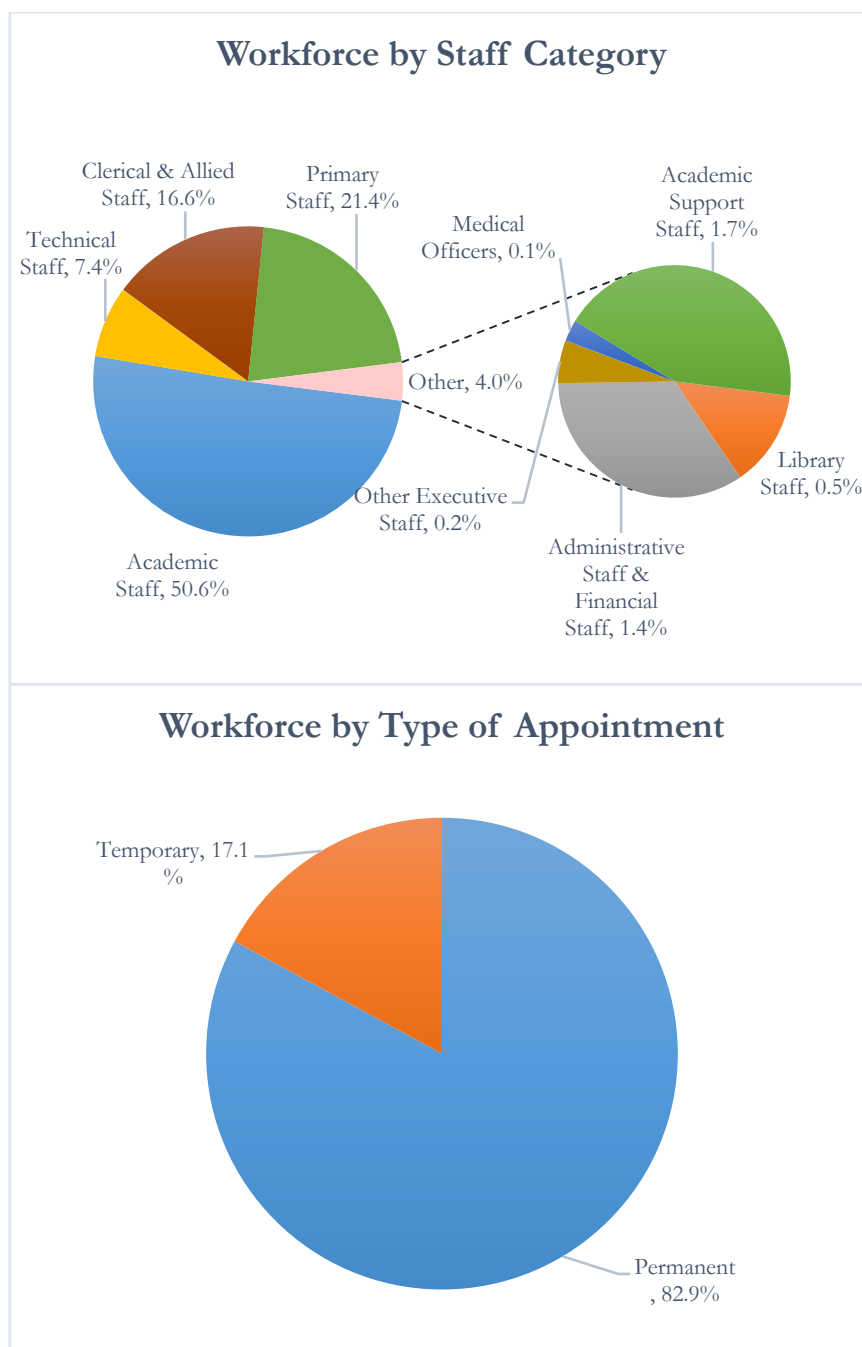
6. HUMAN RESOURCES OF THE UNIVERSITY

NOTES TO THE FINANCIAL STATEMENTS

1 Significant Accounting Policies

1.1 General Policies

1.1.1 Reporting Entity

University of Kelaniya was incorporated under the University Act No. 16 of 1978, and situated at Dalugama, Kelaniya.

1.1.2 Principal Activities and Nature of Operations

This is a national university mainly operates on government funds.

The university primarily caters to local students in the fields of Humanities, Social Sciences, Sciences, Medicine, and Commerce & Management.

The university is promoting higher studies and research.

1.1.3 Basis of Preparation

(a) Statement of Compliance

The Financial Statements comprise the Statement of Financial Position, Statement of Financial Performance, Statements of Changes in Net Assets / Equity, Cash Flow Statement and Notes to the Financial Statements. These statements have been prepared in accordance with the Sri Lanka Public Sector Accounting Standards (SLPSAS) issued by the Institute of Chartered Accountants of Sri Lanka and adopted by the University Grants Commission by its Financial Circular Letter No. 3/2011. The accounting policies adopted are consistent with those used in the previous financial year.

(b) Basis of Measurement

Financial statements have been prepared on historical costs basis and do not take into account changes in money values, except where it is stated. Cost is based on the fair value of the consideration given in exchange for assets.

(c) Functional and Presentation Currency

The financial statements are presented in Sri Lankan Rupees, which is the University's functional and presentation currency.

(d) Going Concern

The Financial Statements have been prepared on the going concern basis.

(e) Use of Estimates and Judgments

The preparation and presentation of financial statements in conformity with SLPSAS requires management to make judgments, estimates and assumptions that affect the application of the accounting policies and reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates and judgmental decisions.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised if the revision affects on that period or in the period of the revision and future periods if the revision affects both current and future periods.

1.2 Assets and Basis of Their Valuation**1.2.1 Property, Plant & Equipment****(a) Recognition and Measurement**

Property, Plant & Equipment are recorded at cost less accumulated depreciation. The cost of Property, Plant & Equipment is the cost of purchase or construction together with any incidental expenses thereon.

(b) Cost

The cost of property, plant & equipment comprises its purchase or construction cost and any directly contributable cost of bringing the asset to working condition for its intended use.

(c) Depreciation

Depreciation is charged to the income statement on the straight line basis at the following rates per annum in order to write off the cost of such assets over their estimated useful lives.

Depreciation is provided on pro rata basis on the assets purchased/constructed/disposed of during the year.

(d) Revaluation of the Property, Plant & Equipments

The Lands, Buildings and Motor Vehicles of the University have been revalued and recognized to the accounts with effect from 01st January 2008.

Revaluation Surplus may be transferred to the general reserve proportionately as the assets are used by the university. In such a case, the amount of the surplus transferred would be the difference between depreciation based on the revalued carrying amount of the assets and depreciation based on the assets' original cost.

(e) Higher Education for the 21st Century (HETC) Grant/IRQU Grant

During the year 2016, Rs:162,020,729.68 Worth of assets was transferred to the University from the HETC project.

These assets are recorded at net book value as at transferred date of 31 October 2016. And depreciations are charged for remaining useful lives based on the cost of the assets.

(f) Land acquired for the construction of Faculty of Computing and Technology

The university has paid Rs.431,745,868 in the year 2016 to acquired a land contains 5 A- 3 R- 9.77 P for the establishment of the Faculty of Computing and Technology.

Subsequently the university has allocated 2 acres from the said land to the Postgraduate Institute of Pali and Buddhist Studies for the value of Rs.148,634,464.

1.2.2 Intangible Assets**(a) Computer Software****i. Basis of Recognition**

An intangible asset is recognized if it is probable that future economic benefits that are attributable to the asset will flow to the University and the cost of the asset can be measured reliably.

ii. Subsequent Expenditure

Subsequent expenditure on software assets is capitalized only when it increases the future economic benefits embodied in the specific asset to which it relates. All other expenditure is expensed as incurred.

iii. Amortization

Amortization is recognized in profit or loss on a straight-line basis over the estimated useful life of the software, from the date that it is available for use since this most closely reflects the expected pattern of consumption of the future economic benefits embodied in the asset.

The estimated useful life of software is five years.

iv. De-recognition

An intangible asset is derecognized on disposal or when no future economic benefits are expected from it. The gain or loss arising from the de-recognition of such intangible assets is included in profit or loss when the item is derecognized.

1.2.3 Inventories

Inventories are valued at cost based on FIFO basis.

1.2.4 Receivables

Receivables are stated at the amounts they are estimated to realize.

1.2.5 Short term Investments**(a) Investment in Government Securities**

Investments in treasury bills, treasury bonds and repurchase agreements are stated at cost.

(b) Investment in Fixed Deposits

Investments in fixed deposits are stated at cost.

1.2.6 Cash & Cash Equivalents

Cash & cash equivalents comprise cash in hand and deposits at Bank.

1.3 Liabilities & Provisions

All known liabilities as at the balance sheet date are included in the Financial Statements and adequate provisions are made for liabilities which are known to exist but the amount of which cannot be determined accurately.

Obligations payable on demand or within one year of the balance sheet date are treated as current liabilities in the balance sheet. Liabilities payable after one year from the balance sheet date are treated as non-current liabilities in the balance sheet.

1.3.1 Accounting for Grants

Grants that compensate the University for Expenses incurred are recognized as revenue in the income statement in the same period in which the expenses are recognized. Grants that compensate the University for the Cost of an asset are recognized in the income statement on a systematic basis over the useful life of the related asset.

1.3.2 Employee Benefit**(a) Provision for Retiring Gratuity**

The university has adopted the benefit plan as required under the payment of Gratuity Act No. 12 of 1983 for all eligible employees.

Defined benefit plans define an amount of benefit that an employee will receive on retirement usually dependent on one or more factors such as age, years of service and compensation.

The liability recognized in the balance sheet in respect of defined benefit plans is the present value of the defined benefit obligation at the balance sheet date together with adjustment for unrecognized past service cost.

(b) Defined Contribution Plan

Obligations for contribution to a defined contribution plans are recognized as an expense in the income statement as incurred

1.3.3 Taxation

The university is exempt from Income Tax under Section 7(b) of the Inland Revenue Act No. 10 of 2006.

1.3.4 Deferred Taxation

Provision has not been made for deferred tax as the university is exempted from Income Tax under Section 7(b) of the Inland Revenue Act No. 10 of 2006.

1.3.5 Capital Commitments and Contingent Liabilities

All material commitments and contingent liabilities are considered and where necessary adjustments or disclosures are made in these Financial Statements.

1.4 Income Statement

1.4.1 Revenue Recognition

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the university and that it can be reliably measured.

- (a) Enrolment fees from students are recognized as revenue on receipt.
- (b) Fees on examinations, seminars, courses and other educational and activities are recognized as revenue on completion of such activity.
- (c) The fees on fee-levying courses recognized to the income statement based on the stage of completion of each course as at the year end. Lecture fees and payments that relate to future periods are shown in the balance sheet as Income Received in Advance under the Reserve & Restricted Funds.
- (d) Interest income is recognized on accrual basis.
- (e) Revenue from grants is recognized when control of the contribution or right to receive the contribution is confirmed.
- (f) Sponsorship related activities are recognized on receipt.
- (g) Other income is recognized on accrual basis.

1.4.2 Expenditure

- (a) Expenses are recognized in the income statement on the basis of direct association between cost incurred and the earning of specific items of the income. All expenditure incurred in the running of the university and in maintaining the capital assets in a state of efficiency has been charged to revenue in arriving at the surplus/deficit for the year.
- (b) Expenses on examinations, seminars, courses and other educational activities are recognized in the income statement on completion of such activity.

1.5 Comparative Information

The Comparative figures have been re-arranged where necessary to conform to the current year's presentation.

1.6 Events After the Balance Sheet Date

The materiality of events occurring after the balance sheet date has been considered and appropriate adjustments, wherever necessary, have been made in the accounts.

1.7 Cash Flow Statement

The Cash Flow Statement has been prepared using the indirect method.

Report of the Auditor General on the Financial Statements of University of Kelaniya for the year ended 31 December 2017 in terms of Sub-Section 108(1) of the Universities Act No.16 of 1978.

The audit of financial statements of the University of Kelaniya for the year ended 31 December 2017 comprising the statement of financial position as at 31 December 2017 and the statement of financial performance, statement of changes in Funds and cash flow statement for the year then ended and a summary of significant accounting policies and other explanatory information was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Sub-section 107(5) of the Universities Act, No.16 of 1978. My comments and observations which I consider should be published with the Annual Report of the University in terms of Sub-section 108(1) of the Universities Act appear in this report.

1.2 Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements, whether due to fraud or error.

1.3 Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Sri Lanka Auditing Standards consistent with International Auditing Standards of Supreme Audit Institutions (ISSAI 1000- 1810). Those Standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of risks of material misstatements of the financial statements, whether due to fraud or error. In making those risks assessments, the auditor considers internal control relevant to the University's preparation and fair presentation of financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the University's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements. Section 111 of the Universities Act, No.16 of 1978 give discretionary powers to the Auditor General to determine the scope and extent of the Audit.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

1.4 Basis for qualified opinion

My opinion is qualified based on the matters described in paragraph 2.2 of this report.

2. Financial Statements

2.1 Qualified opinion

In my opinion, except for the effects of the matters described in paragraph 2.2 of this report, the financial statements give a true and fair view of the financial position of the University of Kelaniya as at 31 December 2017 and its financial performance and cash flows for the year then ended in accordance with Sri Lanka Public Sector Accounting Standards.

2.2 Comments on financial statements

2.2.1 Sri Lanka Public Sector Accounting Standards

Sri Lanka Accounting Standard 07

The following observations are made.

- (i) In terms of paragraph 47 of the Standard, when the fair value of a revalued asset differs materially from its carrying amount, a further revaluation is necessary. However, action had not been taken to account the fair value of lands costing Rs.653,159,142 purchased prior to 31 December 2013 after being revalued.
- (ii) As the useful life of non-current assets had not been reviewed annually in terms of paragraph 65 of the standard, 23 motor vehicles costing Rs.52,021,032 had been fully depreciated but further being utilized. Accordingly, the estimated error had not been revised in terms of Sri Lanka Public Sector Accounting Standard 03.

2.2.2 Accounting Deficiencies

The following observations are made.

- (a) Sums of Rs.1,894,340 and Rs.74,773 had been spent for the purchase of a land, 2.51 purchase in extent and its stamp fees respectively in the year under review and it had been brought to accounts as recurrent expenditure, instead of being accounted as capital expenditure.
- (b) According to the depreciation policy of the University, motor vehicles depreciated at 20 per cent and as such a vehicle should be fully depreciated at the end of the 5th year. However, 3 motor vehicles acquired in the years 2011 and 2012 costing Rs.16,715,704 had been depreciated by Rs.3,343,141 in the year 2017 as well.

2.3 Non-compliance with Laws, Rules, Regulations and Management Decisions

(b) Paragraph 9.3.1 (vii) of the Public Enterprises Circular No.PED/12 of 02 June 2003.	Without filling the vacancies in executive staff, 04 officers had been employed on acting basis for a period of 3 months to one year.

3. Financial Review

3.1 Financial Results

According to the financial statements presented, the financial result of the University for the year ended 31 December 2017 had been a surplus of Rs.365,899,881 as compared with the surplus of Rs.495,212,649, for the preceding year thus indicating a deterioration of Rs.129,312,768 in the financial results of the year under review as compared with the preceding year. The decrease of external examination revenue by Rs.169,094,386 and the increase of staff cost by Rs.137,382,648 in the year under review as compared with the preceding year had mainly attributed this deterioration. In analysis of financial results of the year under review and the preceding 4 years, there had been a surplus from the year 2013 to 2017. After readjusting staff remuneration and depreciation on property, plant and equipment, the contribution of Rs.1,572,617,629 in the year 2013 had continuously improved up to Rs.2,691,011,756 in the year 2017.

4. Operating Review

4.1 Performance

4.1.1 Planning

(a) Enrolment of students

The number of students could have been enrolled in the year under review to 5 faculties amounted to 3,205, whereas 3,235 had been enrolled. Excessive students amounting to 12, 12, 45 and 116 had been enrolled to the Faculty of Medicine, Faculty of Computers and Technology, Faculty of Commerce and Management and Faculty of Arts respectively, whereas lesser number of students amounting to 36, 46 and 73 had been enrolled to the speech and Language Therapy course, Faculty of Science and special admission in the Faculty of Arts respectively.

(b) Conducting Lecturers

The following observations are made.

- (i) As lots of lapses such as non-indicating the dates, subject unit, name of the lecturer, signature, the time, lecture was delivered, academic year etc. in the students signature registers were observed it could not be ensured whether the lecturers had covered the number of lecture hours in terms of academic time table.
- (ii) A test check carried out in the Department of Philosophy observed that there were 23 instances were imbalances between the dates stated in the attendance registers maintained by the Faculty offices for visiting lecturers and the dates indicated in the students signature registers.

(c) Centre for Distance and Continuing Education

Centre for Distance and Continuing Education had registered 67,828 students for the last 4 academic years. The following observations are made in this connection.

- (i) Out of 91 students registered in the year 2011 for Bachelor of Science Degree, none of the students had completed the degree even up to 31 August 2018, though 7 years had elapsed.
- (ii) The preliminary examination for 16,079 students registered for 3 courses of Arts, Business Management and Commerce in the years 2014 and 2015 had been commenced on 01 August 2018 and the students had not been enrolled for the academic year 2016.
- (iii) Periods from 3 months to 3 years had been taken to issue the results of 3 examinations relating to the Arts and Business Administration Courses. Test check observed that although more than one year had elapsed after handing over the answer scripts of 11 subjects, the results of which had not been issued so far, to the Heads of Divisions, they had not been returned.

4.2 Management Activities

The following observations are made.

- (a) Action had not been taken to recover the value of 28,876 library books which had been identified as misplaced by the Board of Survey of Library books conducted in the year 2012, from the relevant parties. It was informed me that this number would change according to the Board of Survey report conducted in the year 2017 but that report was not made available to audit even by 31 August 2018.
- (b) Due to non-utilisation of funds for the relevant purposes totalling Rs.174,824,530 existed in 11 fund accounts established in the previous years for special purposes, sums of Rs.132,733,087 and Rs.42,091,443 had been transferred to the University Development Fund and the Medical Faculty Development Fund respectively during the year under review. In addition, the balance of 3 fund accounts opened in the year under review as at 31 December 2017 amounted to Rs.13,705,037 but the actual expenditure incurred by 28 August 2018 was only Rs.959,380.
- (c) Even though, the accommodation and other expenses of lecturers who proceed abroad for the presentation of their research papers should be paid in foreign exchange before proceeding abroad a sum of Rs.1,754,713 had been paid to 7 lecturers in Sri Lankan rupees, who had proceeded abroad in the year under review.
- (d) A sum of US\$ 5442 had been paid to 2 lecturers in the Faculty of Social Science for the participation in the presentation of research's to a seminar held in United Kingdom from 07 to 10 November 2017 as registration fees, incidental expenses, food and lodging fees. Even though, the lodging fees according to the quotations obtained from the hotel amounted to £ 341 for 7 days, it had been treated as 'per day' and made the payment. As a result, it was observed that an over payment of US\$ 3,410 had been made.

- (e) Lecture hours had not been allocated to a senior female lecturer in the Faculty of Social Science from the academic time tables, from the year 2012 to 12 February 2018. One and only evidence to establish whether this lecturer was in service had been only the examination of 20 dissertations and marking 306 answer scraps during the period from 2009 to 2014. However, salaries and all allowances had been paid to this lecturer during this period. Even though, there was no working service period, a 2 ½ months service extension had been granted to her even beyond the retirement age in terms of Circular No.12/2015 dated 05 September 2015 of the University Grants Commission, considered as covering the lecture hours furthermore. In addition, a concessionary motor vehicle permit had also been issued to her on 01 April 2011.

4.3 Operating Activities

In terms of paragraph 33 of Chapter 10 of the Establishments Code for University Grants Commission and Universities, the number of lecturers who had breached the agreements entered into in proceeding abroad for scholarships amounted to 21 and the amount due from them amounted to Rs.75,077,754 as at 31 August 2018.

In addition, the lecturers who had breached the bonds were allowed to pay the bonded amount by instalments. Even though, the recoverable bonded amount had been too much, opportunities had been given to pay them by smaller instalments such as Rs.20,000, Rs.30,000 and Rs.50,000 etc. irrespective of the recovery period by instalments and as such it had taken a long period to settle the bonded money.

4.4 Under-utilisation of Funds

The following observations are made.

- (a) A fixed deposit named as “Student Relief Fund” had been opened in the year 1989 and the balance of this account as at 31 December of the year under review amounted to Rs.1,333,567. As the objective of the establishment of this fund for what purposes of expenditure could be met therefrom etc. had not been determined, this fund had become underutilized since several years.

- (b) Balances of Rs.4,097,398 and Rs.4,249,691 had existed as at 31 December 2017 in 16 Scholarship Fund accounts and 21 gift fund accounts respectively which had been opened during the period 1980 and 2010 and the interest income earned by those funds amounted to Rs.4,910,648 and Rs.3,171,581 respectively. Only a sum of Rs.28,100 had been utilized from this interest income in 5 instances during the year under review for awarding scholarship and gifts and as such, it was observed that much money of these funds had become underutilized.
- (c) A balance of Rs.29,736,235 had existed in the University Research Grants Account as at 31 December 2017, out of which, a sum of Rs.18,032,876 had become underutilized since the year 2011.

4.5 Personnel Administration

The approved and actual academic and non-academic cadre of the University as at 31 December 2017 stood at 1762 and 1385 respectively. Accordingly, the number of vacancies amounted to 398 and the excess cadre was 24. The following observations are made in this connection.

- (a) The approved permanent academic staff as at the end of the year under review had been 781 and the actual cadre was 561, thus existing 220 vacancies. Only 37 of those vacancies had been filled by 30 July 2018 and action was being taken to recruit 91 persons but there were further vacancies of 92.
- (b) The number of vacancies in the non-academic staff and the excess cadre amounted to 149 and 24 respectively. Three persons had been recruited to 2 posts outside the approved cadre. The approved cadre of Health Services Labourers amounted to 10 whereas the actual cadre was 25 and as such the excess staff had become 15. By 30 July 2018 recruitments had been made for 34 vacancies in the non-academic staff and action was been taken to recruit another 14 person but still there were 101 vacancies.

4.6 Vehicles Utilisation

The following observations are made.

- (a) A bus attached to the Faculty of Medicine, Ragama had not been operated since 26 May 2016 and action had not been taken to dispose of this vehicle or to get it repaired and used.
- (b) A bus belonging to the University had been referred to a private garage on 09 July 2017 for fixing front and back wind screen without calling for quotations. Even though, more than one year had passed, it had not been repaired and handed back. The physical verification observed that this vehicle had been parked outside the garage, resulting being decayed.

5. Sustainable Development

5.1 Reaching Sustainable Development Goals

Every public entity should act in accordance with the Circular No.NP/SP/SDG/17 dated 14 August 2017, issued by the Secretary to the Ministry of National Policies and Economic Affairs and the 2030 'Agenda' of the United Nations on Sustainable Development. Nevertheless, the University of Kelaniya was not aware about how to act in respect of functions within the purview of its scope. However, the Vice Chancellor informed me that various programs and actions had been taken to reach Sustainable Development Goals through 5 projects viz, waste management, water management, energy management, habitat management and training programs during the period 2014 to 2018.

6. Accountability and Good Governance

6.1 Presentation of Financial Statements

Even though, the annual financial statements should be purchased to the Auditor General within 60 days after the closure of the year of accounts in terms of paragraph 6.5.1 of the Public Enterprises Circular No.PED/12 of 02 June 2003, the financial statements of the University had been presented on 09 May 2018, after a delay of 69 days.

6.2 Procurement and Contract Process

6.2.1 Procurements

The following observations are made.

- (a) Even though, a sum of Rs.1,610,000 had been paid in the year 2017 for the supply of curtains to two offices in the University, an agreement in terms of guideline 8.9.1 (b) of the government procurement guidelines had not been signed therefor.
- (b) Preparation of cost estimates, obtaining relevant approval, referring to Procurement and Technical Evaluation Committees for this procurement should have been performed at the beginning of the procurement process. However, deviating from this procedure, recommendations of the Procurement Committee and the Technical Evaluation Committees and the approval of the Board of Control had been obtained after being selected the supplier.
- (c) Even though, it was stated that the bids would be called for from the registered suppliers of the University for the above procurement it was observed that the supplier to whom this contract had been awarded was not a registered supplier of the University for the above purpose.

6.2.2 Weaknesses in contract administration

The contract for the construction of the Information and Communication Technology Centre, the contract value of which amounted to Rs.157,593,998 had been awarded to the State Engineering Corporation and its works had been commenced on 01 September 2016. Even though, it should have been completed by 30 August 2018, but its financial progress and the physical progress had been only 48 per cent and 40 per cent as at 30 June 2018.

Weaknesses in systems and controls observed in audit were brought to the attention of the Vice Chancellor from time to time. Special attention is needed in respect of the following areas of control.

13. Audit Committee Report

Composition of the Audit Committee

The Audit Committee of the University established as a sub-committee responsible for the Council consists of three non-executive members. The following officers were engaged in audit committee activities in the year 2017.

The members from the Auditor General's Department were also invited to participate as observers.

Meeting

As per Public Enterprises Circular No. P. E. D./31, committee meetings should be held at least four times a year. The Committee met four times in the year under review and the internal and external audit reports were discussed at these meetings. The Committee reports were submitted to the University Council for information and necessary action.

Main Responsibilities

The main objective of the Audit Committee is to assist the Council for the efficient functions of the financial matters of the University.

The main responsibilities are;

1. Review and supervision of the financial statements, financial reporting and the continuation of the audit process.

2. Examine any matter related to the finance of the University and other related matters.
3. Approving the annual internal audit plans and programmes.
4. Supervision of the internal audit plan and programme.
5. Investigate the external and internal audit reports and take follow up action on recommendations.
6. Review and supervision of the effective performance of the internal system controls.

Activities within the Year

The Committee was engaged in the following activities within the year under review.

1. Approval and supervision of the annual internal audit plans and programmes.

The Committee approved the internal audit plan and internal audit programme for the year 2017 and supervised it throughout the year. The Committee reviewed and supervised the effectiveness of the internal audits, performance of the queries and the performance of the Internal Audit Division.

2. Compliance with laws and regulations

The compliance with the relevant laws and regulations were reviewed with the reports submitted by the external and internal auditors. The Committee further followed up on the preparation and presentation of the annual accounts reports of the University and the settlement of statutory payments such as gratuity, pensions and the Provident Funds.

3. Continuous review and supervision on the violation of contracts

The Committee continuously reviewed and supervised the recovery process from the staff members who violated bonds. As a result, it was able to recover a complete bond amount from persons and Rs. 4.7million was recovered in the year under review. There were 18 bond violators at the beginning of the year 2017. It was able to recover the whole bond value from three persons within the year. Nine persons are paying the recoverable in installments and legal action has already being taken to recover the relevant amounts from the remaining six persons.

4. Review and strengthening of the internal control system

Necessary recommendations on the control of fixed assets, regulating the expenditure for contractual activities, lending library books, annual board of survey of stores/survey of fixed assets, recovering the unsettled advances, settling the unrecognized and unsettled loan balances and strengthening the internal controls. Continuous review was done on the actions taken to correct the weaknesses depicted in the Auditor's Report and Audit Inquiry for the year 2017. The University was satisfied with regard to the true and fair opinion issued by the Auditor's Report for the year 2017.

5. Audit Committee Meetings

The Audit Committee meetings were held at four occasions within the year ended as at 31st December 2017. All the Audit Committee members actively participated in all the committees. A representative from the Auditor General's Department participated at every meeting of the Audit Committee as a supervisor. Other staff members from the University were also invited when required. Senior Assistant Internal Auditor acts as the Secretary of the Committee.

Conclusion

The Committee was satisfied with the success of the follow up activities based on the recommendations on the matters considered by the Committee in the year 2016.

2.2 **Comments on financial statements**

2.2.1 **Sri Lanka Public Sector Accounting Policies**

Sri Lanka Public Sector Accounting Policies No. 07

- (i) All the lands that are used by the University have been referred to the Department of Assessment for assessing and the assessment report has not been received yet. The Department of Assessment has been reminded from time to time in this regard and it has been noted to account the said values after the assessment report has been received.
- (ii) It has been informed to send a report after assessing all the vehicles within one day as the received assessment report is not in order.

2.2.2 Accounting Deficiencies

- (a) has accounted from the Journal No. C – 072 in the year 2018.
- (b) has been corrected by the Journal No. R – 165 in the year 2018.

2.3 Non-compliance to Rules, Regulations and Management Decisions

- (a) Financial Regulations of the Democratic Socialist Republic of Sri Lanka

- i. As per the Financial Regulations 104 (3) and (4) on accidents to the vehicles of the University, steps have been taken to conduct the preliminary inquiries and the formal inquiries on the accidents that had taken place from 01.01.2018. An inquiry officer in this regard has been appointed and the relevant preliminary inquiries are being conducted at present.

- ii. According to the Memos of the Finance Committee dated 04.08.2018 (19) and the approval of the 464th Council, it has been noted to retain for a period of two months and account for the income thereafter.

- iii. Action has been taken after a Memo was presented to the Finance Committee and the approval of the Council was obtained to take the remaining deposits except the security deposits worth Rs. 45,000/- to the income for the year 2018.

- (b) The University Grants Commission has filled all the vacancies for the executive staff by this time.

3. Financial Review

3.1. Financial Results

Agreed.

4. Operational Review

4.1 Performance

4.1.1 Planning

(a) Enrolment of Students

For the Academic year 2016/2017 160 students are to be enrolled for the Faculty of Medicine and the number of students has been increased due to the foreign students referred by the UGC from time to time. There are three courses conducted in relation to the Faculty of Computer and Technology and the number of students enrolled has been increased as the Degree Programme on Computer Sciences has been commenced from the academic year 2016/2017. Though the UGC was informed on the requirement of 450 and 1200 students for the Management Degree Programme in the Faculty of Commerce and Management and Arts Courses respectively, the UGC has referred 500 students to be registered for the Management course and 1320 students for the Arts course.

According to the letter of the Dean of the Faculty of Medicine dated 27.07.2017, though 85 students have applied under Disability and Rehabilitation for the academic year 2016/2017, the UGC has referred 50 students to the University under the Speech and Audio Science course. The University constantly informs the UGC on the vacancies and receive registers of students. However, as the UGC transfers the students registered for several courses in the Faculty of Science under filling vacancies in higher courses/ vacancies there is lack of student registration.

The UGC has been informed to refer 170 students for the year 2016/ 2017 under the Special Entrance for the following subjects and the number of registered students and the number of students referred for registration are as follows:

(b) Conducting Lectures

i. At the beginning of the relevant biannual, the relevant lecturers will be given a time table as discussed at the Department meetings. Lectures are not conducted due to the absence of students for lectures as a result of the sudden strikes launched by students at various instances. At the same time, sometimes lectures are not conducted due to various events. However, the Department Heads have been informed to conduct lectures covering the relevant syllabus in a manner that does not adversely affect the students.

ii. At the beginning of each academic year, the visiting lecturers are informed by every Department to regularly note their attendance. There are instances when the signature of students could not be taken when additional lectures are conducted for them. In some Departments all the matters are done by a single clerk. In such instances, there are issues on maintaining the attendance registers of students in the proper manner. The relevant officers have been informed to take steps to avoid such instances in performing duties.

(c) Distance and Continuous Education Centre

i. Agreed.

- For the students registered for the year 2011, 2013 academic year is the third year (final year). The relevant examinations have been conducted from 10.06.2017 to 23.06.2017.
- The final Unit results thereof have been released on 09.01.2018.
- None of those students have completed the degree.

ii. The first examination for the student batch enrolled for the Bachelor of Arts (General) degree (External) for the 2014 academic year was commenced on 01.08.2018 and completed on 20.10.2018.

- The student registration process for the 2016 academic year has been finalized by now.

iii. Agreed.

The assessment of examination answer papers are performed by the permanent academic staff members of the University relevant to the subjects. University lecturers conduct the mandatory lectures, marking the answer papers of the internal examinations and engage in national level examination matters. Therefore, there is a delay in receiving marks and it leads to the delay in issuing results.

There are 76 subject units in the Bachelor of Arts (General) degree programme and the final results can only be issued after the Distance and Continuous Education Centre has received the results of all the subject units of subjects of undergraduates. The conference paper marking method has been introduced in order to avoid such delays and issue the results of the Bachelor of Arts degree programme.

All the results of the second examination of the Business Management (General) degree – 2014 have been issued.

4.1.1 Management Activities

(a) As it was revealed from the library book survey on identified misplaced books conducted in the year 2012 and the 2017 Book survey some copies from this stock of books are included in the library book collection. According to the final report of the 2017 Library book survey, 24,721 books have been misplaced and a report on the number of these books including their values will be prepared and submitted during the next three months. The Internal Audit Division has received the final report of the Library Book Survey for the year 2017 and the accuracy of that report is being examined at present.

(b) There are three sub-ledger accounts under the University Development Account for the identified Special Projects and only Rs. 10,330,000/- has been allocated for this purpose. For the account opened for the Science Exhibition was financed only by the sponsors. For the

three accounts of the fund an amount of Rs. 959,379.82 has been incurred as at 27th August 2018. There has been a delay in settling the advances obtained for the Science Exhibition and steps have been taken to transfer the balance after the advances have been settled.

(c) The payment of the combined allowance and casual allowance for the lecturers before their departure abroad has been suspended. And the payment of their allowance in the Sri Lankan currency has also been stopped.

(d) Though the quotation letter submitted by the said two lecturers for the payment for the relevant accommodation charges for the participation in the conference in the United Kingdom had mentioned USD 341 for 7 days, their request letter had mentioned USD 341 for one day. The payment of USD 341 per diem was made to them as in the verbal inquiry they stated that USD 341 was for one day and USD 420 is allocated per diem as per the Circular. The said excess amount had been returned to the University and the relevant receipts have been submitted.

(e) The relevant Department Heads has informed that Mrs. RA Kulasekara had been engaged in teaching for the period from the year 2008 to 12th February 2018. The relevant Department has informed that she has worked as the Coordinator to the Mass Media subject in the external examinations conducted during the said period by the University and as an invigilator of the said examinations. At the same time, it is informed that she has been actively involved in subject related other programmes such as ‘Sanjananee’ and student seminars and workshops conducted by her Department of Studies, i.e. the Department of Mass Media.

As this lecturer who was working as a Senior Lecturer by the year 2006 had reached the highest step in her salary scheme by that year, the payment of salary increments for her had been stopped. The salary increment sheets for the academic years of 2014 and 2015 have not been returned to the Establishments Department either recommended or not recommended. As the salary increment sheets for the years 2016 and 2017 have been returned after recommended by the Department, steps have been taken to provide such salary increments.

When a lecturer has reached the retirement period, the Establishments Department inquiries from the said lecturer whether her retirement date is her 65th birthday or the end of the

academic year. As per the inquiry from Mrs. RA Kulasekara dated 04.10.2017 she had informed that she would serve until the end of the 2016/2017 academic year. According to the decision of the Council, she has been retired from the end of the 2015/2016 academic year.

4.3 Operational Activities

The bond amount of the said two lecturers has been calculated and there are 19 officers who have violated agreements by now. The balance is Rs. 76,343,960.00. Steps have been taken to recover this amount.

There are two lecturers paying the amounts in less amounts in more installments than the number of installments decided by the Council and they have been informed to increase their installment amounts. Action has been taken to take legal action against a lecturer who is paying Rs. 20,000/- monthly in contrary to the intimation. Drafting the complaint for taking legal action against the said lecturer has been finalized and the said documents have been sent to the Attorney-General's Department.

4.4 Under-utilization of funds

- (a) The relevant sections have been informed in this regard and further action will be taken.
- (b) The relevant sections have been informed and further action will be taken depending on the answers received from the relevant sections.
- (c) The approval of the Council has been received to utilize Rs. 4.5 million from the underutilized balances for the staff development.

4.5 Staff Administration

- i. At present the academic staff is 619 and steps have been taken to publish paper advertisements to fill the balance vacancies.
- ii. In the cadre registry approved for the year 2013, there was one vacancy for the post of Generator Operator and two vacancies for the Office Machine Operators and action had been taken accordingly and those posts have been removed from the 2017 cadre registry. In the

cadre registry for the Health Services Labourer approved for the year 2013, there were vacancies for 26 posts and action had been taken accordingly and according to the approved cadre registry for the year 2017, the approved Health Services posts have been reduced to 10. As per the vacancies, action had been taken to fill 110 vacancies as at 12.12.2018. At the same time, when filling the vacancies for posts for which applications should be called as per the Circular No. 876, there had been a delay in filling the vacancies due to the non reception of the registry to suit the vacancies. At the same time, the transfer of a considerable number of staff members belonging to the posts of Management Assistant, Work Assistant and Technical Officer has also contributed for the increase in relevant vacancies.

4.6 Vehicle Utilization

(a) In order to take future actions on the misuse or repair and use of the bus bearing No. 61-5088 that was used for the transportation requirements of the Medical Faculty students of Kelaniya University, a senior officer from the Auto Mobiles Company visited the University on 06.12.2018 as requested by the University and he examined the bus. He has given verbal instructions that it is useless to repair this bus and it is appropriate to take rapid action to auction and sell it. The same officer has informed that the written report in this regard would be sent to the University in due course.

(b) The front and rear wind shields of the bus bearing No. 61-8315 has been fixed by the Samarasinha Wind Screen Company and it has been brought to the University and as instructed by the Vice Chancellor, a quality assurance report form the Lanka Auto Mobile Company on its road worthiness has been obtained. According to this report it has been recommended that it is appropriate to auction and sell this vehicle as a high cost has to be incurred for its repairs.

5. Sustainable Development

Achieving the Sustainable Development Goals

The University of Kelaniya, as the first green University in Sri Lanka for the sustainable development purposes, has initiated 5 types of projects from 2014 to 2018.

i. Waste management

- ii. Water management
- iii. Energy management
- iv. Accommodation management
- v. Training courses and programmes

The University of Kelaniya, in order to achieve the sustainable development goals has implemented a number of various programmes and activities under these 5 projects and has achieved their positive results.

6. Accountability and Good Governance

6.1 Delay in presenting Financial Statements

Before the 28th of February 2018 a meeting of the Council was held on 14.02.2018. It was unable to present the accounts to this meeting as the account activities could not be finalized by that time. There was a strike held by the non-academic staff until 17th April 2018. After the strikes the accounts were presented to the next Council meeting held on 08th May 2018 and they have been forwarded to the audit after approved by the Council. Instructions have been given to present the final account reports for the year 2018 before the due date.

6.2 Procurement and Contract Administration

6.2.1 Procurements

(a) Contracts have been awarded for providing curtains to the office of the University Deputy Vice Chancellor for Rs. 805,000/- and for providing curtains to the English Language Department for Rs. 805,000/- and the payments have been made after such work and the agreements have not been signed. It has been noted to take necessary action according to the Procurement Guidelines in future.

(b) Agreed. The relevant supplier has been selected based on the urgency requirements, after discussion with the Section Heads and the recommendation of the Work Engineer without obtaining the recommendations of the Technical Evaluation Committee and the recommendation of the Procurement Committee and the approval of the Council have been obtained afterward. It has been noted to take necessary action according to the Procurement Guidelines in future.

- (c) Agreed. Action will be taken in future to call quotations for relevant tasks from suppliers registered for each task.
