On behalf of the Board of Directors I am pleased to present to you the Annual Report and the audited Financial Statements of Lanka Logistics & Technologies Ltd., for the **financial year ended 31st March 2009**.

I am pleased to report that the Company has had a year of significant success, achieving not only good operating results but also making strong progress towards maintaining a steady growth in the operating results.

During this year company earned revenue of Rs. 105.4 Mn by the supply of goods & services to the Centre for Research & Development in comparison to Rs. 71.4 Mn earned during the previous year. Company earned a net operating profit of Rs. 4.7 Mn at a growth rate of 104% in compared to that of the previous year.

It is with great pleasure I state that with the intensified actions by the armed forces and the police on the humanitarian operation in the north and east, we as the procurement facilitation provider of restricted and critical arms and ammunitions met the demands with quality goods and timely delivery. The provision of this logistic support resulted saving a large sum of foreign exchange to the government and minimized the third part involvement in military procurement. For the procurement services facilitated by us accrued administration fees as per the decision of the Hon. Cabinet of Ministers.

The directors have pleasure in submitting their report, together with the Audited Accounts for the financial year ended 31st March 2009 and independent Auditors Report thereon.

Review of the Year

Company was enable to record a turnover of Rs 105.5 million compared to Rs 71.4 million in the previous year. The results of the financial year 2008/2009 show a Profit before tax of Rs.4.1 million compared to Rs.1.7 million earned during the previous year. But the Profit after tax show a decrease in year 2008/2009 compared to year 2007/2008 because of the high tax expense incurred in year 2008/2009. Further current assets and total assets have been increased by 40% and 36% respectively.

Principal Activity

During the year, the principal activities of the company were procurement of equipment and services for the Army, Navy, Air Force and Police.

The Board of Directors of the Company is responsible for the governance of the Company, which includes setting out strategic aims, providing leadership & supervising the management.

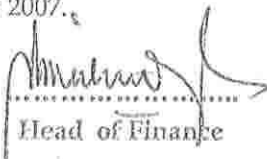

Lanka Logistics & Technologies Limited ("Company") is a Limited Liability Company incorporated and domiciled in Sri Lanka. The registered office of the Company is located at 4 - 205, BMICH, Bauddhaloka Mawatha, Colombo 07, and the principal place of business is situated at the same address.

1.2 Principal Activities and Nature of Operations

During the year, the principal activities of the Company were procurement of equipment and services for the Army, Navy, Air Force and Police.

1.3 The notes to the Financial Statements on pages (5) to (16) form an integral part of the Financial Statements.

1.4 Number of Employees

The number of employees at the end of the year was 18.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES2.1 General Policies2.1.1 Basis of Preparation

The Balance Sheet, Statement of Income, Changes in Equity and Cash Flows, together with accounting policies and notes ("Financial Statements") of the Company as at 31st March 2009 comply in all material respects with the applicable Sri Lanka Accounting Standards.

These financial statements presented in Sri Lanka Rupees have been prepared on a historical cost basis.

The Directors have made an assessment of the Company's ability to continue as a going concern and they do not intend either to liquidate or to cease trading.

2.1.2 Comparative Information

The accounting policies have been consistently applied by the Company.

2.1.3 Foreign Currency Translation

All foreign exchange transactions are converted to Sri Lanka Rupees, which is the reporting currency at the rates of exchange prevailing at the time the transactions were effected. Monetary assets and liabilities denominated in foreign currencies are translated to Sri Lanka Rupee equivalents using year-end spot foreign exchange rates. Non-monetary assets and liabilities are translated using exchange rates that existed when the values were determined. The resulting gains and losses are accounted for in the Income Statement.

2.1.4 Taxation

(a) Current Taxes

The provision for income tax is based on the elements of income and expenditure as reported in the financial statements and computed in accordance with the provisions of the Inland Revenue Act.

2.1.5 Borrowing Costs

Borrowing Costs are recognised as an expense in the period in which they are incurred.

2.1.6 Deferred Expenditure

Expenditure which is deemed to have a benefit or relationship to more than one financial year is classified as deferred expenditure. Such expenditure is written off over the period, to which it relates, on a straight-line basis.

2.2 Valuation of Assets and Their Measurement Bases

2.2.1 Trade and Other Receivables

Trade receivables are stated at the amounts they are estimated to realize net of provisions for bad and doubtful debts.

2.2.2 Cash and Equivalents

Cash and cash equivalents are defined as cash in hand, demand deposits and short term highly liquid investments, readily convertible to known amounts of cash and subject to insignificant risk of changes in value.

For the purpose of cash flow statement, cash and cash equivalents consist of cash in hand and deposits in banks net of outstanding bank overdrafts. Investment with short maturities i.e. three months or less from the date of acquisitions are also treated as cash equivalents.

2.2.3 Property, Plant & Equipment

(a) Cost

Property, Plant & Equipment are recorded at cost less accumulated depreciation.

All items of Property, Plant & Equipment are initially recorded at cost. Where items of Property, Plant & Equipment are subsequently revalued the entire class of such assets is revalued. Revaluations are done with sufficient regularity to ensure that their carrying amounts do not differ materially from their fair values, at the balance sheet date. Subsequent to the initial recognition as an asset at cost, revalued Property, Plant and Equipment are carried at revalued amounts less any subsequent depreciation thereon. All other Property, Plant and Equipment are stated at historical cost less depreciation.

(c) Restoration Costs

Expenditure incurred on repairs or maintenance of Property, Plant and Equipment in order to restore or maintain the future economic benefits expected from originally assessed standard of performance is recognized as an expense when incurred.

(d) Depreciation

The provision for depreciation is calculated by using a straight line basis on the cost or valuation of all Property, Plant and Equipment. The principal annual rates used are;

IT Equipment & Accessories	25%
Interior Decorations	50%

Property, Plant and Equipment on finance leases, which effectively transfers to the Company substantially all of the risk and benefits incidental to ownership of the leased item are capitalised at their cash price and disclosed as Property, Plant and Equipment and depreciated over the period the Company is expected to benefit from the use of the leased assets.

The corresponding principal amount payable to the lessor is shown as a liability, lease payments are apportioned between the finance charges and reduction of the lease liability so as to achieve a constant rate of interest on the remaining balance of the liability. The interest payable over the period of the lease is transferred to an interest in suspense account. The interest element of the rental obligations applicable to each financial year is charged to the Income Statements over the period of the lease.

(b) Operating Leases

Leases where the lesser effectively retains substantially all the risk and benefits of ownership over the leased term are classified as operating leases.

Rentals paid under operating leases are recognized as an expense in the Income Statement.

2.2.5 Investments(a) Current Investments

Current investments are stated at lower of cost and Market Value.

The cost of an investment is the cost of acquisition inclusive of brokerages, fees, duties and bank fees.

(b) Long Term Investments

Long Term Investments are stated at cost OR valuation OR lower of cost and market value on a portfolio basis.

The cost of the investments is the cost of acquisition inclusive of brokerage fees, duties and bank fees.

2.3 Liabilities and Provisions

2.3.1 All known liabilities have been accounted for in preparing the financial statements.

2.3.2 Retirement Benefit Obligations

(a) Defined Benefit Plan - Gratuity

Gratuity is a Defined Benefit Plan. In order to meet this liability, a provision is carried forward in the balance sheet, based on a half a month's salary of the last month of the financial year of all employees for each completed year of service, commencing from the first year of service.

The gratuity liability is not funded nor actuarially valued. This item is grouped under provision and other liabilities in the Balance Sheet.

(b) Defined Contribution Plans - Employees' Provident Fund & Employees' Trust Fund

Employees are eligible for Employees' Provident Fund Contributions and Employees' Trust Fund Contributions in line with respective Statutes and Regulations.

2.4 Grants and Subsidies

Grants and subsidies are recognised at their fair value where there is reasonable assurance that the grant/subsidy will be received and all attaching conditions, if any, will be complied with. When the grant or subsidiary relates to an expense item, it is recognised as income over the period necessary to match them to the costs to which it is intended to compensate on a systematic basis.

Grants and subsidies related to assets, including non-monetary grants at fair value are deducted at arriving at the carrying value of the asset.

2.5 Income Statements

2.5.1 Revenue Recognition

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue and associated costs incurred or to be incurred can be reliably measured. Revenue is measured at the fair value of the consideration received or receivable net of trade discounts and sales taxes. The following specific criteria are used for the purpose of recognising of revenue.

(a) Sale of Goods

Revenue from sale of goods is recognised when the significant risks and rewards of ownership of the goods have passed to the buyer; with the Company retaining neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold.

(b) Rendering of Services

Revenue from rendering of services is recognised in the accounting period in which the services are rendered or performed.

(c) Interest

Interest Income is recognised on an accrual basis.

(d) Rental Income

Rental income is recognised on an accrual basis.

(e) Others

Other Income is Recognised on an Accrual Basis

Net Gains and losses of a revenue nature on the disposal of Property, Plant & Equipment and other non current assets including investments have been accounted for in the Income Statement, having deducted from proceeds on disposal, the carrying amount of the assets and related selling expenses. [On disposal of revalued property, plant and equipment, amount remaining in the Revaluation Reserve relating to that asset is transferred directly to Accumulated Profit.]

2.5.2 Expenditure Recognition

- (a) Expenses are recognised in the Income Statement on the basis of a direct association between the cost incurred and the earning of specific items of income. All expenditure incurred in the running of the business and in maintaining the Property, Plant & Equipment in a state of efficiency has been charged to income in arriving at the profit for the year.
- (b) For the purpose of presentation of the Income Statement the Directors are of the opinion that the function of expenses method, presents fairly the elements of the Company's performance, and hence such presentation method is adopted.
