THE FINANCE ACT, No. 11 OF 2004

Order under Section 26

BY virtue of the powers vested in me under Section 26 read with Section 22 of the Finance Act, No. 11 of 2004 and Article 44(2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, I, Mahinda Rajapaksa, the President of the Democratic Socialist Republic of Sri Lanka, do by this order, repeal the Schedule I, II and III of the regulations made and published in the *Gazette Extraordinary*, No. 1595/14 of 31st March, 2009 with effect from January 01, 2010 and substitution of the Schedule I, II and III hereto.
