Order under section 2

BY virtue of the powers vested in me by section 2 of the Finance Act, No. 11 of the 2002, as last amended by Finance (Amendment) Act, No. 13 of 2009, I, Mahinda Rajapaksa, Minister of Finance and Planning, do by this Order declare that, the Pharmaceutical products under H. S. Headings 30.01, 30.02, 30.03, 30.04, 30.06, Bitumen under H.S. Heading 27.14 and H.S. Code 2713.20, Aircraft stimulators and parts under H.S. Codes 8805.21 and 8805.29, parts of Aero planes or Helicopters under H. S. Code 8803.30 and Turbo-jets or Turbo-propellers under H. S. Code 8411.91 imported into Sri Lanka shall be exempted from the payment of Port and Airport Development Levy with effect from 24th November, 2010.
